#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Navicore Solutions Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Navicore Solutions Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the

audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**A. DESCRIPTION OF PLAN**

The Navicore Solutions Employee Savings Plan (the "Plan") is a defined contribution plan qualified under Internal Revenue Code §403(b) and is maintained for the exclusive benefit of eligible employees. The Plan was originally effective November 1, 2011. Effective January 1, 2023, the Plan was amended and restated to reflect current law and plan design elections, including employer contribution features, automatic enrollment, Roth elective deferrals, participant loans, and in-plan Roth rollovers. Operational changes were completed during 2024; the restated terms apply as of January 1, 2023.

The Plan is administered by the Company's Plan Administrator, which has discretionary authority to interpret the Plan's provisions and to determine eligibility and benefits in accordance with ERISA requirements.

The following description of the Navicore Solutions Employee Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. Eligibility Employees are eligible to make elective deferrals on the first day of the month following 30 days of employment. Eligibility to receive employer matching and non-elective contributions is attained after completing 1,000 hours of service in a 12-month period, with entry on the first day of the next January 1 or July 1 following satisfaction of that requirement.
2. Contributions Participants may make pre-tax and/or Roth elective deferrals subject to applicable Internal Revenue Code limits, including age-50 catch-up and, if eligible, the special 403(b) 15-year catch-up. Employer matching and non-elective contributions may be made at the Company's discretion in accordance with the Plan document. The Plan includes automatic enrollment at 3.00% of compensation unless a participant affirmatively elects otherwise.
3. Participant Accounts Each participant's account is credited with their contributions, any employer contributions, and allocated investment earnings (losses), and is charged with applicable administrative expenses in accordance with the Plan. The value of a participant's vested account represents their benefit under the Plan.
4. Vesting Elective deferrals (including Roth) are 100% vested immediately. Employer matching and non-elective contributions vest on a 6-year graded schedule (0%, 20%, 40%, 60%, 80%, 100%). Participants become fully vested upon Plan termination, attainment of Normal Retirement Age, death, or disability, as applicable.

**A. DESCRIPTION OF PLAN - (CONTINUED)**

5. Distributions                      On termination of employment, a participant may receive their vested account as a lump sum (or annuity if offered by the vendor). In-service distributions are permitted at or after age 59½, upon disability, or for hardship as defined by the Plan. The Plan provides for mandatory cash-outs and automatic IRA rollovers for small account balances consistent with the maximum limit permitted by law. Required minimum distributions are made in accordance with the Internal Revenue Code.
6. Loans                                Participants may borrow from their accounts within limits allowed by the Plan and federal law. The minimum loan amount is \$1,000, and the maximum is the lesser of 50% of the participant's vested account balance or \$50,000 (adjusted for any loans during the prior 12 months). Loans are normally repaid through payroll deductions over five years, or longer if used to purchase a primary residence. No more than two loans may be outstanding at one time.
7. Investment Framework            Participants direct the investment of their accounts among the Plan's available funds. If no election is made, contributions are invested in the Plan's qualified default investment alternative (QDIA).
- The Plan is intended to comply with ERISA §404(c). Plan assets are held in custodial accounts.
- The Plan Year ends December 31. Plan assets are held in custodial accounts and invested through American United Life Insurance Company, the Plan's trustee and recordkeeper.

**B. SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of registered investment companies are valued at published market prices which represent the net asset value of shares held by the Plan at year-end. Participant loans are valued at their outstanding balances which approximates fair value.

**B. SUMMARY OF ACCOUNTING POLICIES - (CONTINUED)**

Investment Valuation and Income Recognition - (continued)

The net appreciation (depreciation) in the fair value of investments is based on the fair value of the investments at the beginning of the year or cost, if purchased during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation)/appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**C. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**E. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Trustee by a letter dated June 30, 2020, that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are shares of mutual funds managed by American United Life Insurance Company. American United Life Insurance Company is the trustee as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the plan to the trustee for investment management services amounted to \$1,591 and \$5,094 for the years ended December 31, 2024 and 2023, respectively.

**G. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**H. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common stocks:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
