Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Total Benefit Management, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer, defined contribution plan administered by Total Benefit Management, Inc. (the Sponsor) covering all full time employees from participating employers (the Employers), who meet certain eligibility requirements. Contributions from the Employers are available to pay benefits to all participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees and Plan Administrator are responsible for oversight of the Plan.

Eligibility

Employees are eligible to begin salary deferrals and receive employer contributions upon completion of a minimum service and age requirement as defined by each participating employer's adoption agreement.

Contributions

Each year participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to maximum limitations established by the Internal Revenue Code. In addition, participants of certain employers have the option to elect to have Roth 401(k) contributions made to the Plan. Roth 401(k) contributions are includable in a participant's taxable gross income for the year in which the contribution is made. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Certain employers participating in the Plan elected automatic enrollment for their employees at a 3% deferral rate.

Under the Plan, certain employers elect to be a safe harbor plan and contribute safe harbor matching contributions. For those employers, each employer determines its own matching contribution formula subject to the overall provisions of the Plan. These contributions may include, but are not limited to, fixed percentage matches based on elective deferrals or tiered matching formulas. Additionally, employers can elect to make discretionary matching contributions as a uniform percentage of employee contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the employer's contribution, Plan earnings/losses, and charged with an allocation of administrative and investment expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions and safe harbor employer matching contributions plus actual earnings/losses thereon. Vesting in the discretionary employer's matching and other discretionary contribution portion of their accounts plus actual earnings/losses thereon is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance from their fund accounts. Loan transactions are treated as transfers between investments and participant loan funds. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate at the time the loan is taken. Principal and interest are paid ratably through payroll deductions. Interest rates on outstanding loans range from 3.25% to 8.5% at December 31, 2024.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their elective deferral contributions, not including earnings.

In-service withdrawals are permitted from all participant accounts upon attainment of normal retirement age.

Investment Options

Investments are held within various investment funds offered and maintained by Nationwide Trust Company, FSB (Nationwide), the custodian of the Plan. Contributions are invested, at the discretion of the participant, in one or a combination of available investment options.

Forfeited Accounts

At December 31, 2024 and 2023, respectively, there was \$0 and \$15,761 of forfeited balances of terminated participants' non-vested accounts. Non-vested forfeited accounts may be used to pay administrative expenses or used to reduce future employer contributions. For the year ended December 31, 2024, \$15,958 in forfeitures were used to reduce employer contributions. No forfeitures were used to pay administrative expenses or reduce employer contributions in 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. This basis does not reflect the Plan's contributions receivable, interest receivable, excess contributions payable, or accrued administrative expenses. The difference in basis of accounting need not be quantified. Accordingly, the financial statements are not intended to present the Net Assets Available for Benefits or their changes in conformity with accounting principles generally accepted in the United States of America.

Plan Mergers and Transfers

The Plan is a multiple-employer plan. Therefore, upon participation, if a joining Employer has an existing 401(k) plan, it will be merged with the Plan. Conversely, if an Employer terminates its participation in the Plan, those assets allocated to participants of the terminated Participating Employer will be transferred out of the Plan. There were \$1,087,585 of assets transferred out of the Plan for the year ended December 31, 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the payment date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on payment date. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

At the Employers' discretion, administrative expenses of the Plan may be paid out of the Plan's assets or may be paid by the Employers. Expenses relating to investment management fees are charged directly against the related investment and are deducted from the participant's account as the transactions occur.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2*: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 3.

Use of Estimates

The preparation of the financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Mutual funds*: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INCOME FUND WITH INSURANCE COMPANY

The Plan is invested in a fully benefit-responsive insurance contract with Nationwide Life Insurance Company. Nationwide Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported by Nationwide Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value to any fund that is not classified as a competing fund. Transfers from the guaranteed income fund may not be made within six months to a competing fund.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the contract at December 31, 2024 and 2023 was \$479,983 and \$558,952 respectively. The crediting interest rate is based on a contractually guaranteed interest rate that may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. At December 31, 2024 and 2023, the interest rate was 2.29% and 2.65%, respectively.

Generally there are no events that could limit the ability of the Plan to transact at contract value. The group investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. At December 31, 2024 and 2023, there are no unfunded commitments and investments are redeemed on a daily basis.

6. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include investment funds managed by Nationwide Trust Company, FSB, who acts as custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also utilizes Morgan Stanley as an investment advisor and Strategic Pension Services, LLC as the plan recordkeeper, so any transactions with those parties also qualify as party-in-interest transactions.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. Therefore, these related transactions qualify as party-in-interest transactions.

7. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by Strategic Pension Services, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trusts are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

9. EXCESS CONTRIBUTIONS

Plan net assets include \$2,369 in excess contributions at December 31, 2024. To satisfy the actual deferral percentage (ADP) test, the Plan refunded the excess contributions, net of investment gains, during 2025. That amount is included in participant contributions on the Plan's statements of changes in net assets available for benefits, for the year ended December 31, 2024.

Plan net assets include \$6,801 in excess contributions at December 31, 2023. To satisfy the actual deferral percentage (ADP) test, the Plan refunded the excess contributions, net of investment gains, during 2024. That amount is included in participant contributions on the Plan's statements of changes in net assets available for benefits, for the year ended December 31, 2023.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 6, 2025, the date the financial statements were available to be issued.
