## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Southern Connecticut I.B.E.W. Annuity Fund

### Opinion

We have audited the financial statements of the Southern Connecticut I.B.E.W. Annuity Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Southern Connecticut I.B.E.W. Annuity Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Southern Connecticut I.B.E.W. Annuity Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Southern Connecticut I.B.E.W. Annuity Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Southern Connecticut I.B.E.W. Annuity Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Report on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules of administrative expenses and schedule of assets held at end of year together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental schedule of assets held at end of year represents supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The supplemental information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**

DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF PLAN**

**General** - The Southern Connecticut I.B.E.W. Annuity Fund (the Plan), formerly the International Brotherhood of Electrical Workers (I.B.E.W.) Local Union No. 488 Annuity Fund, was established by the Board of Trustees on October 7, 1975 to be effective retroactive to March 1, 1975 and is maintained pursuant to collective bargaining agreements. The Plan, as amended and restated, is intended to qualify as a money purchase pension plan under section 401(a) of the Internal Revenue Code (the Code). The purpose of the Plan is to supplement the benefits of the Southern Connecticut I.B.E.W. Pension Fund by the establishment of an individual account plan to which contributions are made for each employee working as an electrical worker in the jurisdiction of I.B.E.W. Local Union No. 488. The Plan is administered by a Board of Trustees consisting of representatives of the employers and the union. The Plan is a defined contribution plan under the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Participants should refer to the Plan Document and its Summary Plan Description for a complete description of the plan provisions.

**Employers' Contributions** - Contributions to the Plan are made by contributing employers at rates established by collective bargaining agreements. The collective bargaining agreement for I.B.E.W. Local Union 488 provides for an hourly contribution rate of \$7.00 effective June 1, 2023 and \$7.70 effective June 1, 2024. Contributing employers primarily conduct business in the State of Connecticut.

Employer contributions are accounted for as exchange transactions.

**Participant Accounts** - An employee becomes a participant in the Plan on the day the participant works at least one hour in covered employment. Covered employment means employment with a contributing employer in a category of work covered by a collective bargaining or participation agreement requiring contributions to the Plan. Participants may direct the investment of employer contributions made on their behalf to any investment option offered under the Plan. If the participant has not specified the allocation into a specific investment type, the contributions will be invested in the guaranteed income fund. Each participant's account is credited with employer contributions and adjusted by investment results and expenses. Administrative expenses are allocated quarterly, on a per capita basis, among those accounts which are in existence, without regard to the value of the participant's account. Net earnings or losses are allocated on a daily basis based upon the investment results of the investment options in a participant's account.

Participants also have an option to invest up to 25% of their account in Prudential's Self-Directed Brokerage Account. The Self-Directed Brokerage Account allows the participant to invest in any of the investments offered through Prudential Financial, Inc.

**NOTE 1. DESCRIPTION OF PLAN (continued)**

**Plan Benefits** - Participants are entitled to their vested benefits upon retirement, disability, death, or termination of covered employment. An election for distribution must be filed indicating the method of distribution and approved by the Board of Trustees. The participant may receive benefits in one lump-sum payment, partial distributions or in equal periodic installments over a fixed number of years.

**Vesting** - Participants are 100% vested in the value of the employer contributions made on their behalf, plus the allocation of net earnings or losses and administrative expenses.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting.

**Employer Contributions** - Employer contributions due and not paid prior to year-end are recorded as receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded for the years ended December 31, 2024 and 2023.

Contributions from 9 employers comprised 78% of total contributions for the year ended December 31, 2024.

Reciprocal contributions represent amounts received from other International Brotherhood of Electrical Workers' fund offices for paid hours worked by electrical workers who are members of the Plan.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value as determined by quoted market prices. See Note 3 for discussion of investment contract with insurance company and Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

### **NOTE 3. INSURANCE COMPANY ISSUED EVERGREEN GROUP ANNUITY PRODUCT**

The Plan has an insurance company issued evergreen group annuity product with Empower Retirement Insurance and Annuity Company (Empower). Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals, and fees. Contract value is also often referred to as “Book Value”. The contract is affected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Empower considers this contract to be fully benefit responsive.

The concept of value other than contract value does not apply to this insurance company issued general account backed evergreen (no maturity date) group annuity spread product even upon a discontinuance of the contract in which case contract value would be paid no later than 90 days from the date the sponsor provides notice to discontinue. The contract’s operation is different than many other evergreen group annuity products in the market by virtue of the fact that a market value (Fair Value) adjustment does not apply upon discontinuance. There are not any specific securities in the general account that back the liabilities of this annuity contract and it would be inappropriate to look to the market value of the securities within the insurer’s general account to determine a fair value. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. This product is not a traditional GIC and therefore there are not any known cashflows that could be discounted.

Generally there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid overtime.

There are not any events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

### **NOTE 4. PLAN TERMINATION**

Although they have not expressed any intent to do so, the Trustees of the Plan and the Connecticut Chapter of the National Electrical Contractors Association, Inc., by mutual agreement, reserve the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the participants are entitled to the balance in their account, which is fully vested and nonforfeitable, after providing for all of the expenses of the Plan at termination.

### **NOTE 5. TAX STATUS**

The Plan is qualified under Section 401(a) of the Code and the related trust is exempt from federal income tax under Section 501(a).

**NOTE 5. TAX STATUS (continued)**

The Plan obtained its latest determination letter on March 18, 2016, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan's legal counsel believes that the Plan is currently designed, and the Plan administrator believes that the Plan is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6. RECIPROCAL AGREEMENTS**

Reciprocal contributions represent amounts received from other International Brotherhood of Electrical Workers Fund Offices for paid hours worked by electrical workers who are participants in the Annuity Fund whose home local is I.B.E.W. Local 488. Reciprocal expense represents amounts paid to other International Brotherhood of Electrical Workers' fund offices for hours worked in I.B.E.W. Local 488 jurisdiction. The contributions are based on the rate stated in the collective bargaining agreement in effect where the work is performed. These amounts are shown net on the Statements of Changes in Net Assets Available for Benefits.

**NOTE 7. CONTRACT ADMINISTRATION**

The Plan had a contract with Zenith American Solutions (Zenith), a third-party administrator, to administer the Plan. The agreement extended automatically thereafter in one year increments, without further action by either party unless terminated. The Plan also had an agreement with Zenith to administer the single check system for a monthly fee of \$237. The Board of Trustees approved an increase in the combined administration and single check system fees to \$5,787 effective January 1, 2024 and \$5,618 effective January 1, 2023. Effective September 1, 2024 these agreements were terminated.

Effective September 1, 2024, the Plan entered into a contract with Solxsys Administrative Solutions, LLC, a third party administrator, to administer the plan. The agreement charges the Plan a fee of \$5,000 a month.

## NOTE 8. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* - pooled separate accounts are valued at the net asset value (NAV) of the units held by the Plan at year end. The NAV is based on the fair value of the underlying assets owned by the fund, net of an investment management fee. The investment management fee is deducted prior to setting the daily unit value.

*Registered Investment Companies* - the registered investment companies' investments are valued at the net asset value of shares held by the Plan at year end and are classified within level 1 of the valuation hierarchy.

**NOTE 8. FAIR VALUE MEASUREMENTS (continued)**

*Participant - directed brokerage accounts* - these accounts are made up of common stocks that are valued at the closing price on the active market on which the individual securities are traded.

During the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

#### **NOTE 9. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS**

The Southern Connecticut I.B.E.W. Pension Fund is related to the Plan through common trustees. The Funds share the cost of meeting expenses, fiduciary bond coverage, and field audit fees. The Plan's portion of shared expenses totaled \$21,024 for the year ended December 31, 2024 and \$23,836 for 2023.

Certain plan investments are mutual funds managed by Prudential Insurance Company of America. Prudential is the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental schedules of assets held at end of year.

#### **NOTE 10. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 11. REVENUE SHARING**

Empower Retirement Insurance and Annuity Company were paid service fees totaling \$168,531 and \$152,157 for the years ended December 31, 2024 and 2023, respectively.

From the above amount, the Plan receives a reimbursement from Empower Retirement Insurance and Annuity Company, the Plan's record keeper, to offset the Plan's cost of providing administrative services to its participants. The reimbursement is in accordance with the terms set forth in the Administrative Services Agreement. The amounts received from the Empower Retirement Insurance and Annuity Group totaled \$99,753 and \$108,947 for the years ended December 31, 2024 and 2023, respectively. The balance of \$68,778 and \$43,210 was retained by Empower Retirement Insurance and Annuity Company for record keeping fees.

#### **NOTE 12. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
