We have performed audits of the financial statements of CompoSecure, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF PLAN

The following description of the CompoSecure, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and adoption agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that is qualified under Section 401 of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Eligibility

The Plan covers all employees of CompoSecure, LLC (the “Plan Sponsor” or “Employer”) except for union and leased employees and non-resident aliens. Employees are eligible to participate if they are 21 years or older and have more than 90 days of service.

#### Contributions

Participants are eligible to make elective deferrals of up to 100% of their eligible compensation on a pre-tax or Roth basis depending on the program as further described in the Plan document, not to exceed annual Internal Revenue Code (“IRC”) limits. The Plan has an automatic enrollment feature in which participants are automatically enrolled at 3% of eligible compensation and that percentage is escalated by 1% each year for 3 years until the participant’s enrollment percentage is equal to 6% of eligible compensation. Participants can opt out at any time. The Plan Sponsor matching contributions are equal to (i) 100% of the Participant’s matched employee contributions that are not in excess of 1% of the participant’s eligible compensation, plus (ii) 50% of the amount of the participant’s matched employee contributions that exceed 1% of the participants’ eligible compensation but that do not exceed 6% of the participant’s eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

A participant who attains age 50 before the end of the Plan year may defer an additional amount, which is referred to as a “Catch-up Contribution,” not to exceed the IRC limit in effect for the year.

Participating employees may elect to allocate their contributions and Plan Sponsor matching contributions into a number of investment funds offered under the Plan in any combination of 1% increments that combined equal 100%. Participants may change their election or transfer monies between funds daily.

#### Participant Accounts

Each participant’s account is credited with participant contributions, Plan Sponsor matching contributions, and an allocation of investment earnings and is charged with withdrawals, an allocation of investment losses and certain participant-requested service expenses, if applicable. Allocations are based on a participant’s compensation or account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### **Vesting**

Participant contributions and rollovers are fully vested upon contribution. Plan Sponsor matching contributions vest based upon completed years of credited service: less than two years - none; two or more years 100%. If employment ends for any reason other than retirement on or after age 65, early retirement, death, or permanent disability, the full current value of any unvested portion of the participant's account will be forfeited.

### **Forfeitures**

Forfeitures are used to reduce Plan Sponsor contributions or to pay Plan expenses. During 2024 and 2023, forfeitures of \$94,197 and \$12,200, respectively, were used to reduce Plan Sponsor contributions. As of December 31, 2024 and 2023, there were \$0 and \$37,545, respectively, of remaining forfeited non-vested account balances.

### **Notes Receivable from Participants**

Participants are eligible for a loan if the participant is an active employee. Participants may apply for a loan from the Plan for the purpose of enabling them to meet a financial hardship or an unusual or special situation related to participant financial affairs. Any new loans, when added to the outstanding balance of all other loans from the Plan will be limited to the lesser of (a) \$50,000 reduced by the excess, if any, of the Participants highest outstanding loan from the Plan during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan, or (b) 1/2 of the participant's vested interest in the Plan. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.5% to 9.5% which are commensurate with local prevailing rates as determined by the Plan administrator. No more than one loan outstanding per participant is allowed. Principal and interest are paid ratably through payroll deductions.

### **Investment Options**

Participants may direct both employee and matching contributions to be invested amongst various investment options as made available and determined by the Plan administrator, which are more fully described in the Plan document. Participants may change their investment options at any time throughout the year with the service provider.

### **Payment of Benefits**

Upon separation of employment due to termination of employment, death, disability or retirement, participants may, at their election, withdraw their benefits or maintain their vested balance in the Plan. If the value of a separated participant's vested balance is less than \$5,000, vested portions will be distributed to the participant in a lump sum payment. Participants are permitted certain in-service withdrawals from their accounts for financial hardships, attaining age 59½ or upon becoming disabled. Participants, at any time, may also withdraw amounts attributable to their after-tax contributions, rollover contributions and/or any portion of their transferred balance that is available under a grandfathered withdrawal option. Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

### Termination of the Plan

While the Plan Sponsor has not expressed any intent to discontinue the Plan, the Plan Sponsor reserves the right to amend or terminate the Plan at any time. Upon termination of the Plan, all funds in each participant's account shall be fully vested.

## 2. SUMMARY OF ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Payments of Benefits

Benefits are recorded when paid.

### Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a taxable benefit payment is recorded.

### Administrative Expenses

Accounting fees and certain administrative expenses of the Plan may be paid by the Plan or by the Plan Sponsor. Loan origination and certain distribution fees are charged against participant accounts. Investment related expenses are included in net appreciation in fair value of investments.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance company. See Note 3 for discussion of fair value measurements. Note 4 for discussion of the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 3. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board has published authoritative guidance on Fair Value Measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Also included in Level 2 are investments measured using a net asset value (“NAV”) per share, or its equivalent, that may be redeemed at that NAV at the period end date or in the near term, which is generally considered to be 90 days.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Pooled Separate Account* - Valued at the NAV or equivalent based on units of the pooled separate account. The NAV, as provided by Voya Retirement Insurance and Annuity Company (“VRIAC” or “Insurance Company”), is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different from the reported NAV. Redemption of the pooled separate account is generally permitted daily and there are no unfunded commitments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. GUARANTEED INVESTMENT CONTRACT WITH PLAN'S INSURANCE COMPANY

The Plan is a party to a fully benefit-responsive guaranteed investment contract with VRIAC. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer subject to a minimum rate established in the agreement. The crediting rate is reviewed periodically for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAS, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

### **5. RISKS AND UNCERTAINTIES**

The Plan provides for participant-directed investment of their voluntary contributions and Plan Sponsor matching contribution in a number of investment funds. Certain underlying investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### **6. PARTIES-IN-INTEREST**

Certain Plan investments are managed by VRIAC, the insurance company of the Plan. Payments for the services provided by VRIAC qualify as party-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

### **7. INFORMATION CERTIFIED BY THE PLAN'S INSURANCE COMPANY**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company has certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value, investments at contract value and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **8. TAX STATUS**

The IRS has determined and informed the prototype plan sponsor, by an opinion letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Accordingly, the Plan has been accounted for as a tax-exempt plan. The Plan has been amended since the prototype plan sponsor received its opinion letter and the Plan administrator and the trustee believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 23, 2025, the date that the financial statements were available to be issued.

There were no subsequent events that would require recognition or additional disclosure in the Plan's financial statements.
