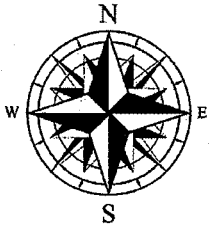

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Putnam Plastics Corporation 401(k) Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Putnam Plastics Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Putnam Plastics Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

1 Description of plan:

The following description of the Putnam Plastics Corporation 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Putnam Plastics Corporation ("Company") who have three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Each year on August 1st, the initial automatic deferral amount will increase by 1 percent of eligible compensation up to a maximum of 11 percent. The Plan currently offers various mutual funds and a fixed annuity fund as investment options for participants. The Company contributes 100 percent of the first 3 percent and 50 percent of the next 2 percent of compensation that a participant contributes to the Plan. The matching Company contribution is invested as directed by the employee. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are invested as directed by the employee. Contributions are subject to certain statutory limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and the Company's matching contribution, and the participant's earnings (losses). There may also be administrative expenses charged, some of which may be based on the participant's transactions, as defined in the Plan. All contributions to the Plan are participant directed and are credited to participants' accounts when received by Empower Trust Company, LLC, the trustee of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are 100% vested immediately.

1 Description of plan (continued):

Notes receivable - participant loans:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% - 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of benefits:

On termination of service, a participant may elect to withdraw any portion of the value of the participant's vested interest in his or her account. Participants may withdraw all or any of their vested account balance in the event of severe financial hardship or upon attainment of age 59 1/2.

2 Summary of significant accounting policies:

Basis of accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United State of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable - participant loans:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. A delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain participant fees and fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of management's review of subsequent events:

Subsequent events were evaluated through October 14, 2025 which is the date the financial statements were available to be issued.

4 Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds* : Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5 Guaranteed Insurance Contract:

The Plan offers a Guaranteed Insurance Contract - Key Guaranteed Portfolio Fund as an available investment option within the Plan. This asset is available through the Plan's group annuity contract with Empower Annuity Insurance Company of America ("Empower"), and is considered to be a fully benefit-responsive guaranteed insurance contract. The Key Guaranteed Portfolio Fund is a fixed account that is part of the general account of Empower and totaled \$449,795 at December 31, 2024. Crediting rates for Key Guaranteed Portfolio Fund are based on a formula established by the contract issuer, are declared in advance, and are reset quarterly. The declared rate will never fall below 0 percent annually. The average yield earned by the plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for 2024 is 1.45 percent. Amounts may be transferred from the participant's account balance in the Key Guaranteed Portfolio Fund at any time. The fixed account value in respect of the participant will be determined as the value of the participant's contributions plus interest and transfers to the fund less any amounts distributed, any transfers from the fund, and any applicable charges.

The contract meets the fully benefit-responsive insurance contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5 Guaranteed Insurance Contract (continued):

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, lay-offs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable. Either party may terminate the contract with at least 60 days advance written notice to the other party. If the parties fail to determine a mutually agreeable contract termination date, the contract termination date will be the 60th business day after the date written notice of contract termination is received at Empower's administrative office. If the Plan is terminated for any reason, the Company shall notify Empower of the date that the final contributions will be remitted to Empower.

6 Related party and party-in-interest transactions:

Certain Plan investments are shares of mutual funds managed by Empower Retirement, LLC. The guaranteed investment contract is managed by Empower Capital Management, LLC. Empower Advisory Group, LLC provides advisory services to the Plan. All are affiliated with Empower Trust Company, LLC, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$124,130 for the year ended December 31, 2024.

PASI, LLC, provides certain administrative services pursuant to a year-to-year engagement agreement between the Company and PASI, LLC. Compensation in the amount \$10,000 was received indirectly as a deduction from the value of the net assets on each valuation day. Fees paid by the Plan for the administrative services amounted to \$4,930 for the year ended December 31, 2024.

Massachusetts Mutual Life Insurance Company provides investment advisory services to the Plan thereby qualifying as a party-in-interest as defined in Section 406 of ERISA. Commission income is received indirectly as a deduction from the value of the net assets on each valuation day. Massachusetts Mutual Life Insurance Company received \$50,435 in compensation for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7 Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8 Tax status:

The Plan has not requested a determination letter from the Internal Revenue Service. The Plan has adopted a pre-approved prototype plan dated June 30, 2020 and relies on the opinion letter received on the prototype document and not on its own individual determination letter. The Plan administrator believes that the plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's tax filings are subject to examination by the appropriate tax jurisdictions and generally remain open for three years.

9 Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
