Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Navicore Solutions Corporate Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Navicore Solutions Corporate Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. A. DESCRIPTION OF PLAN

The Navicore Solutions Corporate Retirement Plan (the "Plan") was formed and commenced on January 1, 1995. The Plan was formed under Internal Revenue Code 401(a) and maintained for the benefit of plan participants and is intended to allow employees to accumulate and receive retirement benefits as well as annual employer profit sharing contributions.

Effective November 1, 2011, notwithstanding anything contrary to the Plan, this Plan was redesigned and no longer accepts employee contributions and is maintained solely for the purpose of the annual employer profit sharing contribution. All employee deferrals on and after such date were made pursuant to the terms of the Navicore Solutions Employee Savings Plan.

The following description of Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General Employer Contributions - The Plan is a defined contribution plan covering all employees of the Company who have one year of service and worked at least one thousand hours during the year and are employed on the last day of the year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions The company contributes a discretionary amount for each Plan Year in an amount determined by the employer. The discretionary contributions are subject to the participant's vesting percentage.
3. Participant Accounts Each participant's account is credited with the allocations of (a) the Company's contribution and (b) Plan earnings. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

A. DESCRIPTION OF PLAN - (continued)

5. Payment of Benefits On termination of service, a participant may elect to receive either (i) a one lump sum payment or (ii) purchasing or providing an annuity. However, such annuity may not be in any form that will provide for payments over a period extending beyond either the life of the participant, or beneficiary, or the life expectancy of the participant, or beneficiary. Benefits payable due to death, total and permanent disability, or attainment of normal retirement age, the optional forms of benefit are a single-sum payment and any annuity that is an optional form of retirement benefit.
6. Forfeited Accounts At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$1,308, respectively. If there is a balance remaining in these accounts they will be used in the following ways: (a) shall first be applied to restore account balances where restoration contributions have been made, (b) may be applied to pay expenses of administration, (c) shall be used to reduce any employer contribution obligation and (d) shall then be considered as additional employer contributions and shall be allocated as part of the employer contribution.

B. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of registered investment companies are valued at published market prices which represent the net asset value of shares held by the Plan at year-end. Participant loans are valued at their outstanding balances which approximates fair value.

The net appreciation (depreciation) in the fair value of investments is based on the fair value of the investments at the beginning of the year or cost, if purchased during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

B. SUMMARY OF ACCOUNTING POLICIES - (continued)

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation)/appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

C. PLAN TERMINATION

In the first quarter of 2024, the Company approved the termination of the Plan, a defined contribution plan subject to ERISA. In connection with the termination, all participants became 100% vested. Within approximately one to two months, all Plan assets were distributed as cash payments or, at participants' election, as direct rollovers to eligible retirement arrangements (including the Company's Navicore Solutions Employee Savings Plan (403(b))). As a result, there were no net assets available for benefits as of December 31, 2024. The Form 5500 filed for the plan year ended December 31, 2024 will be marked "final return/report," reflecting the full termination of the Plan.

E. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Trustee by a letter dated June 30, 2020, that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by American United Life Insurance Company. American United Life Insurance Company is the trustee, as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the plan to American United Life Insurance Company for investment management services amounted to \$2,154 and \$4,188 for the years ended December 31, 2024 and 2023, respectively.

G. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

H. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in active markets;• Inputs other than quoted prices that are observable for the asset or liability;• Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered by the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
