Independent Auditor's Report

To the Board of Directors
Apostolic Christian Home
Employees Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Apostolic Christian Home Employees Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Apostolic Christian Home Employees Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Apostolic Christian Home Employees Retirement Plan and to meet our other ethical responsibilities, in accordance with

the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Apostolic Christian Home Employees Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Apostolic Christian Home Employees Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Apostolic Christian Home Employees Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, as identified in the table of contents, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

NOTE 1
DESCRIPTION OF PLAN

The following description of the Apostolic Christian Home (the Organization) Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all full-time employees of the Organization who are at least 21 years old. Full-time employees may elect to make participant contributions as soon as administratively possible at the date of employment. Employees are eligible for an employer matching contribution after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Organization oversees the governance of the Plan. The assets of the Plan are maintained under an agreement with American United Life Insurance Company, a OneAmerica company (the custodian), who also performs recordkeeping functions related to the employee account balances.

Basis of accounting – The Plan prepares its financial statements using the accrual basis of accounting.

Contributions – Each year, participants may contribute up to the lesser of 100% of their wages or the elective deferral limit plus the catch-up contribution for employees 50 and older, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization contributes a matching contribution equal to the employee's contribution plus 2%, up to a maximum of 7% of the employee's compensation. The matching contribution is invested in the same ratio as the participant-directed contributions. Employer and employee contributions are subject to certain limitations prescribed by the Internal Revenue Service.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution, (b) the Plan earnings, and (c) administrative expenses. Allocations of Organization contributions are based on participant compensation as defined in the Plan. Allocations of Plan earnings and expenses are based on participant account balances and investments held. Certain expenses of the Plan are participant-specific and are allocated only to the participants to which they relate. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits – On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive any or all of the participant's vested interest in his or her account on any distribution date following his or her separation from service. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Non-vested amounts from separated participants are used to pay plan expenses or reduce employer contributions.

NOTE 2
SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Contributions Receivable – The Plan considers participant contributions receivable to the Plan on the date they are withheld from the participant's paycheck. Employer contributions receivable may include any nonelective match made for the current year but deposited in the subsequent year. No allowance for credit losses exists as there were no contribution receivables as of December 31, 2024 and 2023.

Participant loans – Participants previously could borrow up to the lesser of 50% of the vested account balance or \$50,000, subject to the terms and conditions of the Plan. The loan is secured by the borrower's account balance and bears interest based on prevailing rates at the time of the loan. Net assets represented by the loan are specifically allocated to the participant account of the borrower. No new participant loans are allowed under the plan.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties - The Plan utilizes various investments. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment valuation and income recognition - The Plan's investments in American United Life Insurance Company's (AUL) separate account are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investments in group annuity contracts are fully benefit-responsive investment contracts reported at contract value. The Plan invests in an investment contract through an unallocated general account.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Corrective distributions - The Plan records corrective distributions as an expense in the year of the distribution rather than recording the amount as a payable at the end of the year. The amount is recognized as a distribution rather than as a reduction of investment income. The amount of corrective distributions is immaterial.

Operating expenses – All investments, including the ones utilized by the Plan, have expenses associated with their management and operations. All expenses of the Plan are paid by either the Plan or the Organization, as provided by the Plan document. The Organization did not make any material payments for the Plan in 2024 or 2023.

NOTE 3
PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4
TAX STATUS

The Plan has adopted the OneAmerica Financial Partners, Inc. 403(b) Prototype Plan. The volume submitter 403(b) plan received notification from the Internal Revenue Service by a letter dated November 22, 2017, that it is acceptable under Section 403 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its tax exemption. The Plan's administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5
SEPARATED PARTICIPANTS AND FORFEITURES

As of December 31, 2024, net assets available for benefits included \$2,881,358 that was allocated to participants who have separated from service. Of this amount, \$2,857,029 was vested.

Forfeited nonvested amounts used totaled \$14,479, and forfeitures totaled \$12,367 in 2024. The forfeiture account balance was \$0 at December 31, 2024.

Forfeited nonvested amounts used totaled \$4,554, and forfeitures totaled \$2,533 in 2023. The forfeiture account balance was \$2,101 at December 31, 2023.

NOTE 7
PARTIES IN INTEREST

The Plan invests in certain funds in separate accounts and group annuity contracts managed by AUL, the Plan custodian. The total fair value of funds in separate accounts and contract value of group annuity contracts managed by AUL was \$7,549,211 and \$8,325,577 as of December 31, 2024 and 2023, respectively. All administrative fees received by AUL and affiliates are paid from the related investment accounts and applied to reduce earnings on the accounts. AUL has estimated total Plan fees and compensation paid to them and related service providers in connection with the Plan to be \$41,551 and \$36,331 in 2024 and 2023, respectively.

NOTE 8
FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standard Codification (FASB ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Level 2 Assets: Investments in AUL's separate account – Amounts allocated to a variable investment account within an AUL separate account are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distribution received and the daily equivalent of any fee charged pursuant to the contract.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive contract with AUL. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the plan.

Because the guaranteed investment contract, listed in the statement of net assets available for benefits as investments in group annuity contract, meets the criteria to be fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported by the recordkeeper, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer or all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$3,752,133 and \$4,475,474, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 10

SUBSEQUENT EVENTS

Plan assets were moved to Voya Financial beginning on January 1, 2025, and split into two plans under two separate trusts. Due to this, no plan audit will be required for the 2025 plan year.

Plan management evaluated subsequent events through September 5, 2025, which is the date the financial statements were available to be issued.

NOTE 11
PLAN ADOPTIONS

During the year ended December 31, 2020, the Plan adopted provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act including coronavirus-related distributions, repayment of coronavirus-related distributions, and suspension of required minimum distributions. Provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act also went into effect on January 1, 2020. Provisions of the SECURE Act 2.0 went into effect on December 29, 2022. There were no significant provisions of the SECURE Act and SECURE Act 2.0 that affected the Plan in 2024 or 2023. Management plans on formally amending the plan for these provisions before the required due date.
