### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial



statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of the Plan

The following description of the HR&A Advisors, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### *General*

Effective January 1, 2011, HR&A Advisors, Inc. (HR&A Advisors, the Company, or the Employer) established the Plan. As of January 1, 2016, the Plan was amended and operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Retirement Committee appointed by the Company's Board of Directors. An independent third-party legal counsel is the Plan's appointed directed trustee (Trustee).

#### *Employer Common Stock Purchase*

On December 8, 2016, the HR&A Advisors Employee Stock Ownership Trust (the Trust) purchased 9,643 shares of the Company's common stock (representing 100% of the Company's total common stock issued and outstanding) for \$14,439,443, financed by \$1,000,000 in cash and \$13,439,443 in a note payable (the Note) to the Company (see Note 5). The stock was purchased at the fair value of \$1,497.40 per share, as determined by a third-party valuation specialist.

The Note is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- The accounts of employees with vested and non-vested rights in allocated shares of Company common stock (allocated).
- Shares of Company common stock not yet allocated to participants (unallocated).

#### *Eligibility*

Employees must be 21 years of age or older and complete 1,000 hours of service at the close of an eligibility computation period, as defined, to receive an allocation of Employer contributions. Employees covered under a collective-bargaining agreement, non-resident aliens, and employees paid on an hourly basis are not eligible to participate in the Plan. Subject to the approval of the Company, employees may make a one-time irrevocable election not to participate in the ESOP.

#### *Participant Contributions*

Employee contributions are not permitted.

### ***Employer Contributions***

The Employer is obligated to make contributions in cash to the Plan, which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on the Note. The Employer may contribute, at its discretion, any additional amounts provided that such contributions do not exceed the maximum amount deductible under the IRC. The Employer contributions for the year ended December 31, 2024 totaled \$811,324.

### ***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation of all participants. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

### ***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to the approval and disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets, and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee shall vote, as directed by the Retirement Committee: (1) all matters not subject to direction by participants, (2) any allocated shares of participants that fail to exercise his or her voting rights, (3) any allocated shares for which the Trustee determines that participant voting instructions would be a violation of ERISA, and (4) all unallocated shares held in the suspense account in the Plan. The Trustee is required to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries in accordance with ERISA.

### ***Vesting***

If, while employed by the Company, a participant dies, incurs a disability, or reaches normal retirement age, as defined, the participant will become fully vested. If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balance in his or her account based on total years of service with the Company.

### ***Put Option***

Under federal income tax regulations, Company stock that is held by the Plan and its participants and is not readily tradable on an established securities market, or is subject to trading limitations, must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is based on the valuation of the shares as of the immediately preceding Plan year-end. The Company can pay for the purchase with interest over a period of five years. Instead of the Employer purchasing the shares, the Trustee, as directed by the Retirement Committee, may offer to purchase the shares from the participant and agree to pay the purchase price. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### ***Notes Receivable from Participants***

Participants are not allowed to borrow from their account in the Plan.

### ***Due to Company***

The Company may, at times, pay the distributions due to withdrawing participants of the Plan. The Plan will record the amount as due to Company. These amounts are expected to be repaid to the Company in the subsequent period.

### ***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may elect to diversify up to 25% of the number of Company common stock shares allocated to his or her account, less any Company common stock shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution that will be transferred to another qualified defined contribution plan maintained by the Employer. The election to diversify is made within 90 days subsequent to each Plan year-end based upon the shares of Company stock in the participant's account at the Plan's year-end.

### ***Payment of Benefits***

Generally, distributions on account of death, disability, or retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service shall commence to be paid not later than one year after the close of the third Plan year following the Plan year in which the participant terminates employment. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock. Shares of Employer securities distributed to a participant shall be subject to a "right of first refusal" under which the shares to a prospective buyer or transferee other than the Employer or Trust must first be offered to the Employer and then to the Trust. The selling price shall be the greater of the purchase price offered by the prospective buyer, if any, or the fair market value of the Employer securities. Under the provisions of the Plan, the Company is obligated to repurchase participant

shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

### ***Forfeitures***

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during December 31, 2024 totaled \$10,041. There were no accrued forfeited non-vested accounts to be allocated to participant accounts as of December 31, 2024 and 2023.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets (deficit) available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### ***Allocations***

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Investment Valuation and Income Recognition***

Mutual funds and the shares of Company common stock are reported at fair value (see Note 4). Dividend income is accrued on the ex-dividend date. Fund transactions are accounted for on the trade date (date the securities are purchased or sold). The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses, and the unrealized appreciation of investments bought and sold, as well as held during the year.

### *Investment Management Fees and Operating Expenses*

Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in the fair value of investments.

### *Administrative Expenses*

As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the majority of operating expenses for the Plan.

The Plan recognized administrative expenses totaling \$2,252 for the year ended December 31, 2024.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Valuation is based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Valuation is based on quoted prices for similar assets or liabilities in active markets, for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the financial instrument has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the financial instrument.

*Level 3* - Valuation is based on inputs that are unobservable and significant to the overall fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation process involves the selection of an appraiser, and Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per-share value that a participant will receive upon distribution.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Note Payable

In 2016, the Plan entered into a promissory note with the Company for \$13,439,443, bearing interest at 2.26%. The proceeds of the loan were used to finance the purchase of Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current-year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 336.8851 shares being released and allocated for the Plan year ended December 31, 2024. The agreement provides for the loan to be repaid over 30 years.

### 6. Tax Status

The Plan obtained its latest determination letter on October 24, 2017 from the Internal Revenue Service (IRS) stating that the Plan, as then-designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related Trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risk and Uncertainties

The Plan's investments consist primarily of the Company's common stock. The Plan also invests in various publicly traded mutual funds. These investments are exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with these investments and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 8. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Retirement Committee directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the Note. Subsequently, the interest of each participant in the Trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

### **9. Related Party/Party-in-Interest**

Certain Plan mutual funds are managed by Charles Schwab & Co. Inc., the custodian of the Plan. The Plan also invests in Company common stock and has indebtedness to the Company. These transactions qualify as related party and party-in-interest transactions. Certain fees paid by the Plan for the investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than a direct payment. The Plan has a number of service providers, and such providers are parties-in-interest under ERISA.

Certain distributions to Plan participants were paid by the Company. Plan liabilities include amounts due back to the Company of \$154,619 and \$243,420 as of December 31, 2024 and 2023, respectively.

Plan management has performed subsequent event procedures through October 13, 2025, which is the date the financial statements were available to be issued. No subsequent events that would require disclosure in these financial statements have been noted as of this date.
