Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of the Plan

The following description of the OTG Concessions Management, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for the complete information.

General

The Plan was established on January 1, 2006, and then subsequently amended and last restated on December 29, 2022. The Plan is a defined contribution plan and is subject to the *Employee Retirement Income Security Act of 1974* (ERISA). Employees of OTG Concessions Management, LLC and its subsidiaries (collectively referred to as the Company or Employer) are eligible to participate in the Plan, except for employees eligible to receive employer contributions to a union retirement plan, in connection with a collective bargaining agreement.

CARES Act

On March 27, 2020, President Trump signed into law the *Coronavirus Aid, Relief and Economic Security Act* (CARES Act). The CARES Act, among other things, includes several relief provisions available to tax-qualified retirement plans and their participants. Plan management evaluated the relief provisions available to plan participants under the CARES Act and implemented the following provisions:

- Special coronavirus distributions up to \$100,000 for qualified individuals.
- Increased plan loan limits to qualified individuals, as described below, to the lesser of \$100,000 or 100% of the participant's vested account balance.
- Suspension of plan loan repayments to qualified individuals, up to one year.
- Waiver of all required minimum distributions for all participants.

These relief provisions expired on December 31, 2020. Plan management will amend their plan document to retroactively adopt these provisions no later than December 31, 2025.

Eligibility

All full-time employees of the Company are eligible to participate in the Plan on the first day of the month following the completion of six months of service and the attainment of age 21.

Contributions

Participant contributions are made on a pre-tax basis, not to exceed statutory limits. Participants who attain age 50 before the close of the plan year are eligible to make catch-up contributions, as defined in the Plan. Participants also may contribute amounts representing distributions from other qualified defined contribution plans. The Company may make discretionary profit-sharing contributions to the Plan in accordance with the provisions contained in the plan document. No discretionary profit-sharing employer contributions were made by the Company for the year ended December 31, 2024.

The Company is required to make a safe-harbor matching contribution equal to 100% of a participant's salary deferral contributions, up to 4% of their compensation, and 50% of the participant's salary deferral contributions that exceed 4% of their compensation, not to exceed 6%.

Participant Accounts

Each participant's account is credited with their deferred contributions, Company contributions, and allocations of their investment earnings net of related fees. Contributions are invested based upon the percent allocation elected by the participant into one or more of the investment options available to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Each participant is permitted to borrow from their account an amount not to exceed 50% of their vested account balance, up to a maximum of \$50,000. The minimum amount that may be borrowed is \$1,000. Only one loan may be outstanding at a time. Loan terms may not exceed 5 years, except to purchase a primary residence, the term of which cannot exceed 10 years. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Interest rates at December 31, 2024 ranged from 4.25% to 9.50%.

Vesting

Participants are fully vested at all times in their elective deferrals, the safe-harbor matching contributions, and discretionary profit-sharing employer contributions, plus earnings thereon.

Benefit Payments

A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement, or death. Participants may withdraw from their individual accounts, pursuant to specific guidelines as set forth in the plan document.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, see Note 4. The sales and purchases of investment securities, and gains and losses on the sale of investments, are recognized at the trade date. Net appreciation includes the Plan's gains (and losses) on investments bought and sold, as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance, plus any accrued but unpaid interest. Defaulted notes are recorded as benefit payments according to the terms of the plan document. Fees charged by the trustee relating to notes receivable from participants are paid from the related participants' accounts. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Most administrative expenses of the Plan are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

Note 3. Certifications of Plan Trustees

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Disclosures About Fair Value of Plan Assets

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds: valued at unadjusted quoted prices, which represent the net asset value (NAV) of shares held by the Plan at year end.
- Collective investment trusts: The value of the collective investment trusts is determined based on the underlying assets, which represents the net asset value, a practical expedient of fair value, of units held by the Plan. The objective is to diversify risk based on the associated target retirement date. The Plan's investment in the collective investment trusts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments as of December 31, 2024 and 2023.

- Common collective trusts – stable value fund: The fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which represents the net asset value, a practical expedient of fair value, of units held by the Plan. The common collective trust fund seeks to preserve the principal investment while earning a level of interest income that is consistent with principal preservation and invests primarily in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds. The common collective trusts do not have any unfunded commitments relating to their investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

All investments are issued and managed by T. Rowe Price, the recordkeeper of the Plan. Any purchases and sales transactions of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions. Administrative fees paid by the Plan for administrative services amounted to \$212,642 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to change or terminate the Plan subject to the provisions of ERISA. In the event of termination, participants become 100% vested and plan assets will be distributed to participants based on their individual account balances.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by T. Rowe Price Retirement Plan Services Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amount reported in the statements of net assets available for benefits.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of approximately \$1.29M and \$1.20M were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively.

Note 11. Subsequent Events

The Plan's management has evaluated subsequent events through October 8, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
