1. Description of Plan

The following description of the First Atlantic Corporation (Company) 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, adopted September 1, 1995, is a contributory, defined contribution plan. All employees of the Company are eligible after completing one year of service and attaining age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

A participant may elect to make pre-tax and Roth deferral contributions to the Plan up to 100% of compensation or the Internal Revenue Service (IRS) limit, whichever is lower. Participants may also contribute amounts representing distributions from other retirement plans. Additional amounts may be contributed by the Company, at the option of the Company's management. Employees represented by a bargaining unit are not eligible for employer contributions.

Effective October 1, 2022, employees of the Company who are eligible and participate in the Plan may receive a discretionary employer matching contribution. Discretionary contributions for the year ended December 31, 2024, were 100% of deferrals up to 1% of eligible compensation.

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. Employer matching contributions are vested according to the following schedule:

Forfeitures

When a participant terminates employment prior to vesting in all of his or her employer provided benefits, unvested employer contributions and the net investment income thereon are forfeited. Forfeitures are used to fund the employer contribution. The timing of such forfeitures is subject to

certain Plan agreement stipulations based on continuous years of nonemployment and the distribution of the vested portion of the participant's account. At December 31, 2024 and 2023, there were total forfeitures available of \$11,615 and \$7,131, respectively. No forfeitures from nonvested accounts were used in 2024.

Participants' Accounts

Each participant's account is credited with the participant's contribution and the Company matching contribution. Allocations of any additional Company contribution and Plan earnings are based on participant earnings or account balances.

The Plan allows participants to direct their individual accounts to various investment options within the Plan.

Notes Receivable from Participants

A participant may borrow an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan provisions. Participants may have up to three loans outstanding at any given time. The minimum note that may be taken is \$1,000. Notes must bear a rate of interest equal to 2% above the prime rate. Notes are collateralized by the participant's nonforfeitable interest in the Plan and are supported by a promissory note.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized gains and losses.

Subsequent Events

The Company has considered transactions or events occurring through October 9, 2025, which was the date that the financial statements were available to be issued.

3. Income Tax Status

The Plan utilizes a volume submitter plan designed by the trustee. The Internal Revenue Service has determined and informed the trustee by a letter, dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination; however, the plan administrator believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

5. Information Certified by the Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Reliance Trust Company, the trustee of the Plan, as complete and accurate. This information is disclosed in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Schedule of Assets (Held at End of Year)

6. Related-Party and Party-in-Interest Transactions

Certain Plan investments are in a stable value fund with Transamerica, the recordkeeper, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to Transamerica, were \$66,866 during 2024. Loan fees of \$5,435 were paid to a third-party administrator by the participants. Investment advisory fees of \$25,066 were also paid from Plan assets and are recorded as part of net appreciation in fair value of investments.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balance and the amounts reported in the statements of net assets available for benefits.

8. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of units held by the Plan at year-end.

Stable value fund: Valued at contract value reported by the Fund as of the Plan's year-end. The fund manager asserts that contract value approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
