INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Amalgamated Meat Cutters and Retail Food Store
Employees Union, Local 342 Health Care Fund

Opinion

We have audited the financial statements of the Amalgamated Meat Cutters and Retail Food Store Employees Union, Local 342 Health Care Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Substantial Doubt about the Plan's Ability to Continue as a Going Concern

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 10 to the financial statements, the Plan has a significant unfunded obligation for benefit claims payable, insurance premiums payable and benefit claims estimated to be incurred but not reported to the Plan as of December 31, 2023. The benefit obligations of \$8,411,850 exceeded the Plan's net assets available for benefits of \$8,075,792 by \$336,058 as of December 31, 2023. Plan management's evaluation of the events and conditions and management's plan regarding these matters are also described in Note 10. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Report on Supplemental Information

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets Held at End of Year and Schedules of Administrative Expenses, together referred to as "supplemental information," are presented for the purpose of additional analysis and are not a required part of the financial statements. The supplemental Schedule of Assets Held at End of Year represent supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Amalgamated Meat Cutters and Retail Food Store Employees Union, Local 342 Health Care Fund (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

Benefits - The Plan provides hospitalization, medical, prescription drug, dental, optical, life insurance, weekly sickness and accident, accidental death and dismemberment, and such others benefits to eligible participants. The Plan also provides certain benefits to eligible spouses and dependents of participants as well as retirees and their dependents.

A participant generally becomes eligible by completing 12 months of covered employment immediately preceding the date a claim is incurred.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Investments and Income Recognition - Investments in common/collective fund, and common stock are carried at fair value which generally represents quoted market prices as of the last business day of the year as provided by the custodian or investment manager or valued using pricing models maximizing the use of observable inputs for similar securities with similar credit ratings. The short-term investment is carried at cost, which approximates fair value. The investments of the Plan are managed and maintained by an independent custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income are recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions - Contributions due but not paid at year end are recorded as a receivable. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was \$60,100 and \$56,400, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Securities Purchased and Sold and Not Settled - This represents the amounts due from or to the custodial bank for sale or purchase of securities with trade dates prior to year-end and settlement dates after year end.

Claims Incurred but not Reported - Claims incurred but not reported at year end were estimated by the Plan's consultant based on claims experience.

Benefit Obligation Presentation - As allowed by relevant accounting standards the Plan is presenting the benefit obligations and the changes in benefit obligation in the notes to financial statements.

Benefits - Benefit payments to or for participants are recorded when paid.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Reclassification - Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

NOTE 3. FUNDING POLICY

The Plan is financed by employer contributions and contributions from participants electing COBRA coverage. The employer contribution rates are specified in the collective bargaining agreements. Employer contributions are accounted for as exchange transactions.

The employer contribution rates in effect ranged from \$133 to \$2,893 per month during the years ended December 31, 2024 and 2023.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 5. TAX STATUS

The Plan obtained its latest exemption letter in 1989 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(c)(9). The Plan has been amended since receiving the exemption letter.

The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

The Plan reimburses UFCW Union Local 342, AMCU & RSFEU Local 342 Welfare Fund and AMCU & RSFEU Local 342 Group Legal Services Fund for its portion of certain shared administrative expenses, which includes salaries, employee benefits and payroll taxes. The shared administrative expenses are allocated on a basis approved by the Plan's Trustees. Due to or from related entities on the Statements of Net Assets Available for Benefits represents the balance owed or receivable for these reimbursements as of December 31, 2024 and 2023, respectively. The reimbursed amounts for the years ended December 31, 2024 and 2023 were \$2,071,557 and \$1,860,527, respectively.

The Plan shares the cost of the UFCW Local 342 employee pension benefit withdrawal liability due to the Local 153 OPEIU Pension Fund based on a shared expense allocation agreement. The withdrawal liability was determined in March 2013 and reallocated in July 2015 and again in March 2024. The Plan has an allocated withdrawal liability of \$333,641 and \$236,039 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, the Plan made payments of its allocated portion totaling \$52,550 and \$35,892, respectively.

NOTE 8. RELATED ORGANIZATIONS (continued)

Certain plan investments are managed by Amalgamated Bank. Amalgamated Bank is the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. These transactions have been denoted as such on the supplemental Schedule of Assets Held at End of Year and the Schedule of Reportable Transactions.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 9. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

NOTE 10. GOING CONCERN

The Plan has a significant unfunded obligation for current benefit claims payable and benefit claims estimated to be incurred but not reported to the Plan as of December 31, 2023. The benefit obligations of \$8,411,850 exceeded the Plan's net assets available for benefits of \$8,075,792 by \$336,058 as of December 31, 2023. There is substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are issued. Management has been mitigating the doubt of the Plan's ability to continue as a going concern by changing benefit providers who process the claims, keeping current with claims that come due, trying to increase contributions during negotiations with employers, and trying to decrease administrative expenses. Additionally, the Plan has hired a consultant to negotiate lowering the claims payable obligation backlog and has appointed the fund administrator to oversee the recovery process, including the preparation and evaluation of cash flow forecasts, budgets of administrative expenses and restructuring participant contribution scales. The ability for the Plan to continue as a going concern is dependent upon the successful implementation of the strategies and achieving the intended results. As of December 31, 2024, the Plan's management has negotiated successfully the claims payable backlog and no additional obligations are expected to be paid. The net assets available for benefits of \$10,561,652 exceeded the Plan's benefit obligations of \$5,295,660 by \$5,265,992, so there is no doubt about the ability to continue as a going concern.

NOTE 11. RISKS AND UNCERTAINTIES

The Plan invests in various investments. These investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of postretirement benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 12. POSTRETIREMENT BENEFIT OBLIGATIONS

The Plan provides certain health care coverage to eligible retirees and their dependents. Retirees and certain dependents are covered beginning at retiree's age 62nd birthday and the coverage terminates at the earlier of the retiree's 65th birthday or his or her death.

Accounting principles generally accepted in the United States of America require that the Plan include the actuarial present value of postretirement benefit obligations in the benefit obligations of the Plan.

The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants.

The following are significant assumptions used in the postretirement benefit obligation valuations as of December 31, 2024 and 2023:

Discount rate:	5.5%

The forgoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The health care cost-trend rate assumption has a significant effect on the amounts reported. If the assumed rate increased by one percentage point, that would increase the obligations as of December 31, 2024 and 2023 by \$546,900 and \$505,800, respectively.

NOTE 13. FEES MANDATED BY THE PATIENT PROTECTION AND AFFORDABLE CARE ACT

The Plan is subject to certain fees mandated by the Patient Protection and Affordable Care Act. Fees payable to the Patient-Centered Outcomes Research Institute (PCORI) are equal to \$3.47 per covered life for the 2024 calendar year and \$3.22 for 2023. Thereafter, the fee will be indexed based on increases in the projected per capita amount of national health expenditures. For the years ended December 31, 2024 and 2023, the Plan paid \$12,645 and \$12,343 in PCORI fees, respectively.

NOTE 14. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
