Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BWC Holdings, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of BWC Holdings, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

1. Description of plan

The following description of the BWC Holdings, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan’s provisions.

General

The Plan is an Internal Revenue Code (“IRC”) defined contribution retirement plan covering all eligible employees of BWC Holdings, Inc. (the Company or plan administrator). Eligible employees may begin to participate on the first day of the calendar month following the date the employee attains age 21 and completes one month of service. The Plan is subject to the provisions of ERISA. Representatives from the management of the Company are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance and report to the Plan administrator. Effective November 17, 2023, the Plan's trustee was changed from Reliance Trust Company (“Reliance”) to Empower Trust Company, LLC (“Empower”). Plan assets were transferred from Reliance to Empower on November 17, 2023 and November 20, 2023.

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 was signed into law. The SECURE 2.0 Act is inclusive of approximately 90 provisions which offer many benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year.

The Plan has adopted the required minimum distributions at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of the SECURE 2.0 Act by December 31, 2025.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, up to Code limits. Participants may designate all or a portion of their deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the right to change their deferral rate at any time or to not participate in the Plan.

The Company makes safe harbor matching contributions for eligible participants to the Plan equal to 100% of elective deferrals up to the first 3% of eligible compensation, followed by 50% of the amount over 3% of eligible compensation, not to exceed 5% of eligible compensation, as defined by the Plan. Although the Company may, at its discretion, make additional matching and profit sharing contributions to the Plan, there were no such contributions elected for the years ended December 31, 2024 and 2023. Participants become eligible to receive employer contributions upon completion of one year of service with the Company. Participants also direct the investment of any Company contributions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, safe harbor matching contributions and any Company discretionary matching contributions, if any, as well as allocations of Company discretionary profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Company safe harbor matching contributions plus actual earnings thereon. In the event of termination due to death, disability or normal or early retirement, participants shall become 100% vested in the Company's discretionary matching and profit sharing contribution portion of their account. For all other participants, vesting in the Company discretionary contributions and profit sharing contributions portion of their account is based on years of service, as defined by the Plan. A participant is 100% vested after six years of credited service as follows:

Forfeited accounts

Forfeitures of non-vested contributions made by the Company may be used to satisfy administrative expenses of the Plan for the year in which the forfeitures occurred, or to reduce future Company contributions. For the years ended December 31, 2024 and 2023, there were no significant forfeitures used to pay administrative expenses of the Plan or to reduce Employer contributions. As of December 31, 2024 and 2023, the forfeitures balance was \$0 and \$472, respectively.

Notes receivable from participants

The Plan permits borrowing by a participant from their vested account balance up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum borrowing of \$1,000. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at Prime plus 2.0%. Principal and interest are paid ratably through payroll deductions. A participant may have only two loans from the Plan outstanding at any time. Principal and interest are paid ratably through payroll deductions. Notes outstanding in 2024 bear interest of 10.50%. The notes are secured by the participant's vested aggregate account balance.

Payment of benefits

On termination of service due to death, disability, retirement, or the attainment of age 59½, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance of \$1,000 or less will automatically receive a lump-sum distribution equal to the value of the vested portion of their account. Distributions are subject to the applicable provisions of the Plan agreement. The Plan also allows hardship withdrawals in specific cases, as defined in the Plan agreement.

2. Summary of significant accounting policies

Basis of presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Investment valuation and income recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s administrator determines the Plan valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Plan expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net appreciation in fair value of investments. Plan expenses paid out of the assets of the Plan for the years ended December 31, 2024 and 2023, were \$28,001 and \$24,867, respectively.

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. No events requiring recognition or disclosure in the financial statements were identified.

3. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* (“ASC 820”) are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net appreciation in fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

4. Information certified by the Plan’s trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Certain investment and notes receivable from participant’s information disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation/depreciation in the fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower and Reliance, the trustees.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Tax status

The Plan uses a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan, which received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, that the Plan and related trust, as then designed, is in accordance with applicable sections of the IRC. Although the Plan has been amended since the opinion letter date, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with parties-in-interest

During the years ended December 31, 2024 and 2023, Empower and Reliance, served as trustees of the Plan, as defined in the Plan documents, and therefore, any fees paid by the Plan to Empower or Reliance, qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Administrative expenses paid directly from Plan assets to the trustees amounted to \$28,001 and \$24,867 for the years ended December 31, 2024 and 2023, respectively. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in- interest transactions.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan administrator, through its investment advisor, monitors the Plan's investments and the risks associated therewith on a regular basis, which the Plan believes minimizes these risks.
