## INDEPENDENT AUDITORS' REPORT

To the Board of Directors of the  
403(b) Thrift Plan for  
United Way of Central Alabama, Inc.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the 403(b) Thrift Plan for United Way of Central Alabama, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Supplemental Schedule Required by ERISA**

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **1. DESCRIPTION OF PLAN**

The following description of the 403(b) Thrift Plan for United Way of Central Alabama, Inc. (the Plan) provides only general information. Participants should refer to the Plan Document(s) for a more complete description of the Plan's provisions.

### **General**

The Plan is a single employer defined contribution plan established by United Way of Central Alabama, Inc. (United Way or the Sponsor) under the provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Management and the Board of Directors of United Way oversee governance of the Plan, including the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to United Way's Board of Directors.

### **Eligibility and Participation**

The Plan is a single employer plan covering all employees of United Way of Central Alabama, Inc., except leased employees and certain other individuals as specified in the Plan Document. Part-time employees are eligible to participate in the Plan after completion of one year of service to the Company. Employees may make salary reduction contributions to the Plan immediately upon commencement of employment. Employer discretionary contributions are available for employees who are at least 21 years of age and have one year of service, as further defined by the Plan.

### **Plan Administration**

OneAmerica serves as Custodian and record keeper for the Plan. The Plan is administered by the Sponsor.

### **Contributions**

Each year, participants may contribute, on a tax-deferred basis, a portion of their compensation not to exceed the dollar limit set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

United Way has the right to determine the amount of any discretionary employer-based contributions annually that will be made for all eligible employees who have met the age and service requirements and are actively employed by United Way on the last day of the Plan year. Employer contributions may be net of any unvested forfeitures for separated employees. Employer contributions are allocated on a pro rata basis to those eligible employees based on annual compensation, as defined by the Plan.

## **1. DESCRIPTION OF PLAN – CONTINUED**

### **Participant Accounts**

Each participant's account is credited with the participant's eligible contributions and allocations of the United Way's discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in United Way's discretionary contribution portion of a participant's account is based on years of continuous service. These contributions vest at a rate of 20% per year, after the first year of service. A participant is 100% vested after five years of credited service.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,795 and \$1,592, respectively. In 2024, forfeitures in the amount of \$2,342 were used to reduce employer contributions to the Plan.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to various investment options offered by the Plan.

### **Benefit Payments**

Upon termination of service, the participant's vested account balance is either paid in a lump-sum amount equal to the value of the account or maintained by the Plan to provide benefits upon death or retirement. Upon retirement, the participant's vested account balance may be paid in a lump-sum equal to the value of the account or installments over a specific period with or without a death benefit to the participant's spouse or beneficiary. In the event of death before benefits start, the participant's vested account balance is paid to the participants spouse or beneficiary in a lump-sum amount equal to the value of the accounts or installments over a specific period. Participants may elect to make hardship withdrawals from the Plan due to certain immediate and heavy financial burdens, subject to conditions set forth in investment arrangements.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Investment in Fixed Option**

The Plan considers assets held in the fixed option, which consists of investments in the stable value account and the fixed account, to be fully benefit responsive investments valued at contract value. Amounts held in the fixed option can be withdrawn at any time without the sale of underlying securities. The fixed option earns interest, credited daily, at a rate that cannot go below the minimum guaranteed credited interest rate. The average interest rates being credited to assets in the fixed option for the years ended December 31, 2024 and 2023 was 2.70% and 2.95%, respectively.

At least ten days in advance of each calendar quarter, a guaranteed rate for that quarter will be established. All contributions or transfers which are allocated to the accounts during that quarter will earn interest at the guaranteed rate for that quarter until the second January 1 following the quarter in which that quarterly rate was established. Withdrawals or transfers from the accounts are on a first-in/first-out basis.

Amounts allocated to the fixed option, and credited interest, are not reduced by expenses and are guaranteed by the financial institution holding the accounts.

The financial institution reserves the right to limit or disallow allocations of new contributions or transfers to the accounts after providing a notice of 30 days.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by United Way and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

Management has evaluated subsequent events and their potential effects on these financial statements through August 27, 2025, which is the date these financial statements were available to be issued.

**3. INFORMATION CERTIFIED BY CUSTODIAN**

All investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by OneAmerica, the Custodian of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the Custodian that such information is complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**4. FAIR VALUE MEASUREMENTS – CONTINUED**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Accounts:*

Valued based on each account's daily net asset value (NAV), which is considered by Plan management to be the best approximation of fair value. The accounts are not exchange traded. Data for NAV's is distributed to plan administrators by OneAmerica and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of the individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments or redemption restrictions from participants in the Plan who invest in these accounts.

**5. PARTY-IN-INTEREST TRANSACTIONS**

The fixed option investments are managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the Custodian of \$1,350 during the Plan year ended December 31, 2024, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan, in whole or in part, at any time by an amendment to the Plan in accordance with Section 12.1 of the Plan and subject to the provisions of ERISA. Thereafter, no participant affected by such termination shall accrue additional benefits and, upon such termination or partial termination of the Plan, the rights of all participants to benefits accrued to the date of such termination, to the extent then funded, are nonforfeitable.

**7. TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The Plan administrator believes the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan continues to qualify under Section 403(b) as a tax-exempt plan as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has filed Form 5500, which is the annual return for employee benefit plans, for all years through December 31, 2023.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
