## Notes to the Financial Statements

December 31, 2024 and 2023

### (1) Description of plan

The following description of the Hillcrest Healthcare Communities 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Hillcrest Healthcare Communities, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees (the "participants"). The entry date is the employee's hire date for elective deferrals and for matching contributions the entry date is the first day of the month following the date the employee attains age eighteen and completes one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which may be after-tax Roth deferrals or pre-tax deferrals deductible by the participants for federal income tax purposes, up to the maximum percentage and amounts allowed by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their account into various investment options offered by the Plan which may be changed on a daily basis.

Effective April 1, 2023, the Plan was amended to include an auto-enrollment provision whereby all employees who have not made an election to contribute to the Plan after six months of employment are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect a different deferral percentage. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment until changed by the participant.

The Plan Sponsor may elect to make a discretionary matching contribution to the Plan. For years ended 2024 and 2023, the Plan Sponsor matched 100% of the first 4% contributed by eligible participants and 50% of the next 2% contributed by eligible participants of their basic annual compensation as defined in the Plan. In order for a participant to receive matching contributions he or she must be age eighteen or older and have worked at least 1,000 hours during the Plan year and be employed on the last day of the Plan year unless the participant terminates employment prior to the last day of the year on account of or following death, disability or attainment of normal retirement age. The Plan Sponsor does not match bonus compensation. The Plan Sponsor may also elect to make an additional discretionary profit sharing contribution. No such discretionary profit sharing contribution was made in 2024 or 2023.

(c) Participant accounts

Each participant's account is credited with the participant's and Plan Sponsor's contributions as determined above. Each participant's account is credited or charged with investment earnings (losses) of the investment options selected by the participants, and an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's discretionary and matching contributions is based on years of continuous service. A participant is 100% vested after three years of credited service according to the following schedule:

3 or more	100%

Participants may also become 100% vested upon reaching normal retirement age of 65, death or disability.

(e) Notes receivable from participants

The Plan does not permit participants to borrow from their accounts.

(f) Payment of benefits

Upon termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump-sum payment or installments over a specified period equal to the vested interest in his or her account. For termination of service due to other reasons, a participant will be entitled to receive the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures are used to pay plan expenses and then to reduce the Plan Sponsor's contributions to the Plan. Forfeited nonvested accounts totaled \$8,427 and \$6,379 as of December 31, 2024 and 2023, respectively. No forfeitures were used to pay plan expenses or reduce Plan Sponsor contributions in 2024. Forfeitures of \$46 were used to reduce Plan Sponsor contributions in 2023.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan document. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Custodian fees associated with administering the Plan and processing distributions are paid from the assets of the Plan and are charged to the applicable participants' accounts and are included in administrative expenses. Fees incurred and paid by the Plan for investment management services are included in net appreciation in fair value of investments.

(j) Plan changes

The Plan was amended to include bonus compensation as an eligible source for elective deferrals, effective January 1, 2023.

(k) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments reported and disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate. The certification was provided by Nationwide Trust Company FSB ("Nationwide") for the period from January 1, 2023 through April 14, 2023, and by Voya Retirement Insurance and Annuity Company ("Voya") for the period from April 15, 2023 through December 31, 2024 and as of December 31, 2023 and 2024.

### (4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2024 and 2023.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Money market fund*: Valued at the closing price reported on the market on which the individual securities are traded.
- (ii) *Mutual funds*: Valued at the net asset value of shares held by the Plan at year end in an active market.
- (iii) *Insurance contract*: Valued at fair value which approximates contract value based on the amount the Plan Sponsor would receive if they terminated the contract at the reporting date, which is book value less an early withdrawal charge, discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. See Note (10).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Excess contributions payable

At December 31, 2024 and 2023, payables of \$18,531 and \$3,192, respectively, were recorded for amounts refundable by the Plan to participants for contributions made as required by nondiscrimination testing.

(6) Income tax status

The Plan Sponsor adopted a 403(b) volume submitter plan, which received a favorable opinion letter from the IRS on March 31, 2017, which stated that the 403(b) volume submitter plan is designed in accordance with the applicable requirements of the IRC. The Plan itself has not yet received a determination letter from the IRS stating that the Plan is qualified under Section 403(b) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

Certain plan investments are shares of a money market fund and an insurance contract managed by Voya, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to service providers which also qualify as party-in-interest transactions.

(9) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(10) Insurance contract

The Plan provides a group annuity insurance contract with Voya as an investment option. Voya maintains these unallocated funds in its general account which supports insurance and annuity obligations of the insurance company. The contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses of Voya. The contract is included in the financial statements at fair value which approximates contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses of Voya.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but was not allowed to be less than 1.00% through December 31, 2024. Such interest rates are reviewed on a monthly basis for resetting.

Transfers and partial withdrawals from the annuity contract are generally limited to 20% of a participant's balance per year. Full withdrawals from the annuity contract may occur in the case of death, retirement, separation from service, hardship and small account balances. Full withdrawals for other reasons are limited and generally must be made in five-installment payments over five years.

(11) Subsequent event

Effective January 1, 2025, the Plan was amended to add an automatic escalation provision. Participants' who have previously been automatically enrolled as described in Note(1)(b) will have their contribution percentage automatically increased by 1% per year up to a maximum of 6% of compensation unless otherwise elected by the participant.
