Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Central Service Corporation Employee Group Benefit Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, the statements of plan's benefit obligations as of December 31, 2024 and 2023 and the related statement of changes in plan's benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Central Service Corporation Employee Group Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan provides health and other benefits to eligible employees (including employee elected eligible dependents) of Stride Bank, National Association (the Bank, or Stride Bank) and Central Service Corporation (the Company). All employees who generally work 30 hours or more per week are eligible for coverage. Coverage for Executive and Officers begins on the date of hire and for all other eligible employees, the first day of the month following 30 days of employment.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is intended to comply with all applicable laws, including the Internal Revenue Code of 1986, as amended, and the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits: The Plan provides health benefits (medical, dental, vision, and pharmaceutical), life insurance, short-term and long-term disability insurance, and accidental death and dismemberment benefits. Certain health care coverages under this Plan may be subject to coverage continuation rights under the Consolidated Omnibus Budget Reconciliation Act (COBRA) or similar state or federal law.

Insured Benefits: The Plan's vision, life insurance, short-term and long-term disability, and accidental death and dismemberment benefits are fully insured through annual contracts with insurance providers. These are experience-rated contracts subject to experience-rating adjustments. Experience ratings are determined by the insurance company in the following year and may result in a premium surplus or deficit. The Plan's dental benefits fell into this group for 2023, then was switched over to a self-insured structure for 2024. This is described in more detail under Self-Insured Benefits.

Self-Insured Benefits: Medical and pharmaceutical benefits are self-insured by the Company. These benefits are provided through an administrative agreement between the Company and Blue Cross and Blue Shield of Oklahoma (BCBS), a division of Health Care Service Corporation, a Mutual Legal Reserve Company, an Independent Licensee of the Blue Cross and Blue Shield Association (BCBS Claims Administrator). Under this agreement, the BCBS Claims Administrator provides benefits and performs other services on behalf of the Company in accordance with the terms of the Plan. The BCBS Claims Administrator provides administrative claims payment services only and does not assume any financial risk or obligation with respect to claims. Ultimate responsibility for payments to providers and participants is retained by the Plan. Coverage for the medical and pharmaceutical benefits is provided to participants through a BCBS Preferred Provider Organization (PPO) network under either a BCBS high deductible health plan (HDHP), or a BCBS traditional plan. A health savings account (HSA) is available to participants who enroll in the HDHP option and a general purpose/dependent care flexible spending account (FSA) to those who select the traditional plan. The Plan has no obligations related to the HSA accounts and they are considered to be owned by the participating employees, therefore associated activity has been excluded from the Plan's financial statements.

An administrative agreement between the Company and The Zero Card, Inc. offers participants a transparent network for certain medical, and diagnostic services and procedures with no deductible or co-pays. Under this agreement, The Zero Card provides claims administration, eligibility verification, and other services. The Zero Card does not assume any financial risk or obligation with respect to claims, and ultimate responsibility for payments to service providers is retained by the Plan.

Beginning January 1, 2024, the Company switched dental benefit plans from a fully insured plan to being self-insured by the Company. The benefits are provided through an administrative services agreement between the Company and Delta Dental Plan of Oklahoma (DDPOK), an Oklahoma nonprofit dental service corporation. Under this agreement, the DDPOK Claims Administrator provides benefits and performs other services on behalf of the Company in accordance with the terms of the dental Plan of Benefits and does not assume any financial risk or obligation with respect to claims. Ultimate responsibility for payments to providers and participants is retained by the Plan. Coverage for the dental benefits is provided to participants through both Delta Dental Participating Dentists and Nonparticipating Dentists. Allowable charges for covered services may be less and costs may be higher for participants electing services out of network.

Stop Loss Coverage: The Company has entered into a stop-loss insurance arrangement with BCBS. The arrangement provides for the self-insured BCBS benefits under the Plan to be self-insured up to \$110,000 in claims at the individual participant level. Claims exceeding \$120,000 at the individual participant level and \$4,033,201 at the aggregate are insured with BCBS. Stop loss recoveries of \$167,413 for the year ended December 31, 2024 were recorded as a reduction of benefits paid in the accompanying statement of changes in net assets available for benefits.

Contributions and Funding: In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums as determined by the Company for their respective benefit elections. Participants pay the full cost of vision, voluntary life, and voluntary accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life, basic accidental death and dismemberment, short-term disability, and long-term disability insurance. The Company shares in the cost of the insured dental benefit and the self-insured medical and pharmaceutical benefits. The funding determination for the self-insured benefits may reduce the Company's funding commitment for claims incurred and approved for payment during the year by the amount of accumulated net assets in excess of benefit obligations, if any, held by the Plan. Any deficiency of net assets over benefit obligations will be funded by the Company on a pay-as-you-go basis.

Plan Termination: Although it has not expressed any intent to do so, the Plan's Board of Trustees, as sponsor, has the right under the Plan agreement to modify the benefits provided to active participants. The Plan may be terminated subject to the provisions set forth in ERISA. In the event of Plan termination, any surplus assets of the Plan remaining after all Plan liabilities have been paid will revert to the Company to the extent permitted by applicable law.

Administrative Expenses: Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Other Plan Benefits: Plan obligations for health and pharmaceutical claims incurred but not reported are estimated based upon historical claims experience and actual claims reported subsequent to the plan year end. Additional payables are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

NOTE 3 - UNAUDITED INFORMATION – CERTIFIED INVESTMENTS

Substantially all information pertaining to the Plan's investments included in the financial statements, including the associated investment income, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Stride Bank, the trustee of the Plan. This information has not been audited by independent accountants.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Observable inputs such as quoted prices in active markets.

Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.

Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Funds: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 2 inputs). At December 31, 2024, the Plan's investment in money market funds consisted of \$800,000 in Northern Institutional, U.S. Government Select Portfolio Money Market Fund, and \$500,259 in a money market deposit account held at Stride Bank. The Plan's investment in the Northern Institutional fund is not FDIC insured. Funds held in Stride Bank's money market deposit account occasionally exceed the federally insured balances.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Company. The Plan paid administrative expenses for the year ended December 31, 2024, were \$300,871. Stride Bank is a wholly owned subsidiary of Central Service Corporation. Stride Bank's trust department manages the fund's investments and is trustee of the Plan. The portion of Plan investments held at Stride Bank is considered a party-in-interest investment.

NOTE 6 - TAX STATUS

The trust established under the Plan to hold the Plan's assets obtained its latest determination letter on July 17, 1992, in which the Internal Revenue Service stated that the trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE 6 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
