Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Columbia Insurance Group's Employee Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

General

The following description of Columbia Insurance Group's Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Columbia Insurance Group (Company) for the benefit of its employees who have at least 30 days of service and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company are the trustees of the Plan.

Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company currently contributes 3% of the participant's eligible salary and matches 100% of the participant's contributions up to 5% of the participant's eligible salary. Contributions are subject to certain limitations. Plan entry dates are on or after the first day of the month the participant meets the eligibility requirements.

Each year, the Company may make discretionary profit sharing contributions at the option of the Retirement Plan Committee, subject to certain IRS limitations. The Company did not make additional profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his/her contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account. All expenses of maintaining the Plan are paid by the Company, with the exception of loan processing fees and withdrawal fees, which are paid by the Plan participants.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's contributions on their behalf plus earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have two outstanding loans at a time. Loan transactions are treated as a transfer from (to) the investment fund to (from) the Participant Loans Fund. Loan terms generally range from 1-5 years. If the loan is for the purchase of a principal residence, the loan may be extended to 10 years. The loans are secured by the balance in the participant's account. Interest rates are determined by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, vested account balances of less than \$5,000 are distributed from the Plan in a single sum. Upon termination of service due to retirement or death, a vested participant (or spouse) may choose from a variety of distribution options, including a single sum payment, a multitude of monthly annuity options, or installment payments made on an annual, semi-annual, quarterly, or monthly basis.

Forfeited Accounts

Participants are fully vested upon entrance to the Plan; therefore, no portion of account balances may be forfeited upon exit from the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Pooled separate accounts (PSAs) are valued at net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in collective investment trusts (CITs) is valued at the NAV of shares held by the Plan at year end based on share value using the audited financial statements of the collective trust at year end.

The fair value of the guaranteed interest accounts (which are not considered to be benefit-responsive) is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Revisions

Certain immaterial revisions have been made to the 2023 financial statements. These revisions did not have a significant impact on the financial statement line items impacted.

- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract with Insurance Company

The Plan enters into two-year and five-year investment contracts annually through Principal Life Insurance Company's Guaranteed Interest Accounts under which the Plan deposits funds based on participant direction. Principal maintains the Plan's deposits in funds to which it adds interest ranging from 0.59% to 4.80% per year for year ended December 31, 2024 (0.38% to 4.80% per year for year ended December 31, 2023), depending on the respective contract. Interest rates are guaranteed for the two-year insurance contract which has matured as of December 31, 2024. Interest rates are guaranteed for each contract with annual contract maturity dates through December 31, 2027 for the five-year insurance contracts, but are subject to change for each succeeding contract period. When changed, the new rate applies only to funds deposited from the date of change. As directed by participants, funds can also be used to purchase units in Principal's Pooled Separate Accounts. Principal does not guarantee the monies invested in the Pooled Separate Accounts as to principal or income. Benefit payments to participants or their beneficiaries are made directly from the Pooled Separate Accounts.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The average yields for the Guaranteed Interest Account were 4.69% and 4.96% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with Principal computed using rates applicable at the benefit payment date.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invests in certain pooled separate, collective investment trust and guaranteed interest accounts of the plan trustee. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$57,391 and \$73,165 of recordkeeping fees to Principal Life Insurance Company during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Principal Life Insurance Company. The prototype plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. As such, the Retirement Plan Committee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
