## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees  
Twin Cities Co-op Partners 401(K) Plan and Trust  
Minneapolis, Minnesota

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Twin Cities Co-op Partners 401(K) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and June 30, 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and for the period from July 1, 2023 to December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Twin Cities Co-op Partners 401(K) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and June 30, 2023, and for the year ended December 31, 2024, and for the period from July 1, 2023 to December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. DESCRIPTION OF THE PLAN

The following description of Twin Cities Co-op Partners 401(K) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. These financial statements present the Plan activity as of and for the year ended December 31, 2024, and as of December 31, 2023, and for the period from July 1, 2023 to December 31, 2023.

**General** - The Plan is a single-employer defined contribution 401(k) profit-sharing plan covering substantially all employees of Twin Cities Co-op Partners, Inc. (the Company) who have three months of service. The Company is the Plan Sponsor and Plan Administrator. John Hancock Trust Company LLC is the trustee and John Hancock Retirement Plan Services LLC provides recordkeeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments are held in mutual funds and a common collective trust. In 2023, the Plan was amended to change its year end to December 31.

**Contributions** - Participants are allowed to make an elective pretax (traditional 401(k)) or after-tax (Roth 401(k)) deferral contributions up to Internal Revenue Code limits and not to exceed 90% of annual compensation, as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, unless elected otherwise. The deferral rate increases by 1% each year until a rate of 6% is achieved. Employees can opt out at any time. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan allows for the Company to make discretionary matching contributions to all participants who make salary deferral contributions. For the Plan year ended December 31, 2024, and the period ended December 31, 2023, the Company made matching contributions of 50% of the first 8% of eligible compensation participants contributed to the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Company's discretionary matching contributions, and (b) Plan earnings and increases (decreases) in the value of investments, net of administrative expenses. Allocations are based on account balances or participant earnings and contributions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - The participant's elective deferral contributions and earnings thereon are always 100% vested. Company discretionary matching contributions and earnings thereon vest based on years of credited service. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant's account will be fully vested upon death, disability, or retirement.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms generally range from 1 to 5 years. The notes are secured by the balance in the participant's account and bear interest at fixed rates determined at note inception using the prime rate plus 1%. The interest rates on notes outstanding at December 31, 2024 and 2023 were 4.25% to 9.5% and 4.25% to 9.25%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - Upon termination of service due to death, disability, retirement, or other reasons, a participant with a non-forfeitable accrued benefit exceeding \$5,000 may elect to receive either a lump sum amount equal to the participant's vested account balance or installments over a period of time not to exceed the participant's assumed life expectancy (or the participant's and their beneficiary's assumed life expectancies). Prior to separation from service, a participant reaching age 59-1/2 may elect to receive all or a portion of their vested account balance or defer payment until retirement.

Upon termination of service, a participant with a with non-forfeitable accrued benefit below \$5,000, must receive a lump-sum distribution.

**Forfeitures** - Forfeited nonvested accounts are used to reduce future Company discretionary matching contributions to the Plan. In 2024 and for the period ended December 31, 2023, \$26,641 and \$11,144 of forfeitures were used to reduce future Company discretionary matching contributions. At December 31, 2024, and 2023, and June 30, 2023, forfeitures available to reduce future Company discretionary matching contributions were \$1,209, \$ -, and \$1,003.

**Investment Options** - Participants are able to direct the investment of their contributions among the various investment options offered by the Plan. Company contributions are allocated on the same basis as participant contributions.

### 1. **DESCRIPTION OF THE PLAN (Continued)**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The accompanying financial statements for the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

**Valuation of Investments and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, and June 30, 2023. Interest income from participant loans is recorded when earned. Delinquent participant loans are reclassified as loans in default and are recorded as deemed distributions at the time they are deemed uncollectible.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation and depreciation in fair value of investments.

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023, and June 30, 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust fund:** The fair value per unit of investments in the common collective trust fund is determined by the fund's trustee based on the fair value of the underlying securities within that fund divided by the number of units trading. Plan management believes using net asset value as a practical expedient to estimate fair value is appropriate for investments in the common/collective trust. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan's investment in the common collective trust fund is not subject to any withdrawal or redemption restrictions. The Plan has no unfunded commitments relating to the common collective trust fund at December 31, 2024 and 2023, and June 30, 2023.

#### 5. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 6. **INCOME TAX STATUS**

The prototype plan document adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

#### 7. **RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from participants qualify as party-in-interest transactions.

The Plan's sponsor pays certain administrative expenses of the Plan.

An affiliate of the trustee manages a Plan investment.

#### 8. **SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
