## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the  
403(b) Thrift Plan for Employees of Methodist Home for Children

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Methodist Home for Children (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters - Supplemental Schedule Required by ERISA**

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN:

The following description of the 403(b) Thrift Plan for Employees of Methodist Home for Children (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan, established on June 1, 1999, is a defined contribution 403(b) plan covering substantially all employees of Methodist Home for Children (the "Plan Sponsor"). The Plan's Custodian is Mutual of America (the "Custodian"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Eligibility.** There are no minimum age or service requirements to be eligible to participate in the Plan. Participants become eligible to receive the employer matching contribution when they have attained the age of twenty-one and completed two years of service. Participants are credited with a year of service beginning on the anniversary date of hire in which they work at least 1,000 hours.

**Contributions.** Each year, participants may contribute up to 100% of pretax annual compensation to the maximum contribution allowed by the Internal Revenue Service ("IRS") regulations, as defined in the Plan. The Plan permits participants over the age of 50 to make additional contributions, known as catch-up contributions, up to the maximum amount allowed by IRS regulations, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor contributes 50% of the participant contributions up to a maximum of 3% of eligible gross compensation.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are fully and immediately vested in their deferrals and the Plan Sponsor's matching contributions plus actual earnings thereon.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. The repayment period for loans will not be longer than five years unless the loan was used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum distribution amount equal to the value of the participant's vested interest in his or her account, regular monthly payments of \$100 or more, or as income under an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may make withdrawals from their accounts in the event of financial hardship not to exceed the amount of the immediate need. After taking a hardship withdrawal, a participant is not permitted to make contributions for a period of six months.

**Investment Options.** Upon enrollment in the Plan, a participant directs the investment of his or her contributions and Plan Sponsor contributions into pooled separate accounts or cash and cash equivalents.

**Forfeited Accounts.** Benefit payments to terminated employees partially vested in the Plan include their vested portion of employer contributions. The nonvested portion of terminated participants' account balances is used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, amounts of \$584 and \$1,180, respectively, were used to offset employer contributions.

**Administrative Expenses.** Administrative expenses of the Plan are paid by the Plan or Plan Sponsor as provided in the Plan document. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

**Basis of Accounting.** The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Cash and Cash Equivalents.** Mutual of America, the Custodian, has determined that some of the Plan's assets are cash and cash equivalents. This is based on certain considerations including liquidity and redeemable value of the underlying investment.

**Investment Valuation and Income Recognition.** The Plan's investments in pooled separate accounts consist of various mutual funds. These investments are carried by the Plan at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. See Note 5 for discussion of fair value measurements.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits.** Benefit payments to participants are recorded when paid.

**Income Taxes.** The Plan Sponsor and the third party administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 403(b) of the Internal Revenue Code and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's mission would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized during the years ended December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to informational return examinations for years prior to 2021.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN:

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Custodian:

4. CONCENTRATIONS OF CREDIT RISK:

The Plan maintains an uninsured cash balance in an interest accumulated fund with Mutual of America. At December 31, 2024 and 2023, the uninsured balance in this account was \$1,475,983 and \$1,209,863, respectively.

5. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Fair Value Measurements:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements:

Fair values are based on inputs other than quoted prices included within Level 1 that are unobservable and significant to the fair value measurements.

The financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled separate accounts:* Units held in the pooled separate accounts are valued at the net asset value ("NAV") based on the fair market value of the underlying investments of the account less its liabilities. The NAV is used as a practical expedient to estimate fair value.

The investment objectives for the pooled separate accounts measured using the net asset or unit value are as follows:

*Asset allocation:* The fund seeks current income and, to a lesser extent, capital appreciation.

*Balanced fund:* The fund seeks capital appreciation and current income by investing in a diversified portfolio of common stocks, debt securities, and money market instruments.

*Equity fund:* The fund seeks investment results that correspond to the investment performance of the S&P 500® Index.

*Fixed income:* The fund seeks current income to the extent consistent with the maintenance of liquidity, investment quality and stability of capital.

*Retirement fund:* The fund seeks to achieve current income consistent with the preservation of capital and, to a lesser extent, capital appreciation.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are pooled separate accounts managed by Mutual of America, the Custodian, as defined by the Plan. Therefore, Mutual of America is considered a party-in-interest.

Fees were paid during the year for administrative record keeping and other professional services to parties-in-interest, and were based on customary and reasonable rates for such services. Fees paid using plan assets for the years ended December 31, 2024 and 2023 related to administrative record keeping and other professional services amounted to \$4,007 and \$3,560, respectively. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan Sponsor directly pays any other fees related to the Plan's operations.

Certain participants of the Plan have outstanding loans (notes receivable from participants) totaling \$177,845 and \$109,941 as of December 31, 2024 and 2023, respectively. These loans are considered party-in-interest transactions.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued. No significant subsequent events have been identified by management.
