## 1. Description of Plan

The following description of the TruVista 401(k) Retirement Plan (the “Plan”) provides only general information. Participants may refer to the Plan document for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan sponsored by TruVista Communications, Inc. (the “Company”) which covers employees of the Company who have attained age eighteen. Part-time employees are eligible once they have worked 1,000 hours in a twelve-month period. Leased employees and independent contractors are excluded from participation in the Plan.

The Plan uses Principal Trust Company as its custodian and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On July 6, 2022, the Company acquired Plant Telephone Company and Plant Telecommunications Sales & Services, Inc. (collectively, “PlantTel”). During 2023, PlantTel’s portion of the National Telephone Cooperative Associations Retirement Savings Plan was merged into the Plan. Assets transferred to the Plan as a result of this transaction were approximately \$3,065,000.

### Contributions

The Plan allows contributions of any portion of a participant’s pre-tax annual compensation, as defined in the Plan and subject to contribution limitations specified by law. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

The Company must make up to 6% matching contributions under the Plan’s safe harbor provisions. Safe harbor employer matching contributions of approximately \$841,000 and \$687,000 were made for the years ended December 31, 2024 and 2023, respectively.

Discretionary matching and/or profit sharing contributions may be made by the Company. No such discretionary matching and/or profit sharing contributions were made for the years ended December 31, 2024 and 2023. Discretionary profit sharing contributions, if any, are allocated among active participants in the same ratio that each active participant’s compensation for the plan year bears to the total compensation of all active participants for the plan year.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions (if any), Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their salary deferrals and employer safe harbor matching contributions, and actual earnings or losses thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based on years of continuous service. Participants are 20% vested in the Company's discretionary matching and profit sharing contributions after two years of service with additional vesting of 20% for each of the next four years, resulting in 100% vesting after the sixth year.

**Participant Notes Receivable**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are collateralized by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024. Loan terms range from one to five years, except for loans made for the purchase of a primary residence. A participant may have no more than one note due to the Plan at any time. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of service a participant may, subject to certain conditions, elect to receive their vested portion of Plan assets under several payout options specified in the Plan's documents. Subject to certain conditions, a participant may receive hardship withdrawals from his or her balance in the Plan while employed. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions. If the plan administrator does not offer an election to defer distributions, a participant who reaches 73 years of age will automatically begin receiving distributions by April 1<sup>st</sup> of the following calendar year.

**Forfeitures**

Participants withdrawing from the Plan with non-vested employer contributions in their accounts forfeit their share of non-vested contributions and earnings thereon. The Plan's provisions allow these amounts to be used for administrative expenses of the Plan or to reduce any employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,400 and approximately \$1,500, respectively. No forfeited non-vested accounts were used to reduce employer contributions during the years ended December 31, 2024 and 2023.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in discretionary employer matching and profit sharing contributions.

**Plan Amendments**

Effective November 28, 2023, the Plan was amended to allow eligible participants to make Roth contributions.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The Plan's policy is to prepare its financial statements using the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under the Plan's accounting policy, contributions and investment income are recorded as received and expenses are recorded when paid.

**Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Participant Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Delinquent participant loans are classified as distributions.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits – modified cash basis.

**3. Custodian Certifications**

Amounts recorded in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 related to investments, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, and other income were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company.

#### **4. Fair Value Measurements**

Financial assets and liabilities carried at fair value are classified and disclosed within a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. All of the Plan's mutual fund investments were valued using Level 1 inputs, based on quoted net asset values of the shares held by the Plan. The Plan's investments also includes the Putnam Stable Value Fund, a common/collective trust that invests in a variety of fully benefit-responsive investment contracts. The Putnam Stable Value Fund totaled approximately \$2,698,000 and \$2,575,000 at December 31, 2024 and 2023, respectively, and is valued using Level 2 inputs.

The Plan also invests in the Principal/T.Rowe Institutional Large Cap Growth Collective Investment Trust Class N, a common/collective trust which does not invest in any fully benefit-responsive investment contracts. This common/collective trust totaled approximately \$9,999,000 and \$7,639,000 at December 31, 2024 and 2023, respectively, and is valued at the net asset value ("NAV") of units of the account. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of each account is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the account provider reserves the right to temporarily delay withdrawal from the accounts in order to ensure that security liquidations will be carried out in an orderly business manner.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although plan management believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Tax Status**

The Plan is a non-standardized profit sharing plan designed to be in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service (the "IRS") determined that the pre-approved plan document and related trust are designed in accordance with applicable sections of the IRC.

**5. Tax Status (continued)**

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

For the year ended December 31, 2024, an operational error was discovered relating to an employee's contributions which resulted in an overpayment of employee contributions to the Plan. As of the date the financial statements were available to be issued, management's calculation of the impact of the error to the Plan's 2024 financial statements is not significant. Management expects to make the corrections during 2025.

The Plan's administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any open tax period in progress.

**6. Party-in-Interest Transactions**

At December 31, 2024, the Plan held investments sponsored by Principal Trust Company. Fees paid by the Plan to Principal Trust Company for custodial, recordkeeping, and investment advisory services amounted to approximately \$100,000 and \$79,000 for the years ended December 31, 2024 and 2023, respectively. The Company also has participant notes receivable. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.
