## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Central Moloney, Inc. Hourly Employees 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was established September 3, 2019, is a defined contribution plan for the benefit of employees of Central Moloney, Inc. (the Employer, Plan Sponsor and Plan Administrator) who are in the Quality Control group or are covered by the collective bargaining agreements with Local Union 1658 IBEW AFL-CIO-CFC (the collective bargaining agreements) only. Generally, employees are eligible to participate in the Plan on the first day of each Plan quarter after completion of two months of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Employer utilizes the services of Empower Retirement (Empower), a third party administrator, to process participant transactions and maintain participant account balances. Empower Trust Company, LLC is the Plan's asset custodian.

The Board of Trustees for the Plan is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$20,300 for the year ended December 31, 2024.

### **Contributions**

Participants may contribute a percentage of annual compensation, as defined in the Plan, not to exceed limitations imposed by the Internal Revenue Service (IRS). The participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan Sponsor will make an annual profit sharing contribution for each employee covered by the collective bargaining agreements in the amount of \$1,250 and each Quality Control employee in the amount of \$1,300, provided that the employees are participants of the Plan and are actively employed by the Plan Sponsor on the date that the annual contributions are determined. Participants will share in the profit sharing contribution regardless of the amount of service completed during the Plan year. The Employer will also make a matching contribution to eligible employees equal to 100% of the participant's elective deferrals up to \$250 per year, as determined at Plan year end.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's profit sharing contribution, the Employer's matching contribution and allocations of Plan earnings, net of certain administrative expenses. Allocations are generally based on participant account balances, as specified in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested at all times in their own contributions plus actual earnings thereon. Vesting in the Employer's contributions, plus actual earnings thereon, occurs according to the following schedule.

### **Investment Options**

Participants may direct the investment of their contributions in one or more mutual funds or a fixed annuity offered under the Plan. Participants may change their investment options at any time.

### **Forfeitures**

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. Under the terms of the Plan agreement, forfeitures are used to reduce Plan expenses or reduce the Employer's contribution. At December 31, 2024 and 2023, the balance of forfeited accounts totaled approximately \$145,000 and \$110,000, respectively. During the year ended December 31, 2024, forfeitures totaling \$15,000 were used to reduce plan expenses and the Employer's contribution.

### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value accumulated in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value accumulated in his or her account as a lump-sum distribution or, if the account balance exceeds \$5,000 on the date of termination, may leave the account under the Plan until the participant reaches normal retirement age or dies.

### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Empower. See Note 4 for further discussion on the determination of fair value amounts.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

### **Payments of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## **NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments and related investment activity reflected in the financial statements and supplemental schedule was certified by the Plan's custodian, Empower Trust Company, LLC as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

**NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2     Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

#### **Mutual Funds**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Fixed Annuity**

The fixed annuity fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**NOTE 5: CORRECTIVE DISTRIBUTIONS PAYABLE**

At December 31, 2023, the Plan had a liability of \$34,995 for amounts refundable for participants who were incorrectly included in the Plan.

**NOTE 6: TAX STATUS**

Effective September 3, 2019, the Plan executed an adoption agreement for the Osborn, Carreiro & Associates, Inc. Defined Contribution Prototype Plan and Trust (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

### ***NOTE 6: TAX STATUS (Continued)***

The Prototype obtained its latest opinion letter on June 30, 2020, in which the IRS informed Osborn, Carreiro & Associates, Inc., that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving that letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

### ***NOTE 7: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain investment options available to Plan participants may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

### ***NOTE 8: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued.
