**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We were engaged to perform audits of the financial statements of Center for Employment Opportunities Tax Sheltered Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Disclaimer of opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

**Basis for disclaimer of opinion**

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements may have been affected by these conditions.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits.

**Other matter - supplemental schedules required by ERISA**

The supplemental schedule of assets (held at the end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

#### NOTE A - PLAN DESCRIPTION

The following plan description of the Center for Employment Opportunities Tax Sheltered Annuity Plan (the "Plan") (a 403(b) plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including definitions of key terms.

##### **General**

The Plan is a defined-contribution plan covering all employees of the Center for Employment Opportunities (the "Organization" or "Plan Sponsor"). For purposes of elective deferral contributions, employees are eligible to participate in the Plan on the day they become employed by the Organization. Employees must complete one year of eligible service and contribute to the Plan to receive matching employer contributions. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974, as amended ("ERISA"). The Board of Directors is responsible for the oversight of the Plan. Management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors. Principal Trust Company ("Principal"), the recordkeeper, trustee and custodian of the investments, holds the Plan's investment assets and executes investment transactions.

##### **Contributions**

Each year, participants may make pre-tax contributions up to the greater of the amount allowed by the Internal Revenue Code ("IRC") or the participant's eligible compensation for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. For 2024, the IRC set contribution limits for participants at \$23,000, with a maximum catch-up for eligible participants of \$7,500.

For nonunion employees, the Organization makes contributions of up to 3% of eligible compensation, as defined in the Plan document, that a participant contributes to the Plan. Union employees are subject to a 5% employer contribution if the participant makes 3% elective deferrals during the Plan year. The matching Organization contribution is invested per the participant-directed allocation.

##### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and Plan Sponsor matching contributions (if eligible), as well as investment earnings. Participant accounts may also be charged with investment losses and an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting and Forfeitures**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of service. A participant is 100% vested after two years of credited service. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0, respectively. These accounts may first be used to pay administrative expenses. Remaining forfeitures may be used to reduce the Organization's match. During 2024, employer contributions were reduced by \$12,549 from forfeited non-vested accounts.

***Plan Loans***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or the greater of 50% of their vested account balance or \$10,000. The loans are secured by the balance in the participant's account. Participants may have only one outstanding loan at a time. The loan interest rate is determined by the Plan Administrator; however, it must be reasonable. In determining the interest rate, the Plan Administrator shall take into consideration fixed interest rates currently being charged by commercial lenders for loans of comparable risk on similar terms and for similar durations. Rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023, respectively. When repayment-through-payroll-deduction is available, principal and interest is paid in installments through this method. In cases where payroll deduction is unavailable, cash payments are to be made timely. Loan balances outstanding were \$431,330 and \$312,915, as of December 31, 2024 and 2023, respectively.

***Payment of Benefits***

A participant is eligible to receive a distribution on his/her vested account balance under any of the following circumstances: (a) retirement; (b) termination of employment; (c) death; (d) hardship; (e) disability; or (f) minimum required distribution upon reaching the age of 73. Lump-sum, annuity, or fixed period payouts are available on retirement or termination of service as permitted in the Plan document. Participants may withdraw amounts from their "rollover accounts" at any time, limited to two withdrawals per year.

***Administration Expenses***

The Organization has elected to pay all administrative expenses incurred by the Plan except for certain transaction fees such as loan and distribution requests, which are paid by the Plan and charged to the participants' accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Risks and Uncertainties***

The Plan provides for investments in various securities that, in general, are exposed to various risks such as interest rates, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

***Non-Interest Bearing Cash in Transit***

In January 2025, the Plan's recordkeeper, trustee and custodian was changed (see Note K). In anticipation of this conversion and to ready the funds for transfer, the Plan liquidated certain participants' accounts as of December 31, 2024. The accounts totaled \$8,569,421 and are reported as non-interest bearing cash in the accompanying statement of net assets available for benefits as of December 31, 2024.

**NOTE C - CERTIFIED INFORMATION**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, as recordkeeper, trustee and custodian of the Plan's investments, has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Investments, at fair value, fully benefit-responsive investment contracts, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs-to-valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date, and such differences could be material.

**NOTE E - PRINCIPAL FIXED-INCOME OPTION**

The Principal Fixed-Income Option is a fully benefit-responsive group annuity contract issued by Principal. This type of contract does not have specific underlying assets assigned; however, this contract is backed by Principal's general account. The contract is credited with earnings and charged for participant withdrawals and administrative expenses. As of December 31, 2024 and 2023, the Plan's investment in the group annuity contract totaled \$5,654,912 and \$4,826,633, respectively. The crediting interest rate was 2.75% for the first half and 2.95% for the second half of (2024) and 1.45% for the first half and 2.30% for the second half of (2023) for the Plan years ended December 31, 2024 and 2023, respectively.

The accompanying statements of net assets available for benefits include the fully benefit-responsive group annuity contract recognized at contract value. The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal, or transfer of all or a portion, of their investment at contract value. A plan-level surrender or transfer of the Plan's interest in the investment contract without 12 months advance notice will be subject to a 5% surrender charge. Under the terms of the contract, the composite crediting rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: amendments to the Plan documents, changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

**NOTE F - PLAN TERMINATION**

While it is expected that the Plan will continue indefinitely, the Plan Sponsor reserves the right to modify or discontinue the Plan at any time subject to the provision of ERISA. ERISA provides the manner in which the assets of a terminated plan are to be allocated.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and a group annuity contract managed by Principal, as custodian defined by the Plan. The Plan also permits receivables from participants. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**NOTE H - TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the IRC (the "Code"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan Administrator believes that the Plan is currently designed and operating, in all material respects, in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related accounts are tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no material uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - ACCOUNTING AND PAYROLL RECORDS**

In November 2007, the DOL issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part 1 of Subtitle B of Title I of the ERISA. Prior to the amended regulations, the Plan (established in 1996) was not viewed as a separate reporting entity. Historically, the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan Sponsor. Accordingly, various accounting and payroll records related to the Plan's 403(b) annuity contracts, and custodial accounts issued to current and former employees prior to January 1, 2009, were not sufficiently maintained by the Plan. Consequently, the financial statements have been prepared based on available

records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness and accuracy of the Plan's financial statements cannot be determined.

**NOTE J - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 13, 202X, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements, other than the following:

As of January 1, 2025, the Plan Sponsor has changed the recordkeeper, trustee and custodian of Plan information from Principal to Empower Trust Company, LLC ("Empower"). Certain participant accounts were liquidated in December 2024 in anticipation of the conversion (see Note B). The Plan's mutual fund investments and notes receivable from participants moved in-kind to Empower in January 2025. Participant account balances invested in the Principal Fixed-Income Option were transferred from Principal to Empower on May 15, 2025.
