#### Note 1. Plan Description

The following description of Stellar Industries, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan established for the benefit of employees of Stellar Industries, Inc. (the Company). Employees of the Company who have completed three months of service and are age 18 or older are eligible to participate in the Plan and are eligible to make salary deferral contributions to the Plan on the first day of the quarter after they become eligible to participate in the Plan. To be entitled to employer contributions, a participant must complete one year of service during the Plan year, defined by the Plan as 1,000 hours during the Plan year. The Board of Directors is responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions and investment options:** Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed a maximum allowed by federal regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, increasing annually up to a maximum of 10%. The Company may, at its sole discretion, make additional matching and/or profit sharing contributions to the Plan each year. No matching or profit sharing contributions were made during the year ended December 31, 2024. Participants direct the investment of their contributions and any employer contributions into various mutual funds and bank common collective trust funds currently offered by the Plan. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching contribution, (b) the Company's discretionary profit sharing contribution and (c) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions plus earnings thereon is based on years of continuous service. A participant vests 20% per year and is 100% vested after five years of credited service.

**Notes receivable from participants:** Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participants. Terms will vary depending on the type of loan with a maximum term allowed of 30 years. The notes receivable must be adequately secured and bear interest at a rate commensurate with prevailing rates. Notes receivable outstanding at both December 31, 2024 and 2023, bear interest at rates ranging from 4.25% to 9.50% and mature through March 2033.

**Payment of benefits:** On termination of service due to death, disability or retirement, or due to other reasons, participants with vested balances greater than \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments. Participants with a vested balance less than \$5,000 may roll over the amount into another qualified plan or receive a lump-sum distribution.

#### Note 1. Plan Description (Continued)

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$17,600 and \$2,200, respectively. During the year ended December 31, 2024, there were no allocations to participant accounts.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of benefits:** Benefits are recorded when paid.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Certain administrative functions of the Plan are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

#### Note 5. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.
- Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund, which represents the NAV of shares held by the Plan at year-end. The fair value of mutual funds is classified within Level 1 of the valuation hierarchy.

**Common collective trust funds:** Common collective trust funds are composed of investment contracts that are valued at the NAV of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trusts, no notice to the issuer is required.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their entire account balance.

#### Note 7. Tax Status

The Plan adopted a nonstandardized form of prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Service, dated March 31, 2014, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan follows the accounting guidance for uncertainty in income taxes and management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### Note 8. Related-Party and Party-In-Interest Transactions

The Plan holds investments with Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company. Principal Trust Company is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.
