Note 1 - Plan Description

The following description of Dykema Gossett PLLC Cash Balance Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined benefit plan covering all eligible employees of Dykema Gossett PLLC (the "Firm") who are considered percentage equity members of the Firm. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Firm is the plan sponsor of the Plan.

Eligibility and Vesting

Each person who is classified as a percentage equity member of the Firm as of the effective date of the Plan, January 1, 2007, became a participant on that date. Any other person shall become a participant on the January 1 that coincides with or following the date of his or her election to equity status.

A member who became a participant in the Plan on January 1, 2007 shall be fully vested as of that date. Any member who first becomes a participant on or after January 1, 2008 shall become 100 percent vested after the completion of three years of service. Effective January 1, 2012, the Plan was amended where all participants are immediately fully vested without regard to years of service.

Cash Balance Accounts

A notional account referred to as the cash balance account has been established and will be maintained for each participant. A participant's cash balance account shall be credited with cash balance credits and interest credits in accordance with the plan document.

A cash balance credit shall be credited to the cash balance account of each participant who has completed one year of benefit service for such plan year. The cash balance credit for a plan year shall be based on the participant's attained age as of the end of the plan year and the participant's highest ownership interest in the Firm during the plan year. This cash balance credit is subject to certain maximum credit amounts set forth in the plan document.

An interest credit shall also be credited to the cash balance account of each participant annually. For plan years beginning on January 1, 2011, the interest credit under the Plan is based upon the market rate actually experienced by the investment portfolio of the Plan's trust fund, not to exceed the cumulative maximum 7.5 percent compounded annually.

The cash balance account shall be equal to the sum of the cash balance credits and the interest credits.

Retirement Benefits

Eligible members with three or more years of service are entitled to retirement benefits beginning at the normal retirement age (62). Effective January 1, 2012, the Plan was amended to eliminate the years of service requirement to be entitled to retirement benefits. The payment of benefits may be delayed if the participant continues to serve as a member of the Firm.

Pension benefits may be payable in the following forms: a qualified joint and survivor annuity, a single life annuity, a qualified optional survivor annuity, or a lump sum. Members should refer to the plan document for a more complete description of these benefit options.

A participant who has attained normal retirement age may elect to receive his or her vested accrued benefit in a single lump-sum payment at any time following the date he or she attains normal retirement age or at any time during any later plan year, even though the participant has not had severance from employment. Effective January 1, 2020, participants may elect to receive a lump-sum payment at any time after attaining age 59½.

Note 1 - Plan Description (Continued)

Termination of Employment Benefits

A participant who terminates employment prior to his or her normal retirement age may elect to receive a distribution of his or her vested accrued benefit as of the first day of any month following such termination of employment. The participant will be entitled to receive a single lump sum or an annuity payment at this time.

Death Benefits

If a participant dies prior to commencement of benefits, a death benefit equal to the actuarial equivalent of the participant's cash balance account will be paid to the participant's surviving spouse in a single lump sum or an annuity, as elected by the spouse. If the beneficiary is not the participant's surviving spouse, a lump-sum payment will be made to the beneficiary on the first pension starting date following the participant's death.

Funding

Contributions are made by the Firm in actuarially determined amounts. The Firm's policy is to make contributions necessary to satisfy ERISA funding standards. Annual contributions meet the minimum funding requirements of ERISA. All contributions to the Plan are made by the Firm. No voluntary employee contributions are allowed.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by SEI Private Trust Company or its affiliates. SEI Private Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines, but are not prohibited transactions under ERISA.

In addition, various administrative costs are paid by the Firm that also qualify as party-in-interest transactions.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Firm.

The Firm paid administrative costs of \$9,954 and \$2,923 on behalf of the Plan for the years ended December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies (Continued)

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments that are attributable, under the Plan's provisions, to the service employees have rendered. These include benefits expected to be paid to:

- (a) Retired or terminated employees or their beneficiaries
- (b) Beneficiaries of employees who have died
- (c) Present employees or their beneficiaries

Benefits are based on the lump-sum amount equal to the participant's cash balance account.

Actuarial Assumptions

The actuarial present value of accumulated plan benefits is determined by an actuary from October Three LLC and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money and probability of payment between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation of the Plan at January 1, 2024 are summarized as follows:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

Contributions to the Plan and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

SEI Private Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements, supplemental schedule of assets held at end of year, and supplemental schedule of reportable transactions are based solely on information certified by the Trustee.

Note 4 - Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits is determined by consulting actuaries from October Three LLC. The calculation of the actuarial present value of accumulated plan benefits attributable to vested participants in the Plan, which was made as of January 1, 2024, the most recent actuarial valuation, is as follows:

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at the outstanding balance, which is the best estimate of fair value.

U.S. Government Securities

The U.S. government securities are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures.

EFFECTIVE DATE

The effective date of the plan was January 1, 2007. The plan was last amended effective January 1, 2022.

PLAN YEAR

January 1 to December 31.

CASH BALANCE ACCOUNT

The sum of Cash Balance Credits and Earnings Credits. As of January 1, 2024, Cash Balance Accounts, excluding Cash Balance Credits for the year, totaled \$34,253,885.

CASH BALANCE CREDITS

Cash Balance Credits shall be credited to eligible participants' Cash Balance Accounts for the year, based on the plan document's provisions. For the 2024 plan year, Cash Balance Credits are estimated to total \$3,716,000.

EARNINGS CREDITS

Earnings Credits shall be credited to participants' Cash Balance Accounts based on the rate of return on plan assets, subject to a cumulative maximum of 7.50% and any minimums required by the plan. As of the participant's benefit commencement date, in no event shall cumulative Earnings Credits during a participant's period of plan participation be less than \$0.

NORMAL RETIREMENT AGE

The attainment of age 62.

BENEFIT AMOUNT

The Cash Balance Account, or its actuarial equivalent payable as an annuity, subject to IRS maximums. Benefits are payable immediately following termination of employment or while in service for participants who have reached age 59.5.

VESTING

Each participant is always 100% vested in his or her Cash Balance Account.

STATUTORY LIMITS

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.
