Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Frick Collection Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. Description of Plan

The following description of The Frick Collection Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Frick Collection (the "Museum") and was established on November 1, 1992. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Trustees of the Museum oversees governance of the Plan. The Museum's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Museum's Board of Trustees.

Eligibility

Participation in the Plan is voluntary and employees may enroll in the Plan at any time immediately following their date of hire with the Museum.

Contributions

Participants may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan document. The money that is deducted are "pre-tax" dollars and Roth. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Museum. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants with at least 15 years of service with the Museum may be eligible for the special 403(b) 15-year service catch-up, allowing up to an additional \$3,000 of elective deferrals per year (lifetime aggregate limit of \$15,000), subject to Internal Revenue Service ("IRS") calculations and coordination with the age-50 catch-up. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an automatic contribution feature under which eligible employees who do not make an affirmative election are automatically enrolled at 4% of eligible compensation. Participants may opt-out or change their rate at any time and may request a permissible withdrawal of automatic contributions and related earnings within 90 days after the first automatic contribution; any matching amounts related to withdrawn deferrals are forfeited.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

Vesting

A participant is fully vested in his or her own contributions, rollover contributions and earnings thereon at all times.

Payment of Benefits

Upon termination of service due to retirement, disability or death, a participant or beneficiary may elect to receive either the entire amount credited to the participant's account in either a lump-sum or, at the participant's election, in periodic installments. For termination of service due to other reasons a participant may receive the current value of the participant's vested account in a lump-sum distribution. Active employees may request to receive a benefit payment upon reaching age 59 ½ or for an immediate and heavy financial need in the form of a hardship distribution.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000 (whichever is less). Participants may take a loan once in any 12 consecutive-month period, subject to the IRC limits, on the total amount that can be borrowed. Participants may only have one outstanding loan at a time. The interest rate must be reasonable and loans must be repaid within five years, unless the loan is used to purchase a principal residence of the participant. The notes are secured by the balance in the participant's account. Principal and interest are paid directly by the participant through periodic monthly or quarterly payments. Interest rates on outstanding loans range from 4.25% to 9.50% with maturity dates through 2029 at December 31, 2024.

Plan Expense Account

The Plan entered into a service agreement with Lincoln Financial Group Trust Company, Inc. ("Lincoln Financial") whereby a portion of the revenue earned by the trustee from certain funds is passed through to the Plan for payment of permitted Plan expenses. For the Plan to receive credits as a result of these arrangements, and to use this credit to pay Plan expenses, the Company created the Plan Expense Account under the Plan. The Plan Expense Account is a nonparticipant directed account within the Plan, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with plan administration. The Plan Credit Account balance was \$27,124 and \$18,511 at December 31, 2024 and 2023. In 2024, no funds were used to reduce administrative expenses from the Plan Expense Account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), using the accrual basis of accounting, which recognizes revenue when it is earned, and expenses as they are incurred.

Use of Estimates

In conformity with U.S. GAAP, the Plan’s management makes estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the Lincoln Fixed Account and Lincoln NY Stable Value Account, which are stated at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan’s contracts, and transfers in (if any), less any withdrawals and transfers out (if any).

The contract value is derived from a discounted cash flow analysis and other factors. Registered investment companies are stated at fair value and classified as Level 1 in the fair value hierarchy as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Museum and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company, qualified institutions.

4. Lincoln Fixed Account

The Lincoln Fixed Account (the “Fixed Account”) is a fully benefit-responsive investment contract with Lincoln National Life Insurance Company. The Fixed Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least quarterly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. Lincoln has an internal committee that reviews and sets interest rates quarterly based on a variety of proprietary factors. Lincoln’s standard crediting methodology is to apply a portfolio interest rate to the Fixed Account. That is, a single interest rate applies to the entire balance of the participant’s Fixed Account. The declared portfolio interest rate is published quarterly in advance of the quarter for which the rate will be effective. The rate of interest actually credited to the Fixed Account will be the greater of the declared rate of interest or the guaranteed minimum interest rate specified in the contract. Lincoln may vary the interest crediting methodology from time to time. A contribution allocated to the Fixed Account is credited with interest beginning on the next calendar day following the day the contribution is received in good order and processed to the participant’s account. The processing date is the same as the date of receipt if all participant data is complete.

4. Lincoln Fixed Account (*continued*)

The Fixed Account represents approximately 15% and 20% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, and represents an obligation from Lincoln as amounts come due. Contributions allocated to the Fixed Account are guaranteed to be credited with a minimum interest rate. The standard guaranteed minimum interest rate is 3.00%.

A participant may transfer or withdraw all or a portion of his or her Fixed Account balance without limitation. Withdrawals are subject to contract surrender charges and annual contract administration charges, if applicable. Surrender charges may be waived under certain conditions, as described in the group annuity contract. In addition, some contracts may have elected an optional free withdrawal provision that permits one withdrawal on behalf of the participant of up to 20% of the participant's total account balance (i.e., Fixed Account balance plus any variable subaccount balances) each contract year without incurring a surrender charge. Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: A.M. Best (A as of February 2025), Standard and Poor's (A+ as of July 2024), Moody's (A2 as of August 2025), and Fitch (A+ as of July 2025).

The Plan administrator does not believe that any events would limit the Plan's ability to transact at contract value.

5. Lincoln Stable Value Account

The Plan offers the Lincoln NY Stable Value Account (the "Contract") as an investment option under the Plan. The Contract is a fully benefit-responsive fixed annuity contract issued by The Lincoln National Life Insurance Company and is backed by the general assets of the issuing company. The Contract is designed to provide Plan participants with liquidity, yield and stability. Benefit payments from the Contract are allowed whenever qualifying life events occur (upon retirement, termination and other life events), but voluntary withdrawals for the purpose of transfer to other investments are limited by 90-day equity wash provisions. The crediting rate is determined and declared periodically by a Lincoln executive committee.

The Contract is not material to the Plan's net assets available for benefits as of December 31, 2024 and 2023, and represents an obligation from Lincoln as amounts come due. The credit risk of the issuer, Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: A.M. Best (A as of February 2025), Standard and Poor's (A+ as of July 2024), Moody's (A2 as of August 2025), and Fitch (A+ as of July 2025).

6. Plan Termination

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Museum has adopted a plan document that has been designed to satisfy the IRC Section 403(b) regulations. The Plan is an adopter of an Internal Revenue Service approved volume submitter plan which received an opinion letter dated March 31, 2017 from the Internal Revenue Service. The Museum believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

8. Party-in-Interest Transactions

Certain investments are managed by Lincoln Financial Group Trust Company, Inc. and Lincoln National Life Insurance Company, the Plan's custodians and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Museum who participate in the Plan, provide administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
