## Independent Auditor's Report

To the Trustees of  
The JEPH Pension Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The JEPH Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. #### NOTE 1. DESCRIPTION OF PLAN

The following brief description of The JEPH Pension Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined benefit pension plan covering substantially all employees of Steuben Foods, and non-union, non-management employees of Mountainside Farms, Pound Ridge and Worchester Creameries, as well as Steuben Sales management employees (collectively, The Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Review Board is responsible for oversight of the Plan. The Investment Review Board determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Trustees.

**Eligibility:** Prior to the amendment effective July 31, 2005, all employees of the Company who had reached the age of 21 and had one year of service were eligible to participate in the Plan. An employee became a participant on the first of the month coinciding with or following both the completion of a year of service and attainment of age 21. The Plan was amended effective July 31, 2005 to freeze participation and benefit accruals as of July 31, 2005. On or after August 1, 2005, no employee who was not a participant as of July 31, 2005 shall become a participant and the accrued benefit of any individual who was a participant as of July 31, 2005 is his or her accrued benefit.

**Contributions:** The Plan's funding policy is for the Company to make annual contributions to the Plan in amounts not less than the minimum funding requirement of ERISA and not more than the amount permitted by the Internal Revenue Code (IRC). During the years ended December 31, 2024 and 2023, the Company made contributions to meet the minimum funding requirements of ERISA.

**Vesting:** A Participant's right to receive his or her retirement benefit shall become non-forfeitable upon the earlier of (a) the date the Participant is credited with a vesting period of service of five years or (b) the Participant's attainment of age 65.

**Pension Benefits:** Employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65), based on a percentage of the average of the highest consecutive five years of compensation multiplied by the number of service years, not exceeding 40 years. The normal retirement date is the first of the month that coincides with or follows the attainment of age 65. The Plan permits early retirement starting at age 55 once the participant has earned 5 years of vesting service. If a participant elects early retirement, the participant can elect to receive a benefit in the amount of the accrued benefit beginning at age 65 or the participant may choose to collect an early reduced benefit from the Plan. The early benefit is reduced by the participants benefit commencement age taking into account the participant will be collecting benefits over a longer period of time.

**Death and Disability Benefits:** If an active participant dies prior to commencing retirement benefits, the Plan will provide a benefit to the participant's spouse. Active participants who become totally and permanently disabled become 100% vested in his/her accrued benefit and payments commence as though the participant had retired.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The Plan prepares the accompanying financial statements on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and such disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Accordingly, actual results may differ from those estimates.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Review Board determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Receivables:** In September 2019, the Plan was notified by the Pension Benefit Guarantee Corporation ("PBGC") (a U.S. government agency), that they were in agreement with the Plan Sponsor's, Steuben Foods, Inc., calculation of additional contributions required to be made relating to the closure of the Elmhurst Dairy, Inc. facility in October 2016. As a result of the Notice of Determination by the PBGC, the Plan Sponsor must fund \$121,029 in seven annual installments. During 2019, total contributions of \$847,203 were recorded, along with a corresponding contribution receivable. Each year as contributions are remitted to the Plan, the receivable will be reduced. The Plan Sponsor remitted \$121,029 during the years ended December 31, 2024 and 2023.

Additional contributions were recorded during the year ending December 31, 2024 amounting to \$232,132 (\$273,185 – 2023) to meet the Plan's minimum funding requirements as calculated by the actuary. These contributions are unrelated to the additional contributions required by the PBGC.

**Payments of Plan Benefits:** Benefits are recorded when paid.

**Administrative Expenses:** All expenses associated with the operation of the Plan including, but not limited to the premiums for termination insurance payable to the PBGC, asset custodian expenses and fees, actuarial and recordkeeping services are paid by the Plan and recorded as deductions in the accompanying statements of changes in net assets available for benefits. All permitted expenses are paid by the Plan, unless paid for by the Company. Fees incurred that have been paid by the Plan for the year ended December 31, 2024 amounted to \$121,071 (\$140,632 - 2023).

**Subsequent Events:** These financial statements have not been updated for subsequent events occurring after October 9, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), *Accounting Standards Codification (ASC) 820: Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled separate accounts:** The separate accounts are stated at fair value based on the quoted market prices of the underlying mutual funds. The separate account investment choices must be reported at the fair value in the defined benefit plan's financial statements. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (NAV) as the practical expedient, or the price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

#### NOTE 5. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, that are attributable to employees' services rendered as defined by the Plans provisions. Accumulated plan benefits include benefits expected to be paid to (a) present employees or their beneficiaries, (b) retired or terminated employees or their beneficiaries, and (c) beneficiaries of employees who are deceased. Benefits under the Plan are based on employees' compensation during their five consecutive years receiving the greatest aggregate amount of compensation as of July 31, 2005. Benefits payable under all circumstances: retirement, death, disability, and termination of employment, are included, to the extent they are deemed attributable to employee service rendered at the valuation date.

The actuarial present value of the accumulated plan benefits is determined by Principal, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The actuarial cost method was computed using the Pension Protection Act of 2006 Funding Rules. The significant actuarial assumptions used in the valuations as of December 31, 2023 were (a) life expectancy of participants (Pri-2012 white collar mortality table), (b) retirement age assumptions (the assumed retirement age was 65), and (c) investment return. The interest rates used to discount the obligation for 2023 was 5.75%. The assumed interest rate is the net rate of return after payment of any expenses or fees charged to the Plan.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. Had the valuations been performed as of December 31, there would be no material differences.

For the year ended December 31, 2024, the change in the actuarial assumptions was due to the discount rate used to determine the present value of accumulated plan benefits increasing from 5.50% to 5.75%.

#### NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

#### NOTE 7. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved defined benefit plan sponsored by Principal. The non-standardized pre-approved defined benefit plan provider has received an advisory letter from the Internal Revenue Service (IRS) on February 28, 2023 as to the pre-approved plan's qualified status. The pre-approved plan advisory letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the advisory letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code (IRC) and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. The Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

#### NOTE 8. PLAN TERMINATION

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the PBGC up to the applicable limitations (discussed subsequently).
- c. All other vested benefits not insured by the PBGC.
- d. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, a statutory ceiling exists, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination, whichever comes later. For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations, and may also depend on the financial condition of the Plan sponsor and the level of benefits guaranteed by the PBGC.

#### NOTE 9. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are maintained in investment funds managed by Principal for the years ended December 31, 2024 and 2023. Principal was the trustee as defined by the Plan and, therefore, transactions with Principal qualify as party-in-interest. Fees paid by the Plan for administrative services amounted to \$54,046 for the year ended December 31, 2024 (\$62,092 - 2023).

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

#### Basis for lump sums

#### Interest rate

Based on the three segment yield curve: 3.55%/3.95%/4.95%  
The plan document defines the lump sum interest rate based on IRC §417(e) rates which closely tie to the high quality corporate bond yields. According to our most recent study, the long-term expected yields for short/intermediate/long corporate bonds are 3.55%/3.95%/4.95%. For details, see Corporate AA yield in Table 3 of Long-Term Capital Market Assumptions link.

#### Mortality

We have selected the same [mortality](#) assumption for lump sum payments, but with a 50/50 blend of male and female total dataset base rates and mortality improvement scales. This reflects the IRS practice of defining lump sum mortality on a unisex basis.

Effective July 31, 2005, a participant's covered compensation is equal to the amount as of that date.

#### Optional forms of benefit payments

The optional forms of benefit payments are:

- Monthly annuity payable as a survivorship life annuity with survivorship percentages of 50, 75, or 100.
- Single sum payment on portion of benefit earned prior to April 1, 1996, up to a maximum of \$10,000.

The optional form conversion basis for payments other than lump sums varies depending on the optional form. See Actuarial Equivalent section of the plan document for details.

#### Lump sum provisions

Small amount force out (SAFO) – allowed up to \$7,000.

Lump sums in excess of SAFO - are allowed as noted above.

Conversion – deferred rate based on the applicable interest rate and applicable mortality table as set forth in Code Section 417. The applicable interest rate uses the second calendar month preceding the first day of the stability period which is the plan year.

#### Changes in Principal Eligibility or Benefit Provisions

There have been no changes in principal eligibility or benefit provisions since the last valuation.
