Notes to Financial Statements
Years Ended December 31, 2024 and 2023

1. Description of Plan:

The following description of the 403(b) Thrift Plan of Community Health Care (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General – The Plan is a defined contribution plan established by Community Health Care (the Employer) originally effective January 1, 1997. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently amended June 2020. The Plan excludes nonresident aliens and employees who normally work less than 20 hours per week. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility – Eligible employees may participate in the salary reduction arrangement in the Plan beginning on their date of hire. Employees are eligible to participate in Employer contributions after attaining age 18 and completion of one year of service in which they have worked at least 1,000 hours. Employees enter the Plan on the first day of the month following the completion of the eligibility requirements.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 403(b) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in the designated default fund, until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have completed at least 15 years of service with the Employer may make qualified organization catch-up deferrals which exceed the elective deferral limit.

The Employer will make a qualified matching contribution equal to 100 percent of participant deferrals up to 1 percent of eligible compensation and an Employer base contribution equal to 4 percent of eligible compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, the Employer's matching and base contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

1. Description of Plan (continued):

Vesting – Participant contributions and actual earnings thereon are 100 percent vested. Vesting in the Employer’s matching and base contributions are based on years of continuous service in accordance with the following schedule:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

Notes receivable from participants – Matrix Trust Company allows participants to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at a rate of the bank’s prime rate plus 1 percent. Interest rates ranged from 4.25 percent to 9.5 percent at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

Benefit payments – Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump-sum distribution or in monthly installments over a period of not more than his or her life expectancy. The Plan allows for in-service distributions if a participant reaches age 59 ½, and hardship distributions subject to Plan provisions. Participants with five years of participation may take in-service distributions of Employer contribution accounts accumulated through March 31, 2013. If a participant terminates employment and the participant’s account balance does not exceed \$5,000, the plan administrator may authorize the benefit payment without the participant's consent.

Administration of the Plan – The Plan is administered by the Employer. Plan assets are invested in accordance with the employee’s instructions. Records of participant account activity are processed and maintained by Mutual of America and Matrix Trust Company, the insurance company and custodian, respectively, which also perform other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$88,594 and \$215,065, respectively. During the Plan years ended December 31, 2024 and 2023, \$289,205 and \$75,218 of forfeitures were used to fund Employer contributions, respectively.

Subsequent events – Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Administrative expenses are paid by either the Plan or the Employer as provided by the plan document. Investment related expenses are included in net appreciation in fair value of investments.

Plan termination – Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100 percent vested in their respective account balances.

3. Information Certified by the Plan Custodian:

Mutual of America and Matrix Trust Company, have supplied the plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

4. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices, that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts – Pooled separate accounts are valued at the NAV of units, as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

Collective Funds – Collective funds are valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there was a transfer of approximately \$3,828,000 from pooled separate accounts (Level 2) to mutual funds (Level 1) due to the assets held with Mutual of America being transferred into the assets held by Matrix Trust Company. For the year ended December 31, 2023, there no were significant transfers out of Level 2 to Level 1.

5. Group Annuity Contract with Insurance Company:

In 1997, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Group Annuity Contract with Insurance Company (continued):

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreement without the consent of the issuer

The contract was terminated, and the assets were transferred to Matrix Trust Company on November 8, 2024.

6. Risks and Uncertainties and Concentrations of Credit Risk:

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

The Plan has a concentration of investments in Vanguard Institutional Index I. A change in the value of this fund could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of the funds being selected by participants, certain other funds may individually represent a concentration of greater than 10 percent of the Plan's investments at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt, or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024, Vanguard Institutional Index I represented greater than 10 percent of the Plan's investments at fair value.

7. Plan Tax Status:

403(b) plans are not required to receive a favorable determination letter from the IRS indicating that the Plan is tax-exempt under present income tax law. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The Employer adopted a prototype document, effective June 2020, with a favorable opinion letter dated March 31, 2017, in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions:

The following transactions are considered party-in-interest transactions under ERISA regulations, but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA:

- The Employer provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees that provide these services also are participants of the Plan.
- Plan investments are managed by Mutual of America and Matrix Trust Company, the Plan's insurance company and custodian, respectively.
- The plan auditor performs the required annual audit of the Plan.
- The Plan relies on a third-party service provider, Milliman Inc., to prepare the Plan's IRS Form 5500 and to provide certain recordkeeping and compliance services.
