## Report of Independent Auditors

To the Administrator of ASM Global Retirement & Savings Plan

We have performed an audit of the accompanying financial statements of ASM Global Retirement & Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of Plan

#### General

The following brief description of the ASM Global Retirement & Savings Plan (the “Plan”) is provided for general information purposes only. Plan participants should refer to the plan document and summary plan document for a more complete description of the Plan’s provisions. The Plan’s sponsor is ASM Global Parent, Inc. (the “Company”).

On August 22, 2024, a Merger Agreement dated November 4, 2023 for the sale of the Plan sponsor’s stock was finalized upon the completion of regulatory approval. Plan management has not yet determined the impact to the Plan.

#### Eligibility

The Plan was established on January 1, 1993. The Plan is a defined contribution plan providing retirement and savings benefits to all eligible employees of ASM Global who have attained the age of 21, are full time employees, are union employees not otherwise excluded from participation per the plan document and as of January 1, 2024 in accordance with the Setting Every Community Up for Retirement Enhancement 2.0 Act (SECURE 2.0 Act), have three consecutive years of service with at least 500 hours in each 12 month eligibility computation period or 1,000 hours of service in a 12-month period. The Plan includes an automatic enrollment feature. Eligible participants are automatically enrolled in the Plan unless they affirmatively decline to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### Contributions

The participants may contribute up to 90% of their annual pretax salary subject to certain limits set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. In accordance with the SECURE 2.0 Act, beginning in 2025, participants who are age 60 through 63 are eligible for an additional catch-up contribution amount, subject to annual IRS limits. If automatically enrolled, a participant’s deferral is set at a percentage of eligible compensation until changed by the participant. The automatic enrollment deferral percentage is 8%, and until changed by the participant, is invested in a Fidelity Freedom fund that approximates the participant’s retirement date. Participants may change the allocation of their investments at any time during the year. The Company may make matching contributions to participants, as defined by the Plan, equal to a discretionary percentage to be determined by the Company, of the participant’s elective deferrals. An eligible employee needs to be employed on December 31 of each plan year to receive the employer matching contributions. The Company, at its discretion, matched 100% of the first 3% of the participant’s deferral amount in 2024.

An additional profit-sharing contribution may also be made at the Company’s discretion based on annual performance. This additional discretionary contribution is allocated among participants’ accounts in proportion to their respective compensation amounts. No additional profit-sharing contribution amounts were contributed for 2024.

Participants may also contribute amounts representing distributions from other qualified plans.

### Forfeitures

Forfeitures are first used to pay administrative expenses. Any remaining amounts, if applicable, may be applied to reduce employer contributions, though no such application occurred in 2024. The Plan used forfeited nonvested accounts to reduce administrative expenses by \$130,238 in 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$952,585 and \$664,059, respectively. If terminated participants resume employment, they may be eligible to make a restoration contribution and return their account balances to a level at which it stood at the time of distribution.

### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings (losses) and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of the participant's respective elected investment options. Allocations of administrative expenses are based on each participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Distributions

Distributions are permitted upon death, disability, retirement, termination, or upon reaching the age of 59 1/2. Participants receive benefits in a lump-sum payment equal to the value of the vested interest in their accounts. Hardship distributions may be taken by all participants, regardless of age, if the participant satisfies certain conditions set out in the Plan. The required minimum distribution age is 73 and terminated participants must begin taking minimum distributions in April of the year following the year they turn age 73. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

### Administrative Costs

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan provisions. During 2024, no administrative costs of the Plan were paid by the Company. Administrative costs paid by the Plan, after use of forfeitures, in 2024 were \$198,742.

### Notes Receivable from Participants

Participants may borrow against their vested interest in the Plan. The minimum loan amount is \$1,000. The maximum loan is the lesser of one-half of the participant's vested balance or \$50,000. Loans bear interest at a rate equal to the prime rate as received by Fidelity Management Trust Company from Reuters plus 2.00% at the date of issuance. The interest rate on the loans outstanding as of December 31, 2024 and 2023 range from 4% to 10.5%, respectively. A

participant may only have one loan outstanding at any given time. Loan terms range from one to five years or up to ten years for the purpose of primary residence. Principal and interest is paid ratably through payroll deductions.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Plan management determines the methods for measuring fair value. Fair value is the price that would have been received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains or losses on investments bought and sold, as well as held during the year.

### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participation compensation is earned.

### Payment of Benefits

Benefits are recorded when paid.

### Risks and Uncertainties

The Plan provides for various investment options in any combination of assorted registered investment companies (mutual funds and a money market fund) and self-directed brokerage accounts (common stock and mutual funds). Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases of defaults, credit rating downgrades. Market risks may also include global events which could impact the value of investment securities, such as a pandemic, international conflict, tariffs or trade wars. Due

to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

### 3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a framework for measuring fair value and expands disclosures about fair value measurements in financial statements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

#### **Registered Investment Companies (Mutual Funds and Money Market Funds)**

Valued at the net asset value of shares held by the Plan at year-end at the closing price reporting on the active market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Related Party and Party in Interest Transactions**

Certain Plan investments are shares of registered investment companies or of self-directed brokerage accounts managed by Fidelity Management & Research Company ("FMR"). FMR is an affiliate of Fidelity Management Trust Company ("Trustee"), the Trustee as defined by the Plan. Therefore, transactions in these investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

**5. Certified Financial Data**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the ERISA. All investment balances and related investment information presented and disclosed in the accompanying financial statements, notes to financial statements and supplemental schedule required by ERISA, including investments, at fair value and participant notes receivable at December 31, 2024 and 2023; and net appreciation in fair value of investments, interest and dividends; and interest on participant notes receivable for the year ended December 31, 2024, were obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Trustee, Fidelity Management Trust Company.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become immediately 100% vested in the Company's contributions.

#### **7. Tax Status of the Plan**

The Plan is a Fidelity Non-Standardized Pre-Approved Profit Sharing Plan with CODA and has received an opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under section 401(a) of the Internal Revenue Code (Code) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan has been amended since the receipt of the opinion letter; however, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is not subject to income tax examinations for years prior to 2021.

#### **8. Subsequent Events**

The Plan's management has evaluated all activity of the Plan through October 6, 2025, the date the accompanying financial statements were available to be issued.
