### Scope and Nature of the Employee Retirement Income Security Act of 1974 (“ERISA”) Section 103(a)(3)(C) Audit

**NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024**

**NOTE 1 - DESCRIPTION OF PLAN**

**General**

The NFS Health & Welfare Benefits Plan (the "Plan") is a self-funded health and welfare plan with stop-loss insurance arrangements that provides health benefits to certain current and former employees of Nuclear Fuel Services, Inc. (the "Plan Sponsor," "Company," or "NFS") and their dependents, along with long-term disability and life insurance. The Plan is administered by the BWXT Employee Benefits Committee. The Company is ultimately owned by BWX Technologies, Inc.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan provides health benefits (including hospital, surgical, medical, and pharmaceutical) to participants, beneficiaries and eligible dependents, subject to payment of premiums, deductibles and coinsurance amounts by the respective participants. Additionally, for the hourly population, dental health benefits are offered. The Plan offers health savings account contributions to certain salaried participants, which are not included in these financial statements. The Plan has entered into stop-loss insurance agreements in an effort to limit exposure for self-insured benefits (an annual qualifying stop loss of \$300,000 per hourly participant and of \$1,000,000 per active salaried participant during the years ended December 31, 2024 and 2023, respectively). Benefits paid to or for participants, net reported on the Statements of Changes in Net Assets Available for Benefits includes stop-loss reimbursements totaling \$284,167 and \$158,694 netted against benefit payments for the years ended December 31, 2024 and 2023, respectively. The claims for self-insured benefits are processed by the Plan's third-party claims processors. The claims processors determine benefits to be paid under claims, draft such amounts from the Plan Sponsor's bank account, and remit such amounts to providers to settle the claims.

For the hourly population only, the Plan also provides long-term disability and life insurance, as well as vision benefits through insured arrangements with Hartford Life and Accident Insurance Company and Metropolitan Life Insurance Company, respectively.

The costs of the benefit plan are shared by the Company, active employees and retirees. Active participants make contributions to the Plan through fixed withholdings from the participant's periodic payroll earnings, and retired participants make monthly contributions which are withheld from their pension income and through separate remittance to the Sponsor based on the premium schedule for the level of coverage selected. During the years ended December 31, 2024 and 2023, participants contributed \$3,105,064 and \$2,887,285 to the Plan, respectively, which included approximately \$184,232 and \$76,113, respectively, of retiree contributions. The Plan Sponsor makes contributions to the Plan for the remainder of the Plan's participant claims, premium expenses and administrative expenses on a pay-as-you-go basis. Contributions made to the Plan from the general assets of the Plan Sponsor were \$13,166,193 and \$12,470,828 for the years ended December 31, 2024 and 2023, respectively. Certain allowable administrative expenses, as defined by the Plan document, are paid by the Plan. Benefits are administered under contract with service providers.

The amounts contributed to the Plan for retired employees are included in the Retiree Medical Trust for Salaried Retirees and the Retiree Medical Trust for Hourly Retirees, both of which are Voluntary Employees' Beneficiary Associations ("VEBA"). Retiree related expenses and the majority of retiree insurance premiums are paid from the VEBA trusts. The trustee of the Plan's non-401(h) assets is Truist Bank (the "Trustee"), and Northern Trust Company serves as the trustee for the 401(h) assets (collectively, the "Trustees").

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and collective bargaining agreements. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants for each respective population. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than the exclusive benefit of the Plan's participants, unless all benefit obligations have been met.

## **Eligibility**

All active, full-time employees of the Company were eligible to participate in the Plan prior to January 1, 2025, at which time benefits covering active employees became subject to the BWXT Health & Welfare Benefits Plan, with retirement benefit obligations remaining part of the NFS Health & Welfare Benefits Plan. Individuals hired prior to January 1, 1994, who are vested in the pension plan (salaried population only) and who have retired from active service after attaining age 55 and who have satisfied the specified early or normal retirement vesting requirements are eligible to participate in the Plan. Individuals who have become disabled while actively employed by the Plan Sponsor are also eligible to participate in the Plan. Individuals who have attained age 55, met the specified early or normal retirement vesting requirements, and are subject to a reduction in workforce by the Plan Sponsor are eligible, upon retirement, for certain benefits offered by the Plan. Additionally, for the salaried population only, those employees who, upon retirement, have age plus years of service credits of 85 or greater will also be eligible for coverage by the Plan. Active employees may choose to participate in other health plans sponsored by the BWXT Investment Company. These employees remain eligible for the postretirement benefit. See Note 2 for additional information regarding the postretirement benefit component of the Plan.

Eligibility for the long-term disability benefit is limited to employees who have completed 12 months of continuous service. For employees hired after February 1, 1988, life insurance benefits become available on the first day of the month following the date of hire.

## **Collective Bargaining Agreement for Hourly Employees**

On September 23, 2023, the Company entered into a five-year collective bargaining agreement with the United Steel Workers Union (the "USW Union"), effective for the period from May 15, 2023 through May 15, 2028, which was an extension of the prior six-year agreement and included no material changes. All USW Union hourly employees of the Company are covered by this agreement with the USW Union. Pursuant to Article 24 of this agreement, hourly employees retiring on or after January 1, 2007 will incur a medical insurance cost share of 10%. Hourly employees retiring on or after January 1, 2008 will incur a medical insurance cost share of 20%.

On August 16, 2024, the Company entered into a four-year collective bargaining agreement with the International Guards Union of America (the "IGUA Union"), effective for the period from October 17, 2024 through October 17, 2028, which was an extension of the prior six-year agreement and included no material changes. All IGUA Union hourly employees of the Company are covered by this agreement with the IGUA Union.

## **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the U.S. ("GAAP").

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; claims incurred but not reported; claims payable; and the actuarial present value of postretirement benefit obligations and changes therein at the date of the financial statements. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan invests in various mutual funds including money market funds, index funds, and bond funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the financial statements. Significant changes in investment values arising in connection with economic disruptions may not be recovered or sustained and these effects could be material in future periods.

## **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value determinations are made by reference to available quoted market prices on national exchanges when available, by reference to quoted prices for similar securities when available, or by using a range of techniques appropriate to the nature of the investment. See Note 3 for further discussion of valuation methodologies used with respect to investments.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation of those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

## **Claims Incurred But Not Reported**

The Plan's liability for incurred but not reported claims is estimated using historical trend information.

## **Payment of Benefits**

Medical benefits are recorded when paid by third-party processors utilized by the Plan, and other benefits paid with the general assets of the Plan Sponsor are recorded when paid.

## **Postretirement Benefits**

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired, terminated, or disabled participants and their beneficiaries and eligible dependents and (2) active employees hired prior to January 1, 1994, and their beneficiaries and eligible dependents after retirement from service with the Plan Sponsor or becoming disabled. Employees hired on or after January 1, 1994 are not eligible for postretirement benefits. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan Sponsor and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and represents the amounts that result from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect those costs expected to be borne by Medicare, the retired participants, and other providers.

Actuarial assumptions used to determine the postretirement benefit obligation include a discount rate of 5.62% and 5.06% as of December 31, 2024 and 2023, respectively. The assumed long-term rate of return on investments for certain assets attributable to the hourly population only was 5.00% for the years ended December 31, 2024 and 2023. The assumed long-term rate of return on investments for certain assets attributable to the salaried population only was 3.25% for the years ended December 31, 2024 and 2023. The assumed long-term rate of return on investments for 401(h) assets attributable to the salaried population only was 3.50% for the years ended December 31, 2024 and 2023. Historical benefit payment and participant premium-payment levels and trends are incorporated into the valuation process. The assumed health care cost trend rate for retirees was 6.50% for the years ended December 31, 2024 and 2023 and 7.50% for other participants for the years ended December 31, 2024 and 2023. The trend gradually decreases to 4.50% by year 2035 for retirees and by year 2037 for other participants. Increasing the assumed health care cost trend rate by 1.00% would have resulted in an increase in the Plan's postretirement benefit obligations of \$2,333,454 and \$2,388,097 at December 31, 2024 and 2023, respectively. The Pri-2012 benefits-weighted mortality assumption with future mortality improvement using Gallagher's modified MP2021 scale was used as of December 31, 2024, with rates reduced post-retirement. The Pri-2012 benefits-weighted mortality assumption with future mortality improvement using Gallagher's modified MP2021 scale was used as of December 31, 2023, with rates reduced post-retirement. Age morbidity aging factors from the Society of Actuaries (Yamamoto May 2013), modified for continuous service, were used. Normal retirement age is 65, and retirement and withdrawal rates used as of December 31, 2024 and 2023 are consistent with historical experience. Changes in actuarial assumptions as of December 31, 2024 resulted in a \$1,029,293 increase to the Plan's benefit obligation, which was primarily due to an increase actual claims cost and plan experience. Changes in actuarial

assumptions as of December 31, 2023 resulted in a \$718,921 increase to the Plan's benefit obligation, which was primarily due to a decrease in the discount rate, partially offset by actual claims cost and plan experience.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The Plan's benefit obligations are expected to be primarily funded by Plan Sponsor contributions to the Plan in future years and assets held in the VEBA trusts.

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators, the trustee, accountant and actuary. These expenses are reported on the statements of changes in net assets available for benefits as administrative expense. All other administrative expenses, such as professional fees, are paid by the Plan Sponsor on behalf of the Plan without reimbursement and are not included in these financial statements.

#### **401(h) Account**

Effective December 21, 1993, the Nuclear Fuel Services, Inc. Retirement Plan for Salaried Employees was amended to include a medical benefit (health and welfare) component in addition to normal retirement benefits to fund a portion of the postretirement obligations for retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code ("IRC"). A separate account, which primarily holds short-term interest-bearing securities, has been established and maintained in the Nuclear Fuel Services, Inc. Retirement Plan for Salaried Employees for such contributions (the "401(h) Account"). In accordance with IRC Section 401(h), the Plan's investments in the 401(h) Account may not be used for, or diverted to, any purpose other than providing health and welfare benefits for salaried retirees and participants.

GAAP specifies the accounting for and disclosure of 401(h) features of defined pension plans by both defined benefit pension plans and health and welfare benefit plans. Health and welfare benefit plans are required to include the net 401(h) assets and the changes therein in the financial statements. Medical and prescription claims totaling \$155,220 and \$212,246 were paid from the 401(h) Account assets on behalf of salaried retirees over the age of 65 in the years ended December 31, 2024 and 2023, respectively, and as such, have not been included in the amounts reported as benefits paid to or on behalf of participants in the Statements of Changes in Net Assets. For additional disclosures on the investments of the 401(h) Account, refer to the audited financial statements of the Nuclear Fuel Services, Inc. Retirement Plan for Salaried Employees.

#### **Evaluation of Subsequent Events**

The plan administrator has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued, for their impact on amounts recorded and related disclosures, and has incorporated related changes as appropriate.

#### **NOTE 3 - FAIR VALUE MEASUREMENTS**

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. ASC 820 also expands the disclosure requirements around fair value and establishes a hierarchy for valuation inputs that emphasizes the use of observable inputs when measuring fair value.

In accordance with GAAP, the Plan classifies its investments into one of the following three categories:

- Level 1 Inputs are based on unadjusted quoted prices for identical instruments traded in active markets.
- Level 2 Inputs are based on unadjusted quoted prices for similar instruments in active markets or identical instruments in inactive markets and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the asset or liability.
- Level 3 Inputs are generally unobservable and typically reflect estimates of assumptions that market participants would use in pricing the asset or liability. The fair values are usually determined using model-based techniques that include option pricing models, discounted cash flow models and similar valuation techniques.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. As of December 31, 2024 and 2023, Investments, at fair value disclosed on the Statement of Net Assets Available for Benefits, substantially all of which were mutual funds, were classified as Level 1 assets within the fair value hierarchy. The common collective trust investment is valued using net asset value per share as determined by the investment advisor as the practical expedient for fair value. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels, and no Level 2 or 3 assets were held.

#### NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEES (Unaudited)

The Plan administrative committee has elected the Section 103(a)(3)(C) audit method of annual reporting compliance permitted by the provisions of 29CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's independent auditors did not perform any auditing procedures with respect to the information certified by the Trustee, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of GAAP. All financial data included in the financial statements and their accompanying notes relating to investments, income from investments, and net appreciation in fair value of investments was obtained from the information certified as complete and accurate by the Trustee, with valuation adjustments made to certain investments which have delayed reporting. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedules, that was prepared by or derived from the information prepared by the Trustees and furnished to the plan administrator. The plan administrator has obtained certifications from the Trustees that such information is complete and accurate (Northern Trust Company has provided the certification related to the 401(h) Account amounts).

#### NOTE 5 - TAX STATUS

The VEBAs established under the Plan to hold the Plan's assets are intended to qualify as tax exempt trusts pursuant to Section 501(c)(9) of the IRC. The hourly VEBA consists solely of contributions for unionized hourly employees that are subject to collective bargaining agreements. Accordingly, investment income related to the hourly VEBA is exempt from income taxes.

The salaried VEBA consists solely of contributions for salaried employees. If the salaried VEBA's investment assets exceed its benefit obligations, the salaried VEBA is subject to an annual excess set-aside test to determine taxable income pursuant to Section 512(a)(3). As of December 31, 2024 and 2023, the salaried VEBA's investments exceeded its benefit obligations and investment income was subject to income tax under the set-aside test. As a result, income tax expense of \$248,876 and \$897,121 was recorded for the years ended December 31, 2024 and 2023, respectively and income taxes payable of \$712,084 and \$897,121 are included in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, respectively. Income tax payments of \$433,913 and \$0 were made during the years ended December 31, 2024 and 2023, respectively.

The Plan Sponsor obtained favorable tax determination letters from the Internal Revenue Service dated October 27, 1994, and, other than taxable income determined from the set-aside test, the Plan Sponsor believes that the VEBAs, as amended, continue to qualify and operate in accordance with the applicable provision of the IRC. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress, and tax periods prior to 2021 are believed to be no longer subject to potential audit.

#### NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan Sponsor provides administrative services to the Plan, and pays certain administrative costs on behalf of the Plan with no reimbursement from the Plan or the participants. The Plan Sponsor serves as the funding party and pays certain benefits on behalf of the Plan under the provisions of the Plan.

The NFS Health and Welfare Benefit Plan maintains within the Plan a separate VEBA trust account on behalf of hourly retirees and a separate VEBA trust account on behalf of the salaried retirees to pay related costs of each retiree group. The trustee paid certain administrative costs from the hourly VEBA trust account which should have been paid from the salaried VEBA trust account totaling \$432,985 and \$382,736 for the years ended December 31, 2024 and 2023, respectively. These payments are prohibited nonexempt transactions. As funds were transferred from the salaried VEBA trust to the hourly VEBA trust to restore the two trusts to their appropriate position for the years ended December 31, 2024 and 2023, there is no impact on the total amounts reported within these financial statements as the VEBA trusts for both the hourly retirees and salary retirees are included in the Plan's financial statements.
