The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1            DESCRIPTION OF PLAN**

The following description of Spring Arbor Management 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of the following companies (collectively, the “Company”):

Employees who are residents of Puerto Rico are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The Company is the plan sponsor and plan administrator of the Plan, and as such, controls and manages the operation and administration of the Plan. The Plan’s assets are held and managed by Empower Retirement (the Custodian), who invests cash received, interest, and dividend income, as directed by participants, and makes distributions to participants (subject to the direction of the Company and the participants).

**Contributions**

Each year, participants in the Plan may voluntarily contribute up to all of their pre-tax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides safe harbor matching contributions of 100% of the first 3% of participant contributions to the Plan and 50% of the next 2% of participant contributions to the Plan. Matching contributions are invested in the same manner as participant contributions, as directed by the participant.

Participant and Company contributions are subject to the limitations specified by the Plan and the Internal Revenue Service (the “IRS”).

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, Company contributions, as well as allocations of earnings and losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting of Benefits**

Participants are immediately fully vested in their voluntary and the Company’s safe harbor matching contributions, plus actual earnings or losses thereon. Company contributions in participant accounts become fully vested upon death, disability (as defined by the Plan), attainment of normal retirement age (as defined by the Plan), or upon termination of the Plan.

**NOTE 1            DESCRIPTION OF PLAN (CONTINUED)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of issuance, is set at 1% over the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Loans are treated as an investment of the borrowing participant's account and only the borrowing participant's account receives interest paid on the participant loan.

**Payment of Benefits**

On termination of service with the Company due to death, disability, retirement, or other reason, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment distributions. The period of installment distributions may not extend beyond the life expectancy of the participant. In addition, the Plan allows hardship withdrawals as allowed by the Internal Revenue Code.

Participants still employed who have reached the age of 59 ½ are eligible to withdraw all or a portion of their vested accounts.

**Forfeitures**

The non-vested portion of a participant's account balance upon termination of service with the Company is forfeited. Forfeitures may be used by the Plan for administrative expenses of the Plan or by the Company to reduce future contributions to the Plan. During the year ended December 31, 2024, approximately \$1,300 of forfeitures were used for administrative expenses of the Plan or to reduce the Company contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$1,100 and \$800, respectively.

**Plan Amendment**

Effective January 1, 2024, the Plan was amended to recognize all prior service with a predecessor employer for purposes of determining eligibility, vesting, and/or benefit accruals, as applicable under the Plan. This amendment applies to certain employees of the Plan who were previously employed by a predecessor employer, regardless of when such service was rendered.

Management has evaluated the impact of this amendment and concluded that it does not materially affect the financial statements of the Plan as of and for the year ended December 31, 2024.

**NOTE 2            SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2            SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses is recorded as repayments of principal and interest are received primarily through payroll deductions and the notes are collateralized by the participants' accounts.

Notes receivable from participants outstanding at December 31, 2024, had interest at rates ranging from 4.25% to 9.50% and maturities through November 2029.

**Deemed Loan Distributions**

Deemed loan distributions are recorded when the participant defaults on the loan. For the year ended December 31, 2024, deemed loan distributions of approximately \$49,000 are included with benefits paid to participants.

**Contributions**

Participant contributions are recorded when withheld from compensation. Employer contributions are recorded in the period in which they become obligations of the Company.

**Corrective Distributions**

Contributions in excess of amounts allowed by the IRS or ERISA requirements are returned to the participant. Contributions are presented net of corrective distributions.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

**New Accounting Pronouncements**

The Plan has considered new pronouncements that alter accounting principles generally accepted in the United States of America and does not believe that any new or modified principles will have a material impact on the Plan's reported financial position or operations in the near term.

**Subsequent Events**

Plan management has evaluated subsequent events through the date of the independent auditor's report, the date which the accompanying financial statements were available to be issued. Based on such evaluation, no events have occurred that, in the opinion of management, warrant adjustments to or disclosures in the financial statements.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820: *Fair Value Measurement* are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies*

The value is based on quoted market prices in an active market where individual securities are traded, as of the last trading day of the Plan year.

*Common Collective Trust*

The net asset value (NAV) of units of a financial institution common collective trust, which are not publicly quoted prices in an active market, is based on the fair value of the underlying investments, less any liabilities. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PARTIES-IN-INTEREST**

Parties-in-interest include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or a Company whose employees are covered by the Plan.

In addition to notes receivable from participants, the Plan had the following party-in-interest transactions for the year ended December 31, 2024, which related to direct fees paid by the Plan for the Services noted:

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Additionally, certain administrative expenses such as audit and legal fees are paid by the Company at its discretion.

**NOTE 6 PLAN TERMINATION AND AMENDMENTS**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Company also has the right to amend any or all provisions of the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and the net assets of the Plan would be allocated among the participants and beneficiaries of the Plan in the order provided for by ERISA.

**Notes to Financial Statements**

**NOTE 7 INCOME TAX STATUS**

The Plan has adopted a prototype defined contribution plan which the IRS has determined and affirmed, in a letter dated November 14, 2022, to be designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. Plan management have analyzed the tax positions taken by the Plan and concluded no uncertain positions have been taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 PROHIBITED TRANSACTIONS**

During the plan year, the Plan Sponsor failed to remit participant contributions totaling \$3,449 for the pay periods ended January 5, 2024 and January 15, 2024 in a timely manner. The contributions were deposited into the Plan on April 15, 2024 and April 16, 2024, a delay of 102 days.

This late remittance was a prohibited transaction under ERISA. The Plan Sponsor fully corrected this issue by remitting the original late contributions and an additional \$31 for lost earnings to the Plan in April 2024.
