1. DESCRIPTION OF PLAN

The following description of Veltek Associates, Inc. 401(K) Profit Sharing Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan, which was started on January 1, 1999, and restated on December 1, 2024, is a defined contribution, profit-sharing and deferred compensation 401(K) plan covering all full-time, non-union employees of Veltek Associates, Inc. (plan sponsor, located in Malvern, Pennsylvania) who have attained the age of 21 years. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Employee Contributions

Each year, participants may contribute up to 85 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

C. Employer Contributions

The sponsor contributes for each payroll period an amount equal to a specified percentage of the participant's base salary or a specified dollar amount. The Company contributes 100% of the first 4% of earnings contributed by participants.

At the end of the plan year, the sponsor, at the discretion of its Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of a participant's compensation to the total compensation of all eligible participants. To be eligible to receive an allocation of the discretionary profit-sharing contributions, you must complete 1,000 hours of service during the plan year and be employed on the last day of the plan year.

D. Participant Accounts

A participant's account is credited in each year with contributions and plan earnings, net of administrative fees. Allocations are based on participant account balances in the investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are immediately vested for their contributions and plan earnings attributed to their contributions. Participants are also immediately vested for the company match contributions.

F. Investment Options

The assets of the Plan are allocated among mutual funds and common/collective trusts accounts at the direction of the participant. The investment options that are available include a cross-section of money, stock and bond funds.

G. Payment of Benefits

Participants are eligible for distributions after employment termination, death or disability, as defined. At retirement, a participant may elect to receive a distribution in one lump-sum equal to the value of his or her account or in installments over a period not exceeding the anticipated life expectancy of the participant and/or any designated beneficiaries. At retirement, the plan reserves the right to pay in a lump-sum a participant's account balance that is less than or equal to \$1,000. If the balance in a participant's account is over \$1,000, but not in excess of \$7,000 upon termination, the amount will be transferred to an Individual Retirement Account outside the plan.

H. Forfeited Accounts

Amounts from forfeited nonvested accounts can be used to offset administrative expenses, restore forfeitures or reduce company contributions. Forfeitures amounting to \$3,082 and \$3,769 were applied toward administrative fees in 2024 and 2023, respectively. There were \$2,513 and \$0 in unused forfeitures for the year ended December 31, 2024, and 2023, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting, except for benefit payments which are reflected on a cash basis.

B. Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

B. Investments (continued)

Purchases and sales of securities are recorded on a trade-date basis, with related dividend and interest income recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's realized gains and losses on investments bought and sold, as well as unrealized gains/losses held during the year. Realized gains/losses are recognized using the average cost method.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, income, contributions, expenses and required disclosures. Accordingly, actual results may differ from those estimates.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their uncollected principal balances. Interest income is recorded when collected. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

E. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, when not otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation/depreciation in fair value of investments.

F. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025 the date on which the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Advisor Trust, Inc., the Plan's record keeper and agent for the custodian, Matrix Trust Company. 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

5. NOTES RECEIVABLE, PARTICIPANTS

Participant loans are permitted transactions from trust fund assets. Loans must be approved by the trustee and the plan administrator upon the participant submitting an application through the website or by contacting the Third Party Administrator. The security for the loan must be adequate in the opinion of the trustee. Interest is charged at the rate of prime plus 1%. Loans are at a minimum amount of \$1,000. The maximum amount of an outstanding loan could not exceed one-half the vested account balance. In addition, under no event could the loan amount exceed \$50,000. This possible maximum amount is reduced by the highest outstanding loan balance during the one-year period ending on the day before the date the loan agreement becomes effective.

6. DEFERRED BENEFITS PAYABLE

At December 31, 2024 and 2023, there were \$1,935,781 and \$227,805 in accounts included in the respective net assets available for benefits pertaining to deferred benefits of individuals who had withdrawn from participation in the plan.

7. RELATED PARTY TRANSACTIONS

Mid Atlantic Trust Company is the trustee who holds plan investments. Paychex, Inc. is the record keeper of these investments. The transactions qualify as party-in-interest transactions. Fees paid in 2024 by the plan for the related services amounted to \$4,885.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

9. RISK AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

10. TAX STATUS

The Internal Revenue Service has determined and informed the plan sponsor by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (Code). The Plan has been amended and restated when required. The Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes the plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by federal authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by the taxing authorities; however, there are currently no audits in progress for any eligible tax periods.
