**NOTE A - DESCRIPTION OF PLAN**

The following description of the Werk-Brau Co., Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General:** The Plan, as amended, is a defined contribution plan covering substantially all eligible employees of Werk-Brau Co. and Ballinger Industries, Inc., (the Company). The Plan was originally established June 30, 1975, and was amended and restated effective November 1, 2016, and January 1, 2019. The Plan was then amended on December 13, 2021, to implement the hardship distribution provisions of The Bipartisan Budget Bill of 2018 effective on the first day of the first Plan Year beginning after December 31, 2018. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). On January 1, 2023, the Plan name was amended to Werk-Brau Co., Inc. Employees' Retirement Plan reflecting the merger of Werk-Brau Co., Inc. and Fabco Inc. Effective February 1, 2023, the Plan was amended to increase the automatic deferral amount from 3% to 4%.

**Eligibility and Vesting:** Employees become eligible as participants in the Plan following six months of service and attainment of age 20.5. Eligible employees do not include employees who are nonresident aliens and who do not receive any U.S. source income from the Company. Any elective Salary Deferrals, Catch-up, Rollover or Transfer Contributions, plus or minus any earnings or losses, are 100% vested. Vesting of employer contributions is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants are credited with a Year of Service for vesting purposes upon completion of 1000 Hours of Service during the Plan year. Employees covered under a collective bargaining agreement (union) shall be eligible to make deferrals after meeting the eligibility requirements and share in matching employer contributions but are excluded from nonelective employer contributions. Union employees are not subject to the automatic salary deferral feature.

**Contributions:** Each year, participants shall be permitted to make elective deferrals in any amount up to the maximum percentage of eligible compensation and dollar amounts permissible under Internal Revenue Code Section 401(k). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an automatic salary deferral feature in which upon eligibility the Employer will automatically withhold 4% (3% through January 31, 2024) of compensation each payroll period. Participants may also contribute amounts representing distributions from other qualified plans or an IRA. Participants direct the investment of their contributions into various investment options offered by the Plan. Annually, for non-bargaining employees, the Company may make discretionary matching and profit-sharing contributions. Matching contributions are based on eligible participant elective deferrals. Profit sharing contributions are allocated to eligible participants based on their compensation to the compensation of all eligible participants. For the year ended December 31, 2024, the Company's discretionary matching and profit-sharing contribution amounted to \$670,659.

**NOTE A - DESCRIPTION OF PLAN (continued)**

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings (losses) and, (c) fees within the funds or loan fees for participants with loans. Plan earnings (losses) and fee expenses are allocated based on the participant's actual units held in the various funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed interest fund.

**Benefits Payments:** The Plan's normal form of payment for participants eligible to receive benefit distributions is a lump-sum payment. In certain cases, benefits are paid in installments based upon appropriate life expectancy values. The Plan also includes a provision for participants to make withdrawals from their account under certain "hardship" circumstances, subject to approval by the Plan administrator.

**Forfeitures:** Forfeitures are retained by the Plan and will be used to offset future employer contributions. The forfeited nonvested accounts totaled \$49,975 and \$30,002 for the years ended December 31, 2024 and 2023, respectively, with no forfeiture amounts being used during the years.

**Notes Receivable from Participants:** Participants may borrow from their account balance any whole dollar amount which must be at a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested interest in their account, reduced by the highest outstanding loan balance, if any, during the prior 12-month period. Loan terms range up to five years with the exception of a home loan which may exceed five years as determined by the Plan Trustees. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime interest rate. Interest rates range from 4.25% to 9.50%. Principal and interest is paid weekly or bi-weekly through payroll deductions. Participants may have one loan outstanding at a time.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation:** The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Investment Valuation and Income Recognition:** Investments are stated at fair value as reported by the Plan's custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the accrual basis on the ex-dividend date. Net appreciation(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Notes Receivable from Participants:** Note receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Allowance for Credit Losses - Notes Receivable From Participants:** The allowance for credit losses is a valuation account that is deducted from, or added to, the note receivables amortized cost basis to present the net amount expected to be collected on the loan. Loans are charged off against the allowance when management believes collectability of a loan balance is confirmed.

Management estimates the allowance balance using relevant available information, from internal and external sources, relating to past events, current conditions, and reasonable and supportable forecasts. Historical credit loss experience provides the basis for estimation of expected credit losses. Adjustments to historical loss information are made for changes in environmental conditions, such as changes in unemployment rates, collateral values, or other relevant factors. Management has determined there is no requirement to provide an allowance for credit losses because the loans are secured by the balance in the participant's account.

**NOTE C - PLAN ADMINISTRATION**

The Plan Administrator is Pentegra Services, Inc., a third-party administrator. The Great-West Trust Company, LLC is the Plan custodian and holds all plan assets and executes all plan transactions. Officers of the Employer serve as Plan Trustees.

**NOTE D - PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons. The Plan invests in certain funds of the Plan Custodian.

Administrative expenses paid to Empower amounted to \$43,834 for 2024. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan.

These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.

**NOTE E - INFORMATION CERTIFIED BY THE TRUSTEES AND CUSTODIANS**

The Plan Trustees have elected the method of annual reporting compliance permitted by 29 CFR 2520.108-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Trustees have received certification from the Asset Custodian that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Benefits and Notes to Financial Statements as of December 31, 2024 and 2023.
- Investment activity, as shown in the Statement of Changes in Net Assets Available for Benefits and Notes to the Financial Statements for the year ended December 31, 2024.
- The Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the Supplemental Schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, notes to financial statements, and supplemental schedule.

**NOTE F - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and are supported by little or no market activity and are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the methodologies used at December 31, 2024 and 2023. The Plan has no liabilities measured at fair value.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

**Group Annuity Contract:** Valued at fair value, which is contract value using a discounted cash flow valuation methodology where the interest rate for the portfolio investment contract is reset at least as frequently as annually. Contract values reported by the asset custodian are based on observable inputs and are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE G - GROUP ANNUITY CONTRACT**

The Plan has entered into a fully benefit-responsive investment contract with Great West Life & Annuity Insurance Company (Great-West). Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting interest rate is based on a formula established by the issuer, but may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. Furthermore certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment without the consent of the issuer. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE H - TAX STATUS**

The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Trustees believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt. The Plan believes it has no uncertain tax positions that would require recognition in the financial statements. Tax returns are filed in the U.S. federal jurisdiction with all open years being subject to examination. The U.S. federal statute of limitations is three years from the due date of the return.

**NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all amounts credited to their accounts.

**NOTE J - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued and has determined that there were no other events to be disclosed in the accompanying financial statements.

**NOTE K - RISKS AND UNCERTAINTIES**

The Plan invests in various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE L - CARES ACT AND SECURE ACT**

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), laws which change the Plan to, among others, allow certain eligible individuals to receive penalty-free withdrawals during 2020, suspend required minimum distributions for 2020, and delay the commencement date for required minimum distributions to age 72. Certain optional features within these acts have been assessed and have been implemented to date. Written amendments to the Plan to reflect these operational changes will be adopted on or before December 31, 2025.

The Plan will implement certain requirements by the Secure 2.0 Act of 2022, laws which change the Plan to, among others, delay the commencement date for required minimum distributions to age 73, requiring catch up contributions to be Roth, expands eligibility to long-term, part-time workers, increases the cash out limits from \$5,000 to \$7,000, and allowing certain eligible individuals to receive a penalty-free withdrawal of up to \$1,000 annually for emergency expenses. Written amendments to the Plan to reflect these operational changes will be adopted on or before December 31, 2025.
