Independent Auditor's Report

To the Board of Trustees of the
Western New York Teamsters 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Western New York Teamsters 401(k) Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(c) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements December 31, 2024 and 2023

Note 1 - Description of the Plan

The following description of the Western New York Teamsters 401(k) Plan (“Plan”) is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

General

The Plan, which was established May 1, 1996, is a defined contribution multiemployer profit-sharing plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all full-time employees who are covered by a collective bargaining agreement between participating employers and Teamsters Local No. 264 (“Union”). Participating employers consist of the Union, Upstate Niagara Cooperative, Inc. (“Upstate”), and Lactalis American Group, Inc. (“Lactalis”).

The Plan is administered by a Joint Board of Trustees consisting of members appointed by participating employers and the Union. The Plan utilizes American Trust Company to provide investment advisory services, administrative consulting services, and custodial services for the Plan’s participant-directed investments.

Participation

Employees of the Union and Upstate are eligible to participate in the Plan after 60 days of employment at a participating employer. Employees of Lactalis are eligible to participate in the Plan the first calendar quarter after six months of service.

Vesting

Participants are 100% vested in their account immediately upon their effective date of participation.

Contributions

Participant contributions are from employees of the Union and Upstate, made through voluntary salary reductions. Contributions for participants employed by Lactalis and Upstate are received from the employer under terms of their collective bargaining agreements with the Union. The Union also contributes to the Plan as an employer on behalf of its employees.

The Plan also allows for rollover contributions.

Participant Accounts

The Plan provides for participant-directed investments, and as such, an account has been established for each participant in the Plan. Each participant’s account is credited with the participant’s contributions and employer contributions contributed on their behalf. Such accounts are also credited/charged with the participant’s share of earnings or losses on his or her investments. Benefits paid to participants, or their beneficiaries are charged directly against the respective participant’s account. Administrative expenses are typically allocated proportionately to each participant; however, such expenses may be allocated as an equal dollar amount depending on the nature of the expense. Expenses incurred for or on behalf of a specific participant are charged directly to such participant’s account. Only participants with an account balance are eligible for benefits and only to the extent of such balance.

Participant loans are not allowed under the plan.

Normal Retirement Benefit

Normal retirement age under the Plan is age 55. Upon retirement, a participant may elect to receive either a lump-sum cash distribution or an annuity equal to the value of the participant's vested interest in his or her account, and/or a direct rollover distribution to a qualified plan. If a participant's account balance does not exceed \$7,000, the balance may only be distributed in a single lump-sum payment. If the participant's account balance is \$7,000 or more, and the participant is married on the date their benefits are to begin, they will automatically receive a joint and 50% survivor annuity unless a joint and 75% or 100% survivor annuity is elected. If a participant is not married, unless a lump-sum option is elected, the participant will automatically receive a life annuity.

The Plan also allows for partial distributions. No more than two withdrawals may be made from a participant's combined account in any Plan year.

Disability Benefits

In the event a participant becomes totally and permanently disabled, the participant is entitled to 100% of his or her account balance. Payment of such benefit will be made as if the participant retired.

Death Benefits

If a participant dies prior to his or her annuity starting date, and is married at the time of death, the surviving spouse is entitled to 100% of the participant's account balance. If a participant is not married at the time of his or her death or is married and has designated a beneficiary other than his or her spouse (with spousal consent), the designated beneficiary is entitled to 100% of the participant's account balance.

Death benefits will be paid in a single lump sum or in installments.

Hardship Withdrawals

The only time an advance withdrawal of an account is allowed is due to hardship. Hardship includes medical care expenses; costs directly related to the purchase of primary residence; funeral expenses for a family member; payment of tuition, related educational fees, and room and board expenses for the next 12 months of post-secondary education of the member or dependent; payments necessary to prevent eviction from or foreclosure on the mortgage of the member's principal residence; and expenses for the repair of damage to the member's principal residence that would qualify for the casualty deduction under the Internal Revenue Code.

A hardship distribution is limited to the salary deferral contributions to the Plan and not from earnings or the total amount of the hardship expense, whichever is less and will be made in a single lump sum payment.

Termination of Employment

A participant may elect to receive the vested benefit in his or her account before normal distribution date (retirement, disability, or death) but not until the anniversary date after the termination of employment. If the vested balance in the account is over \$7,000, written consent must be received before the distribution is made. If the vested balance is \$7,000 or less, there is no need for consent before distribution.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are stated on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on an ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Contributions receivable are evaluated based on analysis of subsequent employer remittances. Contributions receivable at December 31, 2024 and 2023, are not material to these financial statements.

Benefit Costs

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date these financial statements were available to be issued, for potential recognition or disclosure in the financial statements.

Note 3 - Termination

It is the present intention of the Trustees to continue the Plan indefinitely. The Trustees have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, the accounts of the participants shall immediately be fully vested and nonforfeitable.

Note 4 - Fair Value Measurement

ASC 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 4 (Continued)

Level 2: Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The Plan may invest in both closed-end mutual funds and open-end mutual funds. Closed-end mutual funds are valued at the closing price reported on the active market on which the individual securities are traded. Open-end mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Fully Benefit-Responsive Investment Contracts

The Plan is invested in the MetLife UTC Stable Value Trust Fund, which meets the fully benefit responsive investment contract criteria and therefore is recorded at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The holder of the investment contract is MetLife (an insurance company), and the contract is a “synthetic” investment contract. The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer (MetLife) to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts the Plan would own only the contract itself.

The synthetic investment held by the Plan includes a wrapper contract that provides a guarantee that the credit rate will not fall below 0%. The assets of the UTC Stable Value Trust Fund are invested in a MetLife separate account. MetLife will guarantee principal and accrued interest, based on credited interest rates, for participant-initiated withdrawals if the contract remains active. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. MetLife will reset the rate each quarter by amortizing the difference between the market value of the portfolio and the guaranteed value over the weighted average duration of the fund’s investments. Participants will receive the principal and accrued earnings credited to their accounts on withdrawal for allowed events. These events include transfers to other Plan investment options, and payments because of retirement, termination of employment, disability, death, and in-service withdrawals as permitted by the Plan.

Certain events limit the ability of the Plan to transact at contract value with MetLife. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

Note 6 - Financial Certifications

The following financial information relating to the Plan’s assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, have been derived from information provided by American Trust Company, the trustee, and have been certified by them as complete and accurate. The incorporation of this financial information in these financial statements and the supplemental schedule is based solely on their certification and has not been audited by independent auditors.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect amounts reported in the statements of net assets available for benefits.

Note 8 - Transactions with Related Parties and Parties-in-Interest

Related Party

The Plan reimburses the Union for a portion of salaries, payroll taxes, benefits for administrative services performed for the Plan by an employee of the Union, as well as for supplies and rent. Expenses allocated to the Plan are based on estimates prepared by Union management.

During the year ended December 31, 2024, the Plan paid a total of \$9,355 to the Union for the allocable expenses but was reimbursed \$10,147 for previously overpaid shared expenses. The reimbursement was reported as an offset against Administrative Expenses in the Statements of Changes in Net Assets Available for Benefits. During the year ended December 31, 2023, the Plan reimbursed a total of \$14,955 to the Union for its share of allocated expenses which included an allocable portion of cyber security costs incurred by the Union during 2023.

Party-in-Interest

American Trust Company serves as custodian for the Plan's participant-directed investments and provides administrative services to the Plan. The Plan's stable value collective trust investment is in the MetLife UTC Stable Value Fund, for which American Trust Company is responsible for the oversight of. Fees paid to American Trust Company amounted to \$141,691 and \$135,804 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expense.

Note 9 - Tax Status

The Plan and related trust were established under a prototype non-standardized plan that received a favorable tax determination letter from the Internal Revenue Service indicating the features of the Plan, as then designed, conform with the requirement of Section 401(k) of the Internal Revenue Code ("IRC") and is therefore exempt from Federal income taxes. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. Management believes that the Plan is no longer subject to income tax examination for the years prior to December 31, 2021.
