Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

1. Exercise professional judgment and maintain professional skepticism throughout the audit.
2. Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
3. Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
4. Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
5. Conclude whether, in our judgment, that there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

1. The form and content of the supplemental schedule, other than the information in the supplemental schedule that is agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
2. The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the PTC Alliance LLC Union Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The Plan is a qualified, defined contribution plan covering eligible employees of PTC Alliance LLC (the “Company”) who are participants in certain of the Company’s collective bargaining agreements. Eligibility differs among the collectively bargained groups that participate in the Plan. The Plan Administrator of the Company controls and manages the operation and administration of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

An eligible participant may elect to contribute any amount of pretax compensation up to the maximum amount allowed by law. In addition, in any calendar year in which a participant is age 50 or above, an additional “catch-up contribution” (limited to \$7,500 in 2024 and 2023) may be made. Participants direct the investment of all contributions into various investment options offered by the Plan. Company contributions vary based on specific locations. The Company provides a matching contribution at certain locations as specified in the Plan document with a minimum of 2% and a maximum of 8% of participants’ compensation. The Company also provides a non-elective contribution to participants at the Darlington and Alliance locations based upon hours worked, as defined for employees hired prior to October 29, 2007 and October 1, 2007, respectively. There is no vesting period for these contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and the Plan’s earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Company contributions and vesting thereof vary among the different collective bargaining agreements.

PTC Alliance LLC Union Retirement Savings Plan

Notes to Financial Statements (continued)

Benefits

Upon termination of service due to death, disability, or retirement, or if a participant's vested account balance is \$1,000 or less, they will receive a lump-sum payment. If the participant's vested account balance is greater than \$1,000 but does not exceed \$5,000, and the participant does not elect either to receive or to rollover the vested account, then the participant's vested account shall be paid as an automatic rollover into an individual retirement account designated by the Plan Administrator.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. No more than two loans may be approved for any participant in a one-year period and generally each loan is to be repaid over a period not to exceed five years. The loans bear interest at rates that range from 5.25% to 10.50%, which are commensurate with local prevailing rates at the time of issuance, as determined by the Plan Administrator. Principal and interest payments are made through payroll deductions.

All loan fees, such as service fees and late payment fees, are charged to the participant.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts may be applied to pay administrative expenses or be applied to reduce future Company contributions. As of December 31, 2024 and 2023, the forfeited balances available were not significant. Forfeitures used to offset administrative expenses and employer contributions were \$28,451 and \$15,844 for the years ended December 31, 2024 and 2023, respectively.

Notes to Financial Statements (continued)

Plan Termination

Although the Company has not expressed any intent to do so, it reserves the right to amend, modify, suspend, or terminate the Plan subject to the provisions of ERISA and applicable collective bargaining agreements. In the event the Plan terminates, participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting. The participants will be entitled to receive the net plan assets directly associated with their individual vested account balance.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation

Investments of the Plan include mutual funds and a collective trust. Shares of the various mutual funds held by the Plan are valued by the custodian at the quoted net asset values (“NAV”) of those shares, which are based on the fair values of the underlying net assets of the mutual funds. The Plan’s interest in the collective trust is valued based on information reported by the custodian using the audited financial statements of the collective trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

PTC Alliance LLC Union Retirement Savings Plan

Notes to Financial Statements (continued)

Benefit Payments

Benefit distributions are recorded when paid.

Administrative Expenses

Except for loan origination fees associated with notes receivable from participants and withdrawal fees associated with benefit payments, all expenses of maintaining the Plan are paid by the Company.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The levels of the fair value hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever applicable.

Level 2 – Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Notes to Financial Statements (continued)

Level 3 – Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- Registered investment companies are valued at Level 1.
- Common collective trust is based upon the units of the collective trust funds held by the Plan at year end times the respective unit value. The collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business fashion. The Plan's investment in the funds is not subject to any withdrawal restrictions, and distributions may be taken at any time. The Plan has no unfunded commitments relating to the funds at December 31, 2024 or 2023. The objective of the fund is to provide investors with a moderate level of stable income without principal volatility.

4. Related Party and Party-In-Interest Transactions

The Plan’s assets are administered under a contract with Principal Trust Company, (the “custodian”), party-in-interest as defined by ERISA. Contributions are held and managed by the custodian, who invests cash received. The custodian invests investment income and makes distributions. Administrative expenses of the custodian are paid by the Company.

Notes to Financial Statements (continued)

During 2024, the Plan paid a net transfer of \$227,315 to the PTC Alliance LLC 401(k) Plan which is included within net transfers of assets on the statements of changes in net assets available for benefits. During 2023, the Plan received a net transfer of \$9,624,708 from the PTC Alliance LLC 401(k) Plan. These transfers are because of changes in employee position or location along with an entire location unionizing during 2023.

Participants may borrow from their fund accounts and therefore these transactions also qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

5. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to tax examinations for years prior to 2021.

6. Information Certified by Custodian

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the custodian of the Plan has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The Plan's independent auditors' did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Reconciliation to Form 5500

The Department of Labor regulations [Reg. 2520.103-1(b)(3)] require the notes to the financial statements to explain any variances from accounting principles generally accepted in the United States of America or differences between the information reported in the statements and in the Schedule H. There were no material differences between the financial statements and the Form 5500.
