INDEPENDENT AUDITORS' REPORT

To the Trustee and Plan Administrator of the
Turner's Outdoors, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Turner's Outdoors, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Turner's Outdoors, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, are complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

Turner's Outdoors Inc. 401(k) Plan is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The Plan was adopted effective November 1, 2004 with a year end of December 31. Participating employers to the Plan include Turner's Operations, Inc. dba Turner's Outdoorsman and The Outdoor Entity Group, Inc.

In December 2020, the Plan was amended to include the employees of a newly created entity, The Outdoor Entity Group, Inc. Additionally, with this amendment, the plan sponsor was changed from Turner's Outdoorsman, Inc. EIN 20-5179071 to Turners Outdoors, Inc. EIN 20-2388389. The change in the plan sponsor prompted a change in the plan name from Turner's Outdoorsman 401(k) Plan to Turner's Outdoors, Inc. 401(k) Plan.

Effective July 1, 2022, the Plan was amended and restated to comply with various legislative and regulatory changes. The Plan Sponsor believes that the provisions under the new plan document are in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The following description of the Turner's Outdoors, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Eligibility and Participation

Each employee who is at least 18 years of age shall become eligible to participate after one year of employment, defined as the completion of at least 1,000 hours of service during the twelve-month period beginning on the date of hire or any plan year beginning after the date of hire. The entry date will be the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. For years 2017 and prior, the minimum age eligibility requirement was 21 years of age.

Effective October 1, 2024, the plan amended the eligibility requirements for elective deferrals to age 18 and one month of service, with no hours of service required. The eligibility requirements for safe harbor matching contributions and nonelective contributions will remain at age 18 and one year of service, with 1,000 hours of service required. The entry date will continue to be the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements.

Participants are eligible for the profit sharing contribution if they meet the eligibility requirements and are employed on the last day of the plan year.

Contributions

Participants may elect to defer up to 100% of eligible compensation annually. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to Internal Revenue Service (IRS) limitations.

The Company makes a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 4% of the participant's compensation.

Also each year, at its discretion, the Company may elect to make a profit sharing contribution to the Plan. There were no Company profit sharing contributions for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Vesting

Employees are 100% vested in all employee and employer safe harbor contributions. Participants are vested in the employer profit sharing contributions based upon the following schedule:

Participant Accounts

A participant's account is credited with the participant's contributions, allocations of (a) the Company's matching contribution, (b) an allocation of the Company's profit sharing contribution, and (c) an allocation of plan earnings. A participant's account is debited with an allocation of plan losses and charged with administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. Allocation of the Company's contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear a reasonable fixed rate of interest (as determined by the Company). Principal and interest is paid through payroll deductions.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. "Hardship" distributions, as outlined in the Plan, are permitted subject to the approval of the Company. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum cash distribution or in periodic installments. Benefits under the Plan shall be distributed solely from the assets of the Plan.

If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees of the administrative agent are paid by the participants. All other expenses related to the administration of the Plan, including fees of the independent public accountants, are paid by the Company. The investment options have certain management fees which reduce the overall return on assets. The net appreciation of assets is reflected net of these fees.

Forfeitures

As of December 31, 2024 and 2023, there was no balance in the forfeitures account. Forfeitures of non-vested plan sponsor contributions are retained in the Plan and may be used to pay plan expenses or reduce employer matching contribution.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIAN

Management, for the years ended December 31, 2024 and 2023, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (the asset custodian of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENT

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the applicable methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts

A daily unit of value is calculated after the close of the New York Stock Exchange by using the net investment factor (NIF) method. Under this method, the previous day's unit value is multiplied by the current day's investment factor to arrive at the new unit value. The NIF for each day is calculated by dividing the current day's mutual fund share price (NAV), plus any dividend or capital gains per share, by the previous day's mutual fund NAV, minus a daily expense factor, if any.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methods or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INSURANCE CONTRACTS

The Plan entered into a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company through the investment in the Fixed Option, a stable value fund. The contract offers a fixed interest investment option through the insurance company's general account and a number of variable investment options through an insurance company's separate account. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and will always equal or exceed the contractually guaranteed rate. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, less withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023 was \$415,332 and \$392,226 respectively.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS

The Company adopted a Non-Standardized 401(k) Profit Sharing Plan sponsored by One America Financial Partners, Inc. The IRS has determined and informed the Trustee by a favorable opinion letter dated November 30, 2020, that the Non-Standardized 401(k) Profit Sharing Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Non-Standardized 401(k) Profit Sharing Plan's opinion letter is being relied on by the Plan. The Plan has been amended since receiving the opinion letter. However, Plan management believes the Plan as designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by American United Life Insurance Company. American United Life Insurance Company is the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transaction. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) of fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan issues notes to participants which are secured by the balances in the participants' accounts. These transactions qualify as a party-in-interest transaction for which a statutory exception exemption exists.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan transitioned its Third-Party Administrator (TPA) and asset custodian services from OneAmerica to ADP.

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and concluded that there were no other events that require recording or disclosure in the financial statements as of December 31, 2024.
