The following description of the A & N Corporation 401(k) Plan, formerly known as A & N Corporation 401(k) Profit Sharing Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, established on January 1, 1989, and most recently restated August 15, 2024, is a defined contribution plan covering all eligible employees of A & N Corporation (the Company or Employer), as defined. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

All employees of the Company, as defined in the Plan agreement, are eligible to make elective salary deferrals and receive Company contributions on the first day of the month coinciding with or following attainment of age eighteen.

**Contributions**

Participants may contribute either pre-tax or after-tax Roth deferrals up to 100% of their eligible annual compensation, as defined in the Plan agreement, up to a certain statutory maximum, which is set by law each year. The Plan provides for the automatic enrollment of eligible participants at a deferral rate of 1% of eligible compensation, unless the participant elects a contrary salary deferral election. Thereafter, employee contributions will automatically increase every year by 1% until the deferral rate equals 4%. The Plan allows for certain additional catch-up contributions for employees over the age limits defined in the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company provides a safe harbor matching contribution equal to 100% of the first 4% of compensation that a participant contributes to the Plan. The Company may also provide a discretionary non-elective profit-sharing contribution to be allocated amongst eligible participants. Effective August 15, 2024, the Company may further provide discretionary additional matching contributions. If the Company makes a discretionary additional matching contribution, it will not apply to elective deferrals exceeding 6% of participant compensation, as defined. The Company did not elect to make a discretionary profit-sharing or discretionary additional matching contributions for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's and Company's matching contributions, and allocations of Company non-elective profit-sharing contributions, and the Plan's earnings and is charged with benefits payments and an allocation of the Plan's losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Transaction fees are charged directly to the accounts of the participants who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

Participants direct the investment of their accounts into various options offered by the Plan. Participants may change their investments periodically, as permitted by the Plan sponsor.

**Vesting**

Participants are immediately vested in their elective deferral contributions, rollover contributions, and Company safe harbor matching contributions, plus actual earnings thereon. Company discretionary profit-sharing and additional matching contributions, plus actual earnings thereon vest over a period of six years as follows:

1 Year	0%
2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years	100%

A participant will also be 100% vested in Company profit-sharing and additional matching contributions upon death, disability, or attainment of early retirement age, as defined.

**Forfeitures**

Any non-vested amounts remaining after the distribution of a terminated participant's vested account balance are forfeited. Amounts forfeited by participants may be used to pay Plan expenses or to reduce Company contributions. There were no unallocated forfeiture balances at December 31, 2024. Unallocated forfeiture balances at December 31, 2023 were \$31. During the year ended December 31, 2024, forfeitures of \$103 were used to pay Plan expenses.

**Notes Receivable from Participants**

Prior to August 15, 2024, participants could borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of a participant's vested account balance. Effective August 15, 2024, the borrowing limit was increased to \$1,000. Participants may have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. The period for loan repayment cannot exceed five years from the date of the loan unless it was used to purchase a principal residence, in which case it may not exceed 30 years. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination of employment, a participant with a vested balance greater than \$5,000 may receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a series of installments over time, or partial withdrawals of at least \$500. If the amount of the participant's vested balance is \$5,000 or less, the Plan will automatically distribute the vested balance in a lump-sum payment. Participants attaining the age of 59 ½ and participants who incur a disability may request an in-service distribution from their vested account balance at a minimum of \$500. Hardship withdrawals may be requested at a minimum amount of \$500 and are paid in one lump-sum upon approval.

Effective August 15, 2024, the Plan no longer limits the dollar amount for partial distributions, the minimum amount of hardship withdrawals was increased to \$1,000, and the Plan also provides various annuity options for participants. The Plan further provides for a mandatory distribution subject to automatic rollover to an individual retirement account if the participant's vested amount at termination does not exceed \$5,000 but is more than \$1,000.

**Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan agreement. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan are included in administrative expenses and certain investment-related expenses are included in net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits. Transaction fees for distributions are charged directly to the accounts of the participants who incur those fees. Any costs associated with the investment of a participant's account are charged to that participant.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments, with the exception of the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract is valued at contract value. Contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals and expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Delinquent notes receivable from participants are recorded as distributions based on terms of the Plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No material events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

**Note 3 - Information Certified by Reliance Trust Company and Sentry Life Insurance Company**

The following is a summary of the Plan’s financial information and data included in the Plan’s financial statements and supplemental Schedule of Assets (Held at End of Year), which was certified by Reliance Trust Company as of December 31, 2023, and for the period from January 1, 2024 to August 30, 2024 and Sentry Life Insurance Company (Sentry) as of December 31, 2024, and for the period from August 31, 2024 to December 31, 2024, as complete and accurate, as permitted by 29 CFR 2520.103 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan’s independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental Schedule of Assets (Held at End of Year).

**Note 4 - Fair Value Measurements**

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from, or corroborated by, observable market data by correlation of other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* At December 31, 2024, and for the period from August 31, 2024 to December 31, 2024, the Plan holds units of participation in pooled separate accounts which are valued daily at their accumulation unit value. Accumulation unit value is determined based on the net asset values (NAV) of the underlying funds, which are generally quoted in active markets, and the contract's separate account charges.

*Mutual Funds:* As of December 31, 2023, and for the period from January 1, 2024 to August 30, 2024, the Plan held investments in mutual funds valued as determined by quoted market price, which represents the NAV held by the Plan at year-end. The mutual funds held by the Plan were deemed to be actively traded.

*Common/Collective Trust:* As of December 31, 2023, and for the period from January 1, 2024 to August 30, 2024, the Plan invested in the Invesco Stable Asset Fund (the Fund). The Fund invests 100% of its assets in Class C units of the Invesco Stable Value Trust, which is composed primarily of fully benefit-responsive synthetic guaranteed investment contracts. The Fund is valued at the NAV of units of the collective trust. The NAV, as provided by the issuer of the Fund, is based on the fair values of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan was required to provide a 12-month irrevocable written notice of intent to redeem all or a portion of its participation in the Fund. There were no unfunded purchase commitments. The Fund files a U.S. Department of Labor Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity. Accordingly, certain disclosure requirements under FASB Accounting Standards Update 2015-12 with respect to investment strategies for investments measured using the net asset value practical expedient are not required in this report.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 - Guaranteed Investment Contract**

In August 2024, the Plan entered into a traditional fully benefit-responsive group annuity contract with Sentry. Sentry maintains the contributions in a general account guaranteed by the insurance company’s claims paying ability. The primary objective of the account is to provide a competitive fixed interest rate and investment security. Under the terms of the agreement, a crediting rate is established for amounts invested in the guaranteed fund based on a formula established by the contract issuer. The crediting rate is reviewed and reset on an annual basis.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) cancellation of the contract as a result of any of the following events; (a) the Plan fails to pay any expense charges as describe in the contract, (b) the Plan fails to provide Sentry with any information or contributions required under the contract, (c) the Plan is no longer a qualified Plan pursuant to Section 401(a) of the IRC, (d) the Plan fails to make contributions, over and above any expense charges, as described in the contract, totaling at least \$75,000 over a period of three consecutive contract years, and (e) there is complete or partial Plan termination, and (ii) more than 20% of the Guaranteed Fund assets are transferred out of the Guaranteed Fund during any 12-month period. Plan management does not believe that any events are probable of occurring that might limit the Plan's ability to transact at contract value with participants.

**Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 - Party-in-Interest Transactions**

The Plan's investments at December 31, 2024 are held and managed by Sentry. During the year ended December 31, 2024, the Plan also paid administrative expenses of \$4,035 to Sentry and the Plan's recordkeeper. These transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as exempt party-in-interest transactions.

**Note 8 - Tax Status**

The Plan adopted a non-standardized defined contribution pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. Upon the restatement effective August, 15, 2024, the Plan received a favorable opinion letter dated June 30, 2020. The opinion letters stated that the Plan was designed in accordance with applicable sections of the IRC. The Plan has been restated since receiving the rulings. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will be 100% vested in their account balances.

**Note 10 - Non-Exempt Transactions**

During the Plan year ended December 31, 2023, the Company did not remit certain employee deferrals and loan repayments within the appropriate time period prescribed by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is currently in the process of taking the appropriate steps to correct these late remittances, including restoring lost earnings.
