## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Catholic Eldercare 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

Because of the unavailability of records prior to January 1, 2009, we were not able to perform sufficient auditing procedures with respect to the participants' individual account balances accumulated from the inception of the Plan and the distributions to terminated participants. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

## **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Line 4i Schedule of Assets Held at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

NOTES TO FINANCIAL STATEMENTS

### 1. Plan description:

The following description of the Catholic Eldercare 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Catholic Eldercare, Inc. (the Organization) established the Plan to provide employees with a systematic means of saving and investing for the future.

#### Eligibility:

All employees of the Organization are eligible to enroll on their date of hire.

#### Plan contributions:

Participants may contribute from 1% to 100% of their base pay by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. The Organization has a discretionary match of 40% of employee contributions up to 4% of base pay per payroll period. Also, the Organization may contribute a discretionary non-elective employer contribution to the Plan on behalf of all eligible employees.

#### Participant accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's matching contribution, (b) Plan earnings (losses) and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined.

#### Investment options:

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into various investment account options offered by the Plan.

#### Vesting:

Participants are immediately vested in their voluntary contributions and the Organization's discretionary matching contributions and actual earnings thereon.

#### Benefits paid to participants:

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum or installments.

The Plan makes involuntary distributions to terminated employees' whose plan balances are \$5,000 or less.

**2. Summary of significant accounting policies:**

## Participant loans:

The Plan does not permit participant loans.

## Participant investment rollovers:

Participants are allowed to transfer or rollover funds into the Plan from other qualified retirement plans.

## Use of accounting estimates and basis of accounting:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

## Accounting for uncertainty in income taxes:

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Organization has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate regulatory authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Contributions:

Contributions from employees and the Organization are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

### 2. Summary of significant accounting policies (continued):

#### Payment of benefits:

Benefits are recorded when paid.

#### Expenses:

Fees for the Plan's administration may be charged to the Plan, unless otherwise paid by the Plan Sponsor. Significant plan administration costs are absorbed by the Plan Sponsor. In 2024 and 2023, certain expenses such as custodian and administration fees from the custodian and third-party administrator were paid by the Plan. Investment related expenses are included in net appreciation/ depreciation in fair value of investments.

#### Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Concentrations:

At both December 31, 2024 and 2023, approximately 24% and 31% of investments were held in two and three funds, respectively.

#### Subsequent events:

Management has evaluated for subsequent events through October 9, 2025, the date the financial statements were available for issuance.

### 3. Information certified by Alerus Financial:

The following is a summary of the Plan's asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Alerus Financial, the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator, by the custodian, related to the following assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

Alerus Financial also certified to the completeness and accuracy of \$965,311 and \$1,168,545 of net appreciation in fair value of investments, \$513,439 and \$326,582 of dividends and \$1,062 and \$531 of interest related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

4. Stable value fund:

The Plan has a stable value fund called the Prudential Guaranteed Income Fund (the Fund), which is designed to provide safety of principal, liquidity, and a competitive rate of return. The Fund invests in a broadly diversified, fixed income portfolio within Prudential’s general account, which is primarily invested in public bonds, commercial mortgages and private placement bonds. Principal and accumulated interest are fully guaranteed by Prudential.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fund is included in the financial statements at fair value, estimated using net asset value per share, as reported to the Plan by Prudential. Net asset value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at net asset value. The Fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The net crediting rate is guaranteed for six months. Since the stable value funds can’t be transferred for 90 days to competing funds as defined by the Fund restrictions, the Fund does not qualify as fully benefit-responsive.

5. Fair value measurements:

ASC No. 820, *Fair Value Measurements and Disclosures* (ASC 820), establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

5. Fair value measurements (continued):

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value fund:* Valued at the NAV practical expedient of shares held by the Plan at year end determined in accordance with a valuation methodology adopted by the fund. (See Note 4)

The Plan document used by the Plan obtained its volume submitter plan advisory opinion dated March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

There were no Plan amendments or restatements in 2024 or 2023.

Although the Plan has been amended since receiving the advisory opinion letter, the Plan Administrator believes the Plan used by the Organization is designed and operating in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and tax-exempt.

**7. Party-in-interest:**

---

As described in Notes 2 and 3, the Plan utilizes service providers. Such parties are parties-in-interest under ERISA. The Plan's custodian, as defined by the Plan, also provides recordkeeping services and received direct fees related to this, which is included in administrative expenses in the statement of changes in net assets available for benefits. Additionally, the Plan's custodian received indirect fees from the Plan related to the investments and these are included in the net appreciation/depreciation in fair value of investments in the statement of changes in net assets available for benefits.

**8. Plan termination:**

---

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.
