### Report on the Audit of the Financial Statements

We have performed audits of the accompanying financial statements of Edco Products, Incorporated 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Edco Products, Incorporated 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally established by Edco Products, Incorporated (the Company) effective January 1, 1990. The Plan has been amended throughout the years to comply with tax legislation. The Plan covers employees of the Company and Edcoat, LLC (participating Employer). The Plan excludes nonresident aliens, leased employees, union employees, seasonal employees and interns. The Plan is subject to the provisions of ERISA, as amended. The Plan trustees are responsible for the oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

**Eligibility**

Employees are eligible to participate in the salary reduction, Company safe harbor contribution, Company discretionary matching contribution, and Company discretionary profit share contribution portions of the Plan monthly following or coinciding with the completion of three months of service and attaining age 18.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have up to 100% of their compensation withheld as pre-tax 401(k) or after-tax Roth contributions to the Plan. Participants aged 50 or older are allowed to make catch-up contributions. The Plan includes an automatic deferral arrangement whereby participants will be auto enrolled at 2% for deferrals, unless otherwise elected. Automatically enrolled participants will have their deferrals increased by 1% each Plan year up to a maximum of 10%, unless otherwise elected.

Subsequent to year-end, the Plan was amended effective January 1, 2025 to clarify auto enrollment and auto increase dates.

The Plan includes a nonelective safe harbor contribution provision whereby eligible participants will receive a contribution equal to 3% of eligible compensation. The Plan also includes a Company discretionary matching contribution that will be allocated under a uniform percentage using a tiered structure, but not to exceed 4% of eligible compensation. The approved discretionary match for 2024 and 2023 was 2% of eligible compensation.

The Company may also elect to make a discretionary profit sharing contribution. The discretionary contribution is allocated to employees' account in the same ratio as each participant's compensation bears to the total of such compensation of all participants. The approved contribution rate in 2024 and 2023 is 10% of eligible compensation.

**Contributions**

Participants who do not complete 480 hours of service during the Plan year or are not employed on the last day of the Plan year for reasons other than death, disability, or retirement shall not share in the allocation of the Company discretionary profit sharing contribution.

Participants are permitted to contribute funds that are received from other qualified plans. Contributions are subject to limitations set by the Internal Revenue Service (IRS).

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's safe harbor, discretionary matching, and profit sharing contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. Participants direct the investment of contributions into various investment options offered under the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Benefit Payments**

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Under the terms of the Plan, distributions from the Plan will be made upon a participant's termination, retirement, or death in the form of a lump sum or partial withdrawal. Participants are eligible for early retirement upon attainment of 55 years of age and seven years of service. Participants who terminate with a vested account balance of less than \$7,000 (\$5,000 prior to 2024) will have their account balance automatically distributed. In-service distributions while employed are allowed provided the participant has reached age 65 and has been a participant in the Plan for at least seven years.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000. The maximum amount is also limited to 50% of their vested account balance or 100% of their deferral account, whichever is less. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 2.00% (1.00% when note is used towards the purchase of a primary residence). Principal and interest is paid ratably through payroll or ACH deductions.

**Vesting**

Participants are fully vested in their deferral contributions, Company safe harbor contributions, Company discretionary matching contributions, and earnings thereon. Participants are fully vested in all contributions upon death, disability, or normal retirement.

Company discretionary contributions (other than safe harbor contributions and discretionary matching contributions) are subject to a graded vesting schedule based on years of service as follows:

**Forfeitures**

Forfeitures of Company discretionary contributions are used to reduce Company contributions or used to pay Plan expenses. There were unallocated forfeitures of \$133,659 and \$71,998 at December 31, 2024 and 2023, respectively. Forfeitures of \$72,031 and \$28,231 were used to reduce Company contributions during 2024 and 2023, respectively. Forfeitures of \$5,544 and \$9,510 were used to pay Plan expenses during 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of revenue and expense during the reporting period. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced, and a benefit payment will be recorded at the time the participant incurs a distributable event.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Minnesota Life Insurance Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefits for the year then ended.

The Standard Insurance Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued daily at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions may occur daily.

*Insurance Company General Account:* The insurance company general account is not fully benefit-responsive and is stated at fair value which approximates contract value. The fair value of the general account is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

**NOTE 5 INSURANCE COMPANY GENERAL ACCOUNT**

The Plan entered into an investment contract with Minnesota Life Insurance Company (Minnesota Life). Minnesota Life maintains certain contributions in a general account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by The Standard. The contract is not fully benefit responsive due to participant transfer restrictions. There are no reserves against fair value for credit risk of the contract issuer or otherwise. Upon termination of this investment contract, the lump sum liquidation value of the general account portion of the participant's accumulation value shall be equal to the product of (a) the participant's general account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date, and (b) a market value adjustment percentage. The average yield and crediting yield for 2024 and 2023 was 2.31% and 2.39%, respectively for new transfer funds and 2.29% and 2.10%, respectively, for renewal funds.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan subject to provisions of ERISA. Upon termination of the Plan, all participant accounts will become 100% vested.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

The investments are held by The Standard Insurance Company (The Standard), the qualified institution. Therefore, all transactions qualify as party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment as they may be offset with revenue sharing credits, rather than a direct payment.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter, received from the IRS on the pre-approved plan indicating the pre-approved plan is qualified under Section 401 of the Internal Revenue Code (IRC) and therefore is not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
