### **1. Plan Description**

The Guardian Bus Company, Inc. 401(k) Plan (the “Plan”) is the 401(k) plan for Guardian Bus Company, Inc. and Professional Bus Service Maintenance, Inc. (collectively the “Company”). The following description provides only general information. The Plan document should be consulted for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan with a 401(k) feature covering all employees of the Company. Employees are eligible to make elective deferrals and receive employer contributions on the first day of the calendar quarter following their completion of one year of service (consisting of 1,000 hours of service within one employment year). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Subsequent to year end, the Company contracted Empower Trust Company as the third-party administrator for the Plan.

#### ***Contributions***

Each year, participants may contribute eligible pretax compensation, as defined by the Plan, up to the maximum allowed by law. Participants may also contribute distributions from other qualified plans (rollovers) excluding those from a designated Roth account. The Plan provides for the Company to make a matching contribution equal to 50% of elective deferrals up to 5% of eligible compensation. An additional contribution for collectively bargained drivers and escorts at the current rate of \$2.75 / day is paid to participants for each day worked during the payroll period. All contributions are participant directed and can be redirected daily. The Plan was amended as of January 1, 2024 to allow Roth elective deferral contributions

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s matching and allocations of discretionary contributions and Plan earnings and charged with the participant’s withdrawals or distributions and an allocation of administrative expenses. Allocations are based on participant account balances as defined. The benefit to which a participant is entitled is the participant’s vested account.

#### ***Vesting***

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Participants’ vesting of Company contributions plus actual earnings thereon is based on years of service. A participant vests 20% after one year of credited service and each year thereafter, until 100% vested after five years of credited service. Upon death, disability, or retirement, as defined by the Plan document, a participant will become fully vested.

### **1. Plan Description (*continued*)**

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans require repayment within no more than 5 years, or up to 30 years if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest must be paid ratably through payroll deductions or otherwise in at least equal quarterly installments.

#### ***Payment of Benefits***

Upon termination of service due to disability or retirement, a participant, or his or her beneficiary, may elect to receive one of the following forms of payment equal to the value of the participant's vested interest in his or her account: 1) Lump sum; 2) Life annuity; 3) Survivor annuity; or 4) partial distribution. In those cases where the vested balance, excluding rollovers, is less than \$5,000, a participant will receive the value of the vested interest as a lump sum distribution. The Plan was amended as of January 1, 2024 to increase the automatic distribution amount to \$7,000. Death benefits paid to a beneficiary will be paid in a lump sum distribution.

#### ***Forfeited Accounts***

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$2,281 and \$1,693. Forfeitures will be used to reduce administrative expenses, reduce employer contributions or reallocated to participants' accounts. For the year ended December 31, 2024, forfeitures in the amount of \$1,676 were used to offset employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan’s investments are stated at fair value. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants or beneficiaries are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date October 6, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

### 5. Common/Collective Trusts

The Plan offers 13 common/collective trusts called the Principal LifeTime Hybrid Funds and Stable Value Fund (“Funds”). The NAV per unit of each of these Funds is determined on a daily basis. Units are issued and redeemed at their NAV per unit. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the NAV per unit. There are no redemption restrictions on these funds. The Plan has no unfunded commitments to these funds at December 31, 2024 and 2023.

### 6. Party-In-Interest Transactions

All investments of the Plan are managed by Principal Life Insurance Company, Principal Trust Company, or Principal Global Investors Trust Company, all of whom are members of Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 7. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype plan document preparer by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

### 7. Tax Status (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. In the case of a partial termination, only those who separate from service will become fully vested.

### 10. Prohibited Transactions

For the 2024 and 2023 plan years, the Employer failed to remit to the Plan certain participants' contributions and loan repayments within the period prescribed by the Department of Labor plan asset regulations totaling \$4,259 and \$467. Delays in remitting the contributions and loan repayments to the Plan were due to administrative issues. The Employer has made the necessary corrections to satisfy both the Department of Labor and IRS guidance for the 2023 amounts in 2024. ### **11. Risks and Uncertainties**

The Plan invests in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
