**NOTE 1 DESCRIPTION OF PLAN**

The following description of BH-SD Opco, LLC dba Alvarado Parkway Institute Behavioral Health System 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution savings plan under Section 401(k) of the Internal Revenue Code, which covers all employees of BH-SD Opco, LLC dba Alvarado Parkway Institute Behavioral Health System and BH-SD Social Rehab, LLC (collectively, the "Company") who are at least 18 years of age, and have provided at least three months of service. The plan is a subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees employed at the Company on January 1, 2001 are eligible to participate in the Plan, regardless of whether or not they meet the other requirement.

CONTRIBUTIONS

Participants may contribute up to 100 percent of their salaries to the Plan up to the Internal Revenue Service annual maximum limit of \$23,000 and \$22,500 for 2024 and 2023, respectively, (\$30,500 and \$30,000, respectively, for participants age 50 or older). Participants may rollover or transfer amounts from other plans. The Company may make a discretionary contribution. Rollover amounts into the plan were \$4,038 and \$60,195 for 2024 and 2023, respectively.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution (subject to vesting), if any, and the Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in participant's accounts, for discretionary contributions are based on years of service, is as follows:

After 1 year of service	20%
After 2 years of service	40%
After 3 years of service	60%
After 4 years of service	80%
After 5 years of service	100%

A participant also attains full vesting due to death, permanent disability, or reaching early retirement age as defined by the plan.

INVESTMENT OPTIONS

Upon enrollment into the Plan, participants may direct their account balances in any investment alternatives approved by the trustees, including but not limited to savings and/or money market funds, and mutual funds. Subsequently, participants may change their allocations and transfer account balances among the investment options offered by the Plan. All earnings and losses on the directed investments are credited directly to the participants' accounts.

PAYMENT OF BENEFITS

Vested benefits are payable in one lump-sum distribution of the entire account balance or in a payment of a portion of the account balance.

For purposes of determining whether or not a withdrawal is being used to provide benefits in accordance with the Plan document, the term "benefits", as defined in the plan document, is limited to amounts becoming payable to the participant due to:

- (A) termination of employment
- (B) retirement
- (C) disability
- (D) death
- (E) in-service distributions
- (F) hardship

Withdrawals for reasons other than those listed above are allowed but may be subject to certain charges and adjustments.

In the event of a mandatory distribution greater than \$1,000, but no more than \$5,000, in accordance with the payment provisions of the Plan, if the Participant does not elect to have such distributions paid directly to an eligible retirement plan specified by the Participant in a direct rollover or to receive the distribution directly under any form of payment allowed under the Plan, then the distribution will be paid in a direct rollover to an individual retirement plan designated by the plan administrator. Mandatory distributions of \$1,000 or less will be paid in cash as directed by the plan administrator, unless the Participant elects a direct rollover or elects to receive the distribution under another form permitted by the Plan.

NOTES RECEIVABLE FROM PARTICIPANTS

A participant may borrow from their 401(k) account. The amount of the loan may not exceed the lesser of \$50,000 or one half of the participant's vested account balance. In addition, a participant may not receive a loan of less than \$1,000 nor may a participant have more than two participant loans outstanding at any time. The loans are secured by the balance in the participants' account and bear interest at a rate for similar loans from commercial lending institutions.

FORFEITED ACCOUNTS

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$- and \$691, respectively. These accounts are used to reduce fees and offset employer contributions. No forfeitures were used during the years ended December 31, 2024 and 2023.

ADMINISTRATIVE EXPENSES

Most of the Plan's administrative expenses are paid by the Plan Sponsor. Amounts totaling \$43,127 and \$39,591 were paid directly by the Plan for administrative fees for the years ended December 31, 2024 and 2023, respectively. Certain investment related expenses are included as a reduction of investment return and are not separately reflected. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting - The accompanying financial statements have been prepared using the accrual method in conformity with generally accepted accounting principles (GAAP) in the United States of America.

Use of estimates - The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments valuation and income recognition - Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in pooled separate accounts and common/collective trusts are valued at net asset value (NAV) as a practical expedient of fair value. The NAV is based on the underlying investments, which are traded on an active market. Fully benefit-responsive investment contracts are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined-contribution plan are required to be reported at fair value unless fully benefit-responsive. The Fixed income guaranteed option is fully-benefit responsive and is required to be disclosed at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value measurement - The Plan follows accounting standards consistent with the FASB Codification which defines fair value, establishes a framework for measuring fair value and enhances disclosures about fair value measurements for all financial assets and liabilities.

Credit Losses - The Plan follows standards applicable to accounting for credit losses, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The measurement of expected credit losses under the current expected credit loss methodology is applicable to trading receivables, financing receivables, held-to-maturity debt securities, and receivables relating to repurchase agreements and securities lending agreements. It also applies to off-balance sheet credit exposures not accounted for as insurance (loan commitments, standby letters of credit, financial guarantees, and other similar instruments) and net investments in leases recognized by a lessor in accordance with Topic 842 on leases.

Notes receivable from participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest accrues according to loan agreements throughout the term of the loans. Management regularly reviews the collectability of the delinquent loan balances and records an allowance based on circumstances of the individual's underlying loan. Uncollectible loans are written off against the participant's balance at the time the participant leaves the Plan. Participant loans are reported net of an allowance of \$0 at December 31, 2024 and 2023.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The pension plan is tax exempt under the Internal Revenue Code Section 401(a) and consequently pays no income tax.

The Plan obtained its latest determination letter on March 31, 2015 in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards for uncertainty in income taxes recognized in the Plan's financial statements and prescribes a recognition threshold and measurement attribute for the financial statement recognition and measurement of a tax position taken or expected to be taken in a tax return. It also provides guidance on derecognition and measurement of a tax position taken or to be taken in a tax return. Accordingly, the Plan has not accrued interest or penalties related to uncertain tax positions.

**NOTE 3    PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time with respect to all participants by the adoption of an appropriate resolution by its owners. In the event of a complete termination of the Plan, the rights of all participants in their account balances shall, as of the date of the termination, be fully vested and not subject to forfeiture.

**NOTE 4 INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEES**

The Plan has obtained a certification from Principal Life Insurance Company (“Trustee”) that all of the information provided to the Plan by the Trustee is complete and accurate. The Trustee certification applies to substantially all of the Plan’s investment assets, transactions, and supplemental schedules. The Trustee reports such information primarily on a cash basis while the accompanying financial statements and supplemental schedules are presented on an accrual basis. Therefore, certain amounts reflected in the financial statements and supplemental schedules may differ from the information certified by the Trustee.

The following is information prepared and certified by Principal Life Insurance Company as of and for the years ended December 31, 2024 and 2023.

**NOTE 5 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract with Principal Life Insurance Company that is operated as a fixed income guaranteed option. Principal Life Insurance Company Plan maintains contributions in an unallocated account which is part of the general assets of trustee. The contract is included in the financial statements at contract value as reported to the Plan by the trustee during the years ended, December 31, 2024 and 2023. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contracts at December 31, 2024 and 2023 was \$14,486 and \$52,114, respectively. The average yield of the fixed income guaranteed option was 1.52% and 2.38% during the years ended, December 31, 2024 and 2023, respectively. The crediting interest rate was 1.55% and 2.38% at December 31, 2024 and 2023, respectively. The crediting interest rate is based on the rate in effect when money is deposited in the account.

Certain events limit the Plan's ability to transact at contract value with the trustees. Such events may include but are not limited to the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the occurrence of an event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable. The investment contract does not permit Principal Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 COMMON-COLLECTIVE TRUST**

During 2024 and 2023, the Plan held interests in multiple Principal LifeTime Hybrids CITs (the "Funds"). The Funds are a commingled pool of the Principal Global Investors Trust Company for Employee Benefit Plans and managed by Principal Global Asset Allocation. The assets of the funds are invested in fixed income securities, shares of money market funds, future contracts, option contracts, and swap agreements. The Funds may also invest in investment contracts offered by insurance companies and other approved financial institutions. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries. Although it is the policy of the management company to use its best efforts to maintain a stable NAV, there is no guarantee that the management company will be able to maintain that value. The Funds are credited with earnings on the underlying investments and charged for participant withdrawals and administrative fees.

**NOTE 7 FAIR VALUE MEASUREMENT**

The Plan follows fair value measurement accounting standards to value its financial assets and liabilities. Fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three broad levels has been established, which are described below:

Level 1: Quoted prices (unadjusted) in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2: Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets; or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3: Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which level 1 inputs were not available. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The Plan's policy is to recognize transfers of investments into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers of investments into or out of level 3.

Mutual funds are valued at quoted market prices in an exchange and active market, which represent the net asset values held by the Plan at year end and are classified as Level 1 investments.

Common collective trusts ("Trusts") are valued at net asset value (NAV) as a practical expedient of fair value. The NAV is calculated by the trusts based on the underlying investments, which are traded on an active market. The plan does not have any common collective trusts with unfunded commitments or with any redemption restrictions. There is no redemption notice period for the individual participants within the Plan.

Pooled separate funds accounts ("Fund") consist of stocks and mutual funds. The underlying securities are valued at NAV as a practical expedient of fair value. The NAV is by the Funds calculated based on the underlying investments, which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There are no plan assets requiring the use of level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.
