NOTE 1 – DESCRIPTION OF THE PLAN:

The following description of the Harte Auto Group 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established on May 30, 2015, available to all employees, excluding nonresident aliens, interns, and residents of Puerto Rico, of George Harte Nissan, Inc., Harte Infiniti, Inc., Harte Family Motors, Inc., Harte Properties, Inc., Harte Enterprises, Inc., and George Harte Infiniti, (collectively, the Company or Plan Sponsor) who have completed six months of service and are age 18 or older. Participants are eligible to participate on the first of the month coinciding with or next following the date requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The plan administrator oversees governance of the Plan. The plan administrator, along with the custodians, also determines the appropriateness of the Plan's investments and monitors investment performance.

Participant Contributions and Investment Options:

Participants may voluntarily contribute a percentage of their pre-tax and post-tax annual eligible compensation as limited by the Internal Revenue Code (the Code) and as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan features an auto enrollment feature, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rates set at 4% unless otherwise elected by the participant. The Plan includes an automatic escalation provision in which deferral amounts are increased 1% each year up to a maximum of 10%.

Participants direct the investment of their accounts into various investment options offered by the Plan with various objectives and degrees of financial risk. The Plan currently offers mutual funds, common/collective trusts and a fully benefit-responsive investment contract as investment options for participants.

Employer Contributions:

Each year, the Plan Sponsor makes a matching contribution equal to 25% of the participant's elective deferral up to a maximum of 4% of participant's compensation. The Plan Sponsor may also make a discretionary non-elective profit sharing contribution to the Plan. This contribution, if made, would be allocated to all employees eligible to contribute to the Plan. There were no non-elective profit sharing contributions made to the Plan for the years ended December 31, 2024 and 2023.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued):

Participant Accounts:

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as an allocation of the Company's discretionary nonelective profit sharing contribution, if any. Participant accounts are also credited with an allocation of investment earnings or losses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Unit Values:

Participants do not own specific securities or assets in the various funds, but have an interest represented by units within the account. Unit values are calculated on a daily basis.

Contributions to, and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit value as last determined, and the participant's accounts are charged or credited with the number of units properly attributed to each participant.

Vesting:

Participants are immediately 100% vested in their voluntary contributions and rollover contributions, including actual earnings thereon. Participants will become 100% vested in any matching and discretionary non-elective profit sharing contributions after three years of service. In addition, participants become fully vested upon death or total and permanent disability, as defined by the Plan.

Notes Receivable from Participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans are evidenced by written promissory notes for the amount of the loan, are secured by the participant's vested account balance and bear interest at rates which are commensurate with prevailing rates as determined by the plan administrator. Notes receivable are repaid over a period not to exceed five years, except when the use of proceeds is for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Participants may have two outstanding loans at any one point. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Code.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued):

Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,339 and \$3,021, respectively. Forfeitures typically represent unvested Company matching contributions and discretionary non elective profit sharing contributions, and are first used to pay Plan expenses and then to reduce future Company contributions. Plan expenses in 2024 and 2023 were reduced by \$8,232 and \$13,031, respectively, from forfeited nonvested accounts. No forfeitures were used to reduce employer contributions in 2024 or 2023.

Payment of Benefits:

Upon termination of service due to death, disability, retirement or other reason (all as defined), a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account balance, or to receive annual or more frequent installments over a period not to extend beyond the life expectancy of the participant, or beneficiary. All required mandatory distributions will be made as defined in the Plan and in accordance with federal law. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or due to hardship, as defined by the Plan. The Plan allows for in-service withdrawals for participants 55 years of age from fully vested employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates:

The preparation of financial statements in conformity with US GAAP requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of income and expense during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 6).

Investment Valuation and Income Recognition (continued):

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions in accordance with the provisions of the Plan. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and included in administrative expenses when incurred. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary at December 31, 2024 and 2023.

Payment of Benefits:

Generally, benefits are recorded when paid. As of December 31, 2023, there were benefits in the amount of \$27,433 requested before year end, that were paid after year end; as a result, these payments were included in benefits payable in the accompanying statements of net assets available for benefits.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Participant Contributions Payable:

Excess participant contributions payable represents payments due to certain active participants to return excess contributions in order to satisfy the relevant nondiscrimination provisions of the Plan. The Plan distributes the excess contributions to applicable participants prior to March 15th each year. There were no excess contributions for the year ended December 31, 2024. Excess participant contributions payable for the year ended December 31, 2023, totaled \$17,861.

Subsequent Events:

Management has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

Reclassifications:

Certain 2023 amounts have been reclassified to conform to the 2024 presentation. Such reclassifications had no material effect on the financial statements.

NOTE 3 – RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 – CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments (at fair value), fully benefit-responsive investment contract (at contract value), and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (Standard) and Charles Schwab Bank (Charles Schwab), qualified institutions and the custodians of the Plan.

NOTE 5 – FAIR VALUE MEASUREMENTS:

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, as of the measurement date. Authoritative guidance establishes a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

NOTE 5 – FAIR VALUE MEASUREMENTS (Continued):

The following summarizes the fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and therefore Level 1.

Common/Collective trust funds (CCT): Valued at the NAV of shares of the collective trust funds held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value, and is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities' liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3, respectively.

NOTE 6 – FULLY BENEFIT-RESPONSIVE CONTRACTS:

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Standard totaling \$583,195 and \$615,886 at December 31 2024 and, 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting interest rate for these contracts is reviewed on a quarterly basis for resetting by the issuer. The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 – FULLY BENEFIT-RESPONSIVE CONTRACTS (Continued):

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Standard. Such events include: (1) termination of the contract, (2) spin-offs, divestitures, layoffs, or corporate relocation, (3) partial or total plan termination, (4) retirement incentive programs, or (5) liberalization of plan withdrawal or transfer rules.

In addition, certain events allow Standard to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) contract owner's failure to abide by state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) plan disqualification, and (5) failure to adopt the plan in a reasonable period of time.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain plan investments are shares of mutual funds, common/collective trusts, and an investment in a fully benefit-responsive investment contract managed by Standard and Charles Schwab. Standard and Charles Schwab are the custodians of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 – PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are entitled to the entire amount of their employer contribution.

NOTE 9 – TAX STATUS:

The Plan is being operated under a prototype non-standardized profit-sharing plan and trust agreement which received an Internal Revenue Service (IRS) opinion letter, most recently amended June 30, 2020, stating that the form of the prototype is acceptable under Section 401(a) of the Code. Although the Plan has been amended since receiving its opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 10 – RECONCILIATION TO FORM 5500:

The differences between these financial statements and the Form 5500, if any, are immaterial.

NOTE 11 – DELINQUENT CONTRIBUTIONS:

During the years ended December 31, 2024 and December 31, 2022, the Company failed to deposit participant deferrals in the amount of \$63 and \$54, respectively, within the required timeframe as stated by the United States Department of Labor (DOL). DOL regulations require that employee contributions be transferred to the custodian as of the earliest date on which such contributions can be reasonably segregated from the employer's general assets. As of October 13, 2025, the Company is pending a corrective contribution to the participant's account for lost earnings on the delinquent contributions identified. The Company has taken corrective action to ensure future compliance with timely transmission of participant contributions to the trustee. The lost earnings have an immaterial effect on the financial statements and are included in employer contributions in the statements of changes in net assets available for benefits.
