Note 1. Description of Plan

The following description of the Always Compassionate Home Care Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 2020 (date of inception) and is a defined contribution plan covering all eligible employees of Always Compassionate Home Care Inc. (Company, Plan Administrator or Employer). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

Eligibility

Every employee age 21 and over is eligible to enter the Plan immediately upon meeting the eligibility requirements, as defined in the plan document. Employees who are covered by the New York State Home Care Worker Wage Parity Law are eligible to receive employer contributions. All participants are eligible to receive a matching contribution.

Participant Contributions

Participants in the Plan may contribute a discretionary amount of their compensation provided that the participant's contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (IRS) each year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to the Internal Revenue Code (IRC) defined maximum. Participants may also contribute amounts representing distributions from other qualified plans as rollover contributions. The Plan allows for participants to make Pre-tax, Roth, or a combination of both deferrals. The Plan also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The Plan was amended effective October 1, 2023 to eliminate the automatic deferral feature.

Employer Contributions

The Employer can make a contribution to each eligible employee as determined by the Employer to comply with the New York State Home Care Worker Wage Parity Law. The Employer is allowed to elect whether to make this contribution directly to the employee or as an employer contribution to the Plan. For the year December 31, 2024, the Employer did not make prevailing wage contributions to the Plan. The Employer may elect whether to make a discretionary matching contribution on behalf of eligible participants. There were no discretionary matching contributions in 2024 .

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer Contributions are 100% vested when paid. Discretionary matching contributions vest as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years of service	None
2 years but less than 3 years of service	20%
3 years but less than 4 years of service	40%
4 years but less than 5 years of service	60%
5 years but less than 6 years of service	80%
6 or more years of service	100%

Forfeitures

The portion of a participant’s account balance, which is not vested upon termination of employment or date of benefit payment, whichever occurs first, is forfeited and remains in the Plan. Forfeitures can be used to reduce employer contributions, or to pay allowable Plan expenses. There were no forfeitures during the year ended December 31, 2024. There was no balance in the forfeiture account as of December 31, 2024 and 2023 .

Notes Receivable from Participants

A participant may borrow from his or her account the lesser of \$50,000 reduced by the excess (if any) of the participant’s highest outstanding loan balance during the one-year period ending on the day before the loan is made over the existing loan balance on the date the new loan is made, or 50% of the participant’s vested account balance. The term of the loan cannot exceed five years unless the loan is used to purchase a principal residence. Participants are allowed to have one loan outstanding and no more than two loans shall be approved for any participant in any 12-month period. The loans are secured by the vested balance in the participant’s account and shall bear a reasonable rate of interest, as defined by the Plan. Repayment of loans must be made with level payments payable at least quarterly and through payroll withholdings. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024, the interest rate on outstanding loans was 4.25% to 9.50%.

Payment of Benefits

Benefit payments are permitted in the event of death, disability, termination of employment, a proven hardship, retirement, or attainment of age 59½ while still employed. A participant eligible for distributions will generally receive their vested benefit in a single lump-sum payment unless otherwise elected as allowed by the Plan provisions. Hardship withdrawals are available, as defined in the Plan.

Administrative Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid or reimbursed by the Employer. The Plan will allocate plan expenses among the accounts of Plan participants. The Employer will allocate these expenses either proportionally based on the value of the account balances or pro rata based on the number of participants in the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal or the Trustee), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Generally accepted accounting principles have established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds: Shares of mutual funds are valued using quoted market prices in an active market.

Pooled separate accounts: The fair value of the pooled separate accounts is determined by the fair value of the underlying mutual funds or stocks and fixed income securities. The fair value of the underlying securities is based on quoted prices of similar assets.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The guaranteed interest account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal. The contract is reflected in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is fully benefit- responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issue or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Principal. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investments options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under the *Employee Retirement Income Security Act of 1974*. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with the participants, is probable.

The guaranteed interest account does not permit Principal to terminate the agreement prior to the scheduled maturity date.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

Note 7. Party-In-Interest Transactions

The Plan invests in various pooled separate accounts managed by the Trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. For the year ended December 31, 2024, the Plan paid \$22,215, to the Trustee for administrative fees. During the year ended December 31, 2024, the Plan the investment advisor and recordkeeper \$20,800 and \$16,062, respectively.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Note 8. Tax Status

The Plan operates under a Non-Standardized Pre-approved Profit Sharing Plan with CODA. Principal has obtained an opinion letter from the Internal Revenue Service dated November 23, 2020 stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code (Code). Generally, the plan administrator and the Plan may rely on the opinion letter received as to the form of the Plan qualifying under the Code. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The plan administration has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
