**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Courtesy Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accounting records of the Plan are maintained on the accrual basis and are presented in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest and Dividend Income - Interest and dividend income is recorded when earned during the year.

Purchases and Sales of Securities - Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of securities is based on cost. Cost is the fair value at the beginning of the Plan year or historical cost if the security was purchased during the Plan year.

Payment of Benefits – Benefits are recorded when paid.

Estimates - The preparation of the financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Subsequent Events – The Plan has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

**NOTE 2 - PLAN DESCRIPTION**

The brief Plan description is provided for general information purposes only; for more complete information, the participants should refer to the Plan agreement.

The Plan is a defined contribution employee benefit plan covering substantially all employees of Courtesy Corporation who have met the eligibility requirements and elect to participate in the Plan. Initially adopted on January, 1, 2008 and restated January 1, 2022, this plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Effective January 1, 2022, Courtesy Corporation employees who are not considered highly compensated employees, are twenty-one years of age, have been employed twelve months and have completed at least 1,000 hours of service during the year, were eligible to participate in the Plan. The Company allows employees to enter the Plan on the first day of the plan year or the first day of the seventh month of the plan year.

Forfeitures – The Plan has no forfeitures as contributions are vested immediately.

Contributions - Under provisions of the Plan, participants may contribute up to 100% of their annual wages up to the maximum percentage allowable by Internal Revenue Code Sections 401(k), 402(g), 404 and 415. Participants direct their investment of contributions into various investment options. Each year, Courtesy Corporation can make discretionary contributions to the Plan equal to the percentage of each participants' elected salary deferral.

Vesting - Participants' accounts are vested immediately upon contributing.

**NOTE 2 - PLAN DESCRIPTION, continued**

Payments of Benefits - Upon termination of service of an employee, or in certain hardship cases, an employee may elect to receive benefits by a lump sum payout, a series of substantially equal periodic installments not to exceed the participant's life expectancy, or partial withdrawals, as described in the Plan provisions.

Loans - Participant loans are not permitted within the Plan.

Administrative Expenses - All administrative expenses may be paid out of the Plan unless paid by the Company. During 2024 and 2023, expenses were paid by both the Plan and the Company.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs rather than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

*Level 1 Fair Value Measurements*

The fair value of mutual funds and common trust accounts are based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2 Fair Value Measurements*

The fair value of these investments are determined by pricing data provided by outside valuation service providers who generally use the mean bid/ask prices but may also use alternative observable pricing inputs including discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

*Level 3 Fair Value Measurements*

The fair value of these investments are determined by inputs to the valuation methodology that are not observable and are significant to the fair value measurement.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2, or 3.

**Mutual Funds** - Mutual funds are valued at the daily closing price which represents the fair value of the shares held by the Plan at year end.

**NOTE 3 - FAIR VALUE MEASUREMENTS, CONTINUED**

Collective Trust Funds - Collective trust funds are valued at NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell its investments for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Certain investments that were measured at NAV have not been classified in the fair value hierarchy table presented below. The fair value amounts presented in the table are intended to permit the reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for plan benefits.

**NOTE 5 – COLLECTIVE TRUST FUND**

The Plan offers the Capital Preservation Fund which is collective trust fund. Collective trust funds are valued at the fair value the underlying investments/mutual funds. The Fund owns traditional and synthetic GIC, investment contracts, security backed contracts, fixed income securities, mutual funds and collective investment trusts; all with various crediting rate formulas. Fixed rate traditional GIC contracts have no reset and are deemed to remain at par. Monthly reset traditional GIC contracts are credited off of the one-month LIBOR rate and a rolling twelve-month Consumer Price Index (CPI). These contracts are reset monthly at a spread to their index and are deemed to be par. Monthly reset synthetic GIC contracts are credited off the internal rate of return, dollar duration, and dollar weighted duration of an underlying portfolio. The monthly reset contracts are maintained at contract value.

The underlying portfolios are priced at market value. As rates rise, the market value falls versus contract value. Crediting rates will rise with a lag due to reinvestment. As rates fall, the market value will rise versus the contract value. Crediting rates will fall with a lag due to reinvestment.

The Fund could be limited in its ability to transact with issuers at contract value if the Fund raises its risk profile or is subjected to an extended period of significant cash outflow. The Fund maintains cash, internal cash flow to offset cash withdrawals.

**NOTE 6 - ADMINISTRATIVE EXPENSES**

The Plan's sponsor pays certain plan administrative fees, audit fees, and ERISA bond coverage for the Plan. These expenses are not reflected on the statement of changes in net assets.

**NOTE 7 - INCOME TAX STATUS**

The Plan has received a determination letter, dated June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA.

Certain Plan investments are managed by TrustPoint, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$27,031 and \$23,663 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
