Note 1 - Plan Description

The following description of Univar Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a contributory, defined contribution 401(k) investment plan available to regular employees of Univar Solutions USA LLC (the Company). Nonresident aliens, leased employees, temporary employees, and independent contractors are not eligible for the Plan. Union employees are only eligible if coverage under this Plan is specified in their collective bargaining agreement. Employees are immediately eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Fidelity Management Trust Company serves as the trustee of the Plan and Fidelity Workplace Services LLC serves as the recordkeeper of the Plan (collectively referred to as Fidelity).

Plan Merger - The Company acquired Valley Solvent Company, LLC (formerly known as Valley Solvent Inc.) on February 29, 2024. Effective January 1, 2025, the Valley Solvent Company 401(k) Savings Plan (Valley Solvent Plan) was merged into the Plan. Assets transferred from the Valley Solvent Plan into the Plan subsequent to year end as a result of the merger totaled approximately \$4,386,000.

Contributions - Participants may elect to defer up to 75% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 6% deferral rate unless they elect a different deferral rate or not to participate in the Plan.

The Company makes a matching contribution equal to 100% of participants' salary deferrals up to 4% of eligible compensation. Employees covered by collective bargaining units may have different matching formulas as negotiated and outlined in their respective collective bargaining agreements. The Plan satisfies nondiscrimination safe harbor rules for all participants whose terms of employment are not covered by a collective bargaining agreement.

The Company also makes a nonelective retirement contribution equal to 4% of eligible compensation to participants employed by the Company on the last day of the plan year. The last day rule is waived for termination due to death, disability, or reaching age 65 while still employed with the Company. Certain employees covered by collective bargaining units may not be eligible to receive nonelective retirement contributions based on terms specified in their respective collective bargaining agreements.

Contributions are subject to limitations under the United States Internal Revenue Code (IRC) or Puerto Rico Internal Revenue Code.

Participant Accounts - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's nonelective contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Note 1 - Continued

Vesting - Any participant employed with the Company on or after January 1, 2003, shall be 100% vested in all employer contributions other than nonelective retirement contributions. Nonelective retirement contributions are subject to a three year cliff vesting schedule. The vesting schedule of participants in plans that were merged into the Plan may be subject to extended vesting schedules not to exceed six years.

Forfeitures - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$1,123,000 and \$581,000, respectively. During the year ended December 31, 2024, approximately \$1,018,000 of forfeited nonvested accounts were used in accordance with the provisions specified in the Plan document.

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive installment payments or a lump-sum distribution equal to the value of the participant's vested account. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates will bear a reasonable rate of interest within the meaning of 29 C.F.R. 2550.408b-1(e). Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Investment Management and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Company has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective Trust Funds - Collective trust funds held by the Plan are valued at the Net Asset Value provided by the funds' trustees. These funds trade on a regular basis, have a published price that the Plan can obtain at any time, and are valued based on this published price. Collective trust funds held by the Plan trade on private markets that are not active; however, the unit price is based primarily on observable market data of the funds' underlying assets.

Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain plan investments are managed by Mercer. Mercer is the Plan's investment advisor. Therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

Note 7 - Tax Status

The Plan obtained its latest determination letter on February 5, 2018, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
