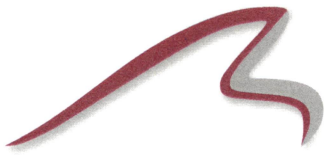

### NOTES TO THE FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN

The following description of the RKI, Inc. Employees' Profit Sharing & 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution retirement plan covering all non-union employees of RKI, Inc. dba Roll-Kraft (the Company). Eligible employees can contribute to the Plan on the pay date immediately following 30 days of service. In addition, employees become eligible to receive matching and discretionary employer profit sharing contributions after the completion of one year of service, as defined. Effective January 1, 2022, each eligible employee of the Company can become a participant in the Plan on the first entry date following the date the employee attains eighteen years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Administrator.

In recent years, the Plan has been amended to comply with the Heroes Earnings Assistance and Relief Tax (HEART) Act, the Worker, Retiree, and Employer Recovery Act (WRERA), and other Internal Revenue Service (IRS) and Department of Labor (DOL) guidance. The purpose of these changes was to comply with IRS and DOL regulations and maintain the Plan's tax-exempt status.

##### Contributions

Participants may elect to contribute their eligible compensation plus additional catch-up contributions on a pre-tax basis, subject to IRS limitations for the Plan year. The Plan also permits rollover contributions from other qualified retirement plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in the target date fund that is closest to the participant's retirement year when they would turn age 65 until changed by the participant. There is no automatic increase or escalation of the deferral percentage beyond the participant's initial enrollment date. Participants direct the investment of contributions into a variety of investment options offered by the Plan.

The Company may, at its discretion, make matching contributions. For the year ended December 31, 2024, matching contributions equal to 50% of the first 6% of the compensation that a participant contributed to the Plan were made by the Company. The Company also offers a discretionary profit sharing contribution to eligible employees. The discretionary profit sharing contribution is determined annually by the Company. No discretionary profit sharing contributions were made for the year ended December 31, 2024. Total annual contributions made to the Plan on behalf of any participant are subject to limitations imposed under the Internal Revenue Code (IRC).

##### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching and discretionary profit sharing contributions, and Plan earnings, and charged with an allocation of administrative expenses. The Company's matching contributions are given only to participants employed at the end of the Plan year who have completed at least 1,000 hours of service during the Plan year and are allocated based on participants' compensation for the Plan year relating to the contribution. Profit sharing contribution allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 1. DESCRIPTION OF PLAN (continued)

##### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, from a minimum of \$1,000 up to a maximum of \$50,000. The notes are secured by the balance in the participant's account. The loan interest rate, determined at inception, is set at Prime (7.5% and 8.5% at December 31, 2024 and 2023, respectively) plus 1%, as defined, in accordance with the Plan's loan policy. Interest rates on existing notes range from 4.25% to 9.90% at December 31, 2024, with maturities through November 2029. Principal and interest are paid ratably through payroll deductions. The loan term for the purchase of a primary residence is 10 years. Interest income of \$3,047 for the year ended December 31, 2024 has been recorded as interest income in the accompanying Statement of Changes in Net Assets Available for Benefits.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service according to the following schedule:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

##### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a future period. If the participant's account balance is between \$1,000 and \$5,000, the Plan Administrator makes an automatic rollover of the account balance to a qualified individual retirement account. If the participant's account balance is less than \$1,000, the Plan Administrator directs the trustee to make a lump-sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Participants may also be permitted to receive a distribution from their account prior to termination of employment if they reach age 59 ½ or experience financial hardship. Any hardship distribution would be limited to actual participant contributions and vested discretionary employer contributions not previously withdrawn and may be authorized at any time by the Plan Administrator.

##### Forfeitures

Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,958 and \$1,615, respectively. Forfeitures are used to reduce Company discretionary matching or profit-sharing contributions. Forfeitures attributable to Company profit sharing contributions are reallocated to participant accounts based on compensation. Forfeitures totaled \$14,079 for the year ended December 31, 2024 and forfeitures totaling \$6,736 were applied to reduce Company contributions or plan expenses.

##### Administrative Expenses

Certain administrative expenses of the Plan are paid by the sponsor and are not included in the statement of changes in net assets available for benefits. During the year ended December 31, 2024, administrative expenses paid by the Plan totaled \$23,410.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invested in a fully benefit-responsive investment contract through a trust administered by Voya Retirement Insurance and Annuity Company (Voya). The statements of net assets available for benefits present the contract value of the investment contract. The statement of changes in net assets available for benefits is also prepared on a contract value basis. Investments of participant's contributions and the Company's contributions into these investments are at the direction of each participant.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on the investments purchased and sold, as well as held, during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses was deemed necessary. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. There were no participant loans in default for the year ended December 31, 2024. A loan that is in default is treated as a taxable deemed distribution to the participant.

##### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amount allowed by the IRC are recorded as a liability and reported as corrective distributions in the accompanying statement of changes in net assets available for benefits. There were no excess contributions payable at December 31, 2024 and 2023.

##### Payment of Benefits

Benefits are recorded when paid. Benefit payments totaled \$1,243,050 for the year ended December 31, 2024.

##### Subsequent Events

Plan management has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

#### 3. CERTIFICATION

Investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest and dividends for the year ended December 31, 2024 were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya and have not been audited by the independent auditors.

#### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Money market fund – Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract with Voya. Voya maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula established by the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Examples of such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan),

(2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, plant closings, layoffs, and early retirement incentives) that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (4) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The Plan may terminate the guaranteed investment contract with ninety days advance written notice.

#### 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan transactions include units of investment accounts managed by Voya for the year ended December 31, 2024. Voya was the custodian of the Plan for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions.

#### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 8. TAX STATUS

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an IRS approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS that it qualifies under IRS Code Section 401(a), provided all terms of the Plan are followed. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates its tax positions in accordance with FASB ASC 740. At December 31, 2024, the Plan Administrator believes that all of its tax positions are appropriate based on current facts and circumstances, and no liability related to uncertain tax positions needs to be recorded.

#### 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
