## INDEPENDENT AUDITOR'S REPORT

Catholic Charities Hawaii Retirement Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Catholic Charities Hawaii Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B to the financial statements.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter – Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B of the financial statements, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) – modified cash basis as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

For the Years Ended December 31, 2024 and 2023

#### NOTE A – DESCRIPTION OF PLAN

The Catholic Charities Hawaii Retirement Savings Plan (Plan) was established on July 1, 1993 by Catholic Charities Hawaii (Organization) for the benefit of its employees and their beneficiaries. The Plan was previously known as Catholic Charities of the Diocese of Honolulu Profit-Sharing Plan until July 24, 2008. The following is a description of the Plan that provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was amended and restated effective January 1, 2022.

#### General

The Plan is a defined contribution plan covering all employees of the Organization, other than employees governed by a collective bargaining agreement, nonresident aliens, leased employees, and independent contractors. There are two classes of participants: 401(k) Participants and Full Participants. There is no minimum service requirement for 401(k) Participants; all employees become eligible for participation on the first day they perform services for the Organization as an employee. The Organization does not match 401(k) deferral contributions or provide discretionary contributions before the employee becomes a Full Participant. Prior to September 1, 2022, an employee became a Full Participant as of the first payroll period beginning on or after the first day of the month following the date the employee completes 12 months of service. Effective September 1, 2022, an employee becomes a Full Participant as of the first payroll period beginning on or after the first day of the month following the date the employee completes six months of service.

#### Contributions

Participants may elect to make employee salary deferral contributions to the Plan up to the lesser of 100% of their eligible compensation, or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and 2023, for employees age 50 and over. The Organization may make discretionary contributions to the Plan as determined by its Board of Directors (up to the maximum amount deductible under Section 404(a) of the Internal Revenue Code). The Organization may also elect on a year-to-year basis to match a part of each Full Participant's elective salary deferral contribution. Total contributions to each employee's account may not exceed the lesser of \$69,000 and \$66,000 (\$76,500 and \$73,500 if age 50 and over) in 2024 and 2023 respectively, or 100% of eligible compensation, as defined. Employees may make rollover and transfer contributions from other qualified plans.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's matching contributions, an allocation of the Organization's discretionary contributions, and an allocation of related investment earnings, less an allocation of administrative expenses that are paid by the Plan. Allocations of discretionary employer contributions are based on the ratio that each participant's compensation bears to the total of all participants' compensation for that year. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

#### NOTE A – DESCRIPTION OF PLAN (Continued)

##### Vesting

Participants, who commenced work prior to July 1, 2009, are 100% vested after three years of continuous service. Participants, who commenced work after June 30, 2009, are 20% vested in employer contributions after two years of continuous service, an additional 20% each year thereafter, and 100% vested after five years of continuous service. Employer discretionary and matching contributions become 100% vested upon death, permanent disability, or attainment of the normal retirement age of 65. Participant deferral contributions and earnings thereon are always 100% vested.

##### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable and related interest must be paid within five years unless they are used to acquire a principal residence, in which case the repayment period may be extended to 15 years. The notes receivable are secured by the balance in the participants' account and bear interest at prevailing rates, which ranged from 5.25% to 10.50% as of December 31, 2024 and 2023. All notes receivable from participants as of December 31, 2024 and 2023 were for general purposes and not for the purchase of a principal residence. Principal and interest are paid ratably through monthly payroll deductions. The notes receivable from participants mature at various dates through September 2029.

##### Payment of Benefits

On termination of service due to death, disability, or normal retirement (age 65), a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or through installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the vested balance upon termination is less than \$1,000, the balance is distributed in a lump sum payment. If the vested balance is more than \$1,000 but less than \$5,000, the balance will be distributed in a lump sum or rolled over to an individual retirement account (IRA). If an election is not made, the balance will be rolled over to an IRA.

##### Withdrawals

Active participants may withdraw all or a portion of their vested discretionary contribution account balances as in-service distributions after attaining normal retirement age by submitting a written application that is approved by the plan administrator. Participants may withdraw all or a portion of their contributions upon a showing of financial hardship and compliance with other restrictions in the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service.

##### Forfeitures

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. Forfeitures applied to administrative expenses of the Plan and employer discretionary and matching contributions amounted to \$14,145 and \$15,814 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, forfeitures and gains on the forfeitures amounted to \$11,722 and \$19,515, respectively. The forfeiture balance at December 31, 2024 and 2023 was \$1,278 and \$3,701, respectively.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

Except for investments, which are accounted for on a fair value basis, the Plan has prepared its financial statements on the basis of cash receipts and disbursements; consequently, certain additions to net assets available for benefits are recognized when received rather than when earned, and certain deductions from net assets available for benefits are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to be presented in accordance with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income are recorded when received.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments from registered investment companies.

NOTE C – CERTIFICATIONS FROM QUALIFIED INSTITUTION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the qualified institution of the Plan.

NOTE D – FAIR VALUE MEASUREMENTS

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to the valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in different fair value measurements at the reporting date.

Investments in registered investment companies are valued using quoted market prices, a Level 1 input. Investments in the common/collective trust are valued at the net asset value of units held by the Plan at year-end. The net asset value, as provided by Empower Trust Company LLC, is used as a practical expedient, which is based on the underlying assets of the common/collective trust. The Plan has no investments valued using Level 2 or Level 3 inputs.

#### NOTE E – COMMON/COLLECTIVE TRUST

The Galliard Stable Return Fund E (Fund) (formerly Wells Fargo Stable Value Fund E) is a common/collective trust fund fully invested in Galliard Stable Return Fund Core, a collective trust fund sponsored by SEI Trust Company, and is reportable in the Plan’s financial statements at fair value (as certified by the qualified institution of the Plan). The value of the Fund is based on the underlying unit value reported by Galliard Stable Return Fund Core, which carries its investments at contract value, which approximates fair value. Galliard Stable Return Fund Core invests in investment contracts and security-backed contracts, which is comprised of fixed-income securities and a contract value guarantee provided by a third party. The Fund reported yields earned of 3.35% and 2.93% at December 31, 2024 and 2023, respectively. The actual interest credited to participants in the Fund was 4.88% and 4.92% at December 31, 2024 and 2023, respectively.

#### NOTE F – TAX STATUS

In a letter dated October 14, 2014, the Internal Revenue Service granted the Plan its most recent “favorable determination” because it met the qualification requirements established by Section 401(a) of the Internal Revenue Code (IRC). The Plan has since been amended and restated. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust is tax exempt.

The modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America, requires uncertain tax positions to be recognized in the financial statements if they are more likely than not to fail upon regulatory examination. The plan administrator evaluated the Plan’s tax positions as of December 31, 2024 and 2023, and for the years then ended, and determined that the Plan had no uncertain tax positions required to be reported. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods.

#### NOTE G – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

First Hawaiian Bank (Bank) is the trustee of the Plan under a trust agreement dated June 24, 1999. The Bank utilizes sub-service organizations to provide computerized trust transactions processing, to obtain information for the pricing of securities, and to perform various functions related to the custody of the securities. The Plan’s assets are held in a trust fund by Empower Trust Company, LLC, a wholly-owned subsidiary of Great-West Trust Company, LLC, the custodian of the Plan and a sub-service organization of the Bank. Recordkeeping services are performed by FASCore, LLC, a wholly-owned subsidiary of Great-West Life & Annuity Insurance Company, LLC and a sub-service organization of the Bank.

**NOTE H – ADMINISTRATION OF PLAN ASSETS**

The Plan is sponsored and administered by the Organization. Certain administrative functions are performed by officers or employees of the Organization, who receive no compensation from the Plan. Fees incurred by the Plan for investment management are included in net appreciation in fair value of the investments. Trustee fees and other administrative expenses are paid by either the Plan or by the Organization, as provided in the plan document. Expenses paid by the Organization are excluded from these financial statements.

**NOTE I – TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

**NOTE J – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan and Organization operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effects on the financial statements of the Plan from such changes in economic conditions are not presently determinable.

**NOTE K – SUBSEQUENT EVENTS**

The plan administrator has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued, and determined that the Plan did not have any subsequent events requiring adjustment to the financial statements or disclosure in the notes to the financial statements.
