### 1. Description of the Plan

The following description of the Softchoice Corporation 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan sponsored by Softchoice Corporation (the Company) to provide deferred tax benefits, savings, and Company contributions to eligible employees. The Plan was originally adopted effective January 1, 1998, and was most recently restated effective April 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Eligibility*

The Plan covers all employees of the Company who are located in the United States of America, excluding non-resident aliens, those covered by a collective bargaining agreement, and effective 4/18/2023, covered transition employees. Employees are eligible for participation on their date of hire. Participants are also eligible to receive Company matching contributions immediately upon hire.

#### *Contributions*

Participants may elect to contribute a percentage of pre-tax annual compensation up to 100% of annual compensation. Participants age 50 and older are also allowed to make catch-up contributions up to the maximum allowed under the Internal Revenue Code (IRC). Effective January 1, 2024, the Plan allowed participants to make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect a different percentage. Automatically enrolled participants have their deferral rate set at 6% with no annual increases. Participants direct the investment of their contributions into various investment options offered by the Plan. A current description of the investment funds may be obtained from the Plan administrator.

The Company may make discretionary matching contributions to the Plan. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 50% of participant deferrals up to 6% of eligible compensation. The Company may also make profit-sharing contributions. No profit-sharing contributions were made for the year ended December 31, 2024.

#### *Participant Accounts*

Each Participant's account is credited with the Participant's elective deferral contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on Participant earnings (losses), account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### *Notes Receivable from Participants*

Participants may borrow from their vested account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The participant loans bear interest at a rate of prime plus 1% at the date the loan was issued, as determined daily by the Plan's administrator. Principal and interest are paid ratably through bi-monthly payroll deductions and are secured by the balance in the participant's account. Loans must be repaid within 5 years unless used for the purchase of a primary residence, in which case the Plan administrator may permit a longer repayment term up to 10 years. Participants may have 2 outstanding loans at a time.

### 1. Description of the Plan (cont.)

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. The Plan also allows for in-service withdrawals at age 59½, along with withdrawals in the event of a financial hardship. Distributions may be made in lump-sum payments, installment payments, or partial withdrawals and are either paid directly to the participant or rolled over to another qualified retirement plan. If a terminated participant's balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump-sums as designated by the Company.

#### *Vesting*

Participants are fully vested in their contributions and rollovers, plus actual earnings or losses thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of continuous service as follows:

<u>Years of service</u>	<u>Vesting percentage</u>
Less than two	0%
Two	50%
Three	75%
Four	100%

Participants are considered fully vested upon termination due to death or permanent disability.

#### *Forfeitures*

The Plan allows for forfeited non-vested accounts to be used to either reduce future Company contributions or pay certain Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,408 and \$365, respectively. For the year ended December 31, 2024, \$157,267 of the forfeitures were used to reduce Company contributions and \$1,763 were used to pay certain Plan expenses.

#### *Plan Expenses*

Certain administrative expenses of the Plan are paid by the Plan. Certain other administrative expenses of the Plan are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment fees are paid by the Plan in the form of reductions of net investment income earned by Plan participants.

The Plan participates in a revenue sharing program and income from the program can be used to pay Plan administrative expenses. The revenue sharing program account balance was \$7,442 and \$7,204, at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, total revenue sharing income was \$63,788, and Plan expenses of \$63,789 were paid using those revenue credits.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

### 2. Summary of Significant Accounting Policies (cont.)

#### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

The investments of the Plan are reported at fair value except for a fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount participants normally would receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Notes Receivable from Participants*

Notes receivable from participants are stated at their unpaid principal balance, plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payments of Benefits*

Benefits are recorded when paid.

### 3 Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America (EAIC) and Empower Trust Company, LLC (collectively, "Empower"), the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

### 4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are as follows:

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV) as of December 31, 2024 and 2023. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Investment in Insurance Contract

The Group Annuity Contract is a fully benefit-responsive guaranteed investment contract, originally with Mass Mutual Life Insurance Company, and now with EAIC. EAIC maintains the contributions in a general account. The account is credited with earnings (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. EAIC makes this guarantee, and although EAIC may credit a higher interest rate, the credited interest rate will not fall below the lifetime guaranteed minimum of 1.00%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus credited interest, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with EAIC. Such events include the following: (1) the complete or partial termination of the Plan, (2) the establishment or activation of, or material change in, any Plan investment fund, or amendment to the Plan or a change in the administration or operation of the Plan, including liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable.

### 6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan (Pre-Approved Plan) with CODA (Pre-Approved Plan) sponsored by Empower Retirement, LLC. The Internal Revenue Service (IRS) has opined and informed Empower Retirement, LLC by letter dated November 14, 2022, stating that the form of the Pre-Approved Plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their Company contributions.

### **8. Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.

### **9. Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. The recordkeeping and custody functions for the underlying investments held by the Plan are performed by Empower. Certain plan investments are managed by Empower, in which usual and customary fees were paid for investment management services. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Notes receivable from participants are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

### **10. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 (Act) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the Act did not have a material effect on the Plan's financial statements.

### **11. Subsequent Events**

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 10, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
