#### NOTE A - SUMMARY DESCRIPTION OF THE PLAN

##### ***General***

The Fritz Industries, Inc. 401(k) Retirement Plan (the "Plan") was established by Fritz Industries, Inc. (the "Company" or "Employer") as a defined contribution plan under Section 401(a) of the Internal Revenue Code ("IRC") to provide retirement, death and disability benefits for eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is administered by a Plan Committee appointed by the Company's board of directors. The following description provides only general information. Certain officers of the Company are trustees of the Plan.

During 2023 the trustee changed from Reliance Trust ("Former Trustee") to Empower Trust Company, LLC ("Trustee"). The Trustee is responsible for the custody and management of the Plan's assets at the direction of the Plan administrator. Empower Institutional along with JPMorgan Invest Holdings LLC ("Recordkeeper") are the Plan's recordkeeper and are responsible for maintaining participants' accounts and executing participant-initiated transactions.

##### ***Eligibility***

All employees who have completed three months of service with the Company are eligible to participate at the first Plan entry date, which is the first day of the month subsequent to achieving three months of service.

##### ***Contributions***

Participants may contribute up to 100% of their pretax annual compensation. The Plan permits the Employer to provide a matching contribution based on a percentage of each participant's contributions. For the year ended December 31, 2024, the Employer's matching contribution was 40 % of the participant's contribution not to exceed 15% of the participant's annual compensation. Participants are automatically enrolled at 3% of their pretax annual compensation subject to annual 1% increase (up to maximum of 8%), unless otherwise elected by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. A participant who has reached the age of 50 may make catch-up contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Employer may also make discretionary matching contributions and discretionary nonelective contributions.

##### ***Participant Accounts***

Each participant's account is credited with their individual contributions, employer matching contributions and allocations of plan earnings and losses. Allocations are based on the proportion that each participant's account bears to the total of all fund balances. Participants direct their investments to any of the available investment options under the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their individual contributions and earnings thereon. Participants become 50% vested in the Employer's matching contributions and earnings thereon after two years of service and 100% vested after three years of service. Participants are 100% vested if they are employed on or after their normal retirement age. Participants also become fully vested upon death or disability, while an active employee, regardless of the years of service.

***Forfeited Accounts***

Forfeitures may be used to offset discretionary matching contributions and discretionary nonelective contributions. As of December 31, 2024, and 2023, \$45,066 and \$33,723, respectively, of the non-vested portion of terminated participants' account balances remain in the Plan as forfeitures. During 2024, no amounts were used to offset employer contributions.

***Payment of Benefit***

In the case of retirement due to full and permanent disability, or termination of employment, participants are able to receive the value of their vested account balances in accordance with the provisions of the Plan, in a lump-sum or installment distribution. The corresponding unvested portions of the participant's benefits are forfeited and are allocated as described in the preceding note on forfeitures. In the event that a participant dies before retirement, the participant's named beneficiary will receive the value of the participant's accumulated Plan benefits. Participants with account balances in excess of \$5,000 who are no longer employed by the Company are allowed to remain in the Plan. Effective April 1, 2024, the \$5,000 was increased to \$7,000.

Hardship withdrawals are allowed, subject to certain limitations defined in the Plan agreement, to the extent vested balances exist in participants' accounts.

***Note Receivable from Participants***

Participants may borrow from their accounts subject to a minimum of \$1,000. The maximum amount of any note (when added to the outstanding balance of all prior notes) may not exceed 50% of the participant's vested account balance or \$50,000. In addition, participants may have no more than one note outstanding at any one time. The note is secured by the vested balance in the participant's account and bear a fixed rate of interest calculated at the Prime Rate plus 1%, as published in the Wall Street Journal on the date of the note. Note terms are for a maximum of five years. However, if the note is for the purchase of a primary residence, the Plan administrator may permit a longer repayment term. Principal and interest are repaid in equal installments through payroll deductions and individual repayments made by the participant.

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting and are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements, the changes in net assets available for plan benefits during the reporting period and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

The Plans' investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note D for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Administrative Expenses***

Substantially all plan administrative expenses are paid directly by the Company. Certain costs and expenses incurred with regard to the purchase, sale or transfer of investments are paid by the Plan. Investment advisory fees for portfolio management are paid directly from fund earnings and are included in mutual fund expense ratios.

**NOTE C - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee and Former Trustee have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective fund:* Comprised of guaranteed investment contracts and valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan Sponsor, Fritz Industries, Inc., is responsible for the Plan's administration and trustee expenses. Certain Plan investments are shares of mutual funds and collective fund managed by J.P. Morgan. Certain fees paid to the Plan trustee for investment management services are incorporated into the expense ratios of the individual mutual funds and paid directly from fund earnings; therefore, these transactions qualify as party-in-interest transactions.

The Plan has notes receivable from participants, which qualify as parties-in-interest to the Plan and are exempt from prohibited transactions rules.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of the ERISA. In the event of Plan termination, participants will become 100% vested in their account balances and plan assets will be distributed in accordance with the Plan.

**NOTE G - TAX STATUS**

The IRS has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the Plan's tax positions and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
