Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of Second Harvest Heartland, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the 403(b) Thrift Plan of Second Harvest Heartland's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of Second Harvest Heartland's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Plan description:

The following description of the 403(b) Thrift Plan of Second Harvest Heartland (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

Second Harvest Heartland (the Organization) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. Deferrals begin on the first day of the month subsequent to enrollment. The plan excludes from eligibility employees who normally work fewer than 20 hours per week or who are reasonably expected to work fewer than 1,000 hours of service in a 12-month period. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan contributions:

Participants may contribute a percent of their base pay by means of pre-tax or post-tax payroll deductions, subject to certain tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. For the years ended December 31, 2024 and 2023, the Organization matched 50% of each employee's deferrals up to 4% of employee compensation and contributed 4% of the employee's annual eligible compensation regardless if the employee was making voluntary contributions to the Plan. Employees were automatically enrolled with a salary deferral of 4% of eligible compensation unless the employee elected not to participate in the Plan.

Participant accounts:

Each participant's account is credited with the participant's contributions, allocations of the Organization's base compensation contributions and Plan gains or losses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Investment options:

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into various investment account options offered by the Plan within a pooled separate account.

Participants are immediately vested in their voluntary contributions and earnings thereon. However, vesting in the Organization's contributions is based on years of service.

1. Plan description (continued):

Vesting:

The following table represents the rate at which the Organization's contributions vest:

Less than 1 year	0%
1 year	25%
2 years	50%
3 years	75%
4 or more years	100%

Distributions:

Upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's account in either a lump sum or, at the participant's election, in annual installments. Upon termination, other than by retirement, disability, or death, a participant becomes eligible to receive the current value of the participants' vested account in a lump-sum based on IRS distribution regulations. During employment, vested employer contributions may be withdrawn from the Plan after five years of plan participation and at age 59½ or later. The Plan provides for automatic distributions for terminated participants with balances less than \$5,000.

Group Annuity Loans:

Participants may borrow from the plan, using a portion of their benefit invested in the Interest Accumulation Account of the Mutual of America General Account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 less the highest outstanding loan balance during the one year period prior to the loan application date, or 50% of the participant's account balance less any current outstanding loan balance. Interest is charged at a reasonable rate that may not exceed the legal limit, which remains in effect for the duration of the loan. During plan years 2024 and 2023, interest rates on participant loans were 5.85%. Loan terms range from 1 to 5 years, or longer for the purchase of a primary residence. The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions.

As of December 31, 2024 and 2023, the balances borrowed under these loans totaled \$129,501 and \$65,893, respectively. Under the borrowing terms, \$155,401 and \$79,072 as of December 31, 2024 and 2023, respectively, of plan assets included in the interest accumulation account serve as collateral for these loans. Collateral is calculated at 120% of the participant loan balance.

Interest paid by participants on such loans during the plan years ended December 31, 2024 and 2023, was \$6,796 and \$2,739, respectively.

1. Plan description (continued):

Group Annuity Loans (continued):

In the event of default, such loans are reportable to plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the plan participant or the participant becomes eligible to receive a distribution under the terms of the plan. As of December 31, 2024 and 2023, there were no loans in default.

Participant investment rollovers:

Participants are allowed to transfer or rollover funds into the Plan from certain types of qualified plans.

2. Summary of significant accounting policies:

Use of accounting estimates:

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Fair value measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

2. Summary of significant accounting policies (continued):

Fair value measurements (continued):

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds in group annuity contract separate account – The Plan has investments in participation units held in mutual funds in a group annuity contract separate account of an insurance company as of December 31, 2024 and 2023. The Plan has concluded that the net asset value (NAV) as adjusted and reported by the insurance company is the practical expedient to fair value for the pool separate account. The investments are redeemable at the adjusted NAV under agreements with the insurance company.

The nature of the investments, changes in market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the mutual funds in a group annuity contract separate account and consequently, the fair value of Plan investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of further fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth additional disclosures for the fair value measurement of investments in certain entities that calculate fair value using net asset value per share as the practical expedient as of December 31:

The Mutual of America Separate Account No. 2 has the following investment strategies:

Equity funds – The objective of the equity funds category is to seek to provide investment results that are comparable to or higher than various stocks or equity indices. To achieve this objective, the funds in this category invest primarily in a diversified combination of common and value stocks of small to mid-sized companies.

Balanced funds – The objective of the balanced funds category is to seek to obtain high total return with reduced risk over the long-term. To achieve this objective, the funds in this category invest in a variety of stocks, bonds and short-term investments.

2. Summary of significant accounting policies (continued):

The Mutual of America Separate Account No. 2 has the following investment strategies (continued):

Fixed income funds – The objective of the fixed income funds category is to seek current income with a secondary objective of preservation of capital. To achieve this objective, the funds invest primarily in investment grade, publicly traded debt securities.

Retirement funds – The objective of the retirement funds category is to seek to provide current income and capital appreciation for the asset allocation associated with the applicable target retirement date. To achieve this objective, the funds in this category invest in various funds in proportions that are balanced to meet the current target of the fund, which will move toward preservation of capital and production of income as the target retirement date approaches. The target of the fund changes over time, so the mix of fixed income funds and equity funds will change to reflect the periodic modification in the fund's target.

Asset allocation funds – The objective of the asset allocation funds category is to seek to provide current income and capital appreciation. To achieve this objective, the funds in this category primarily invest in a mix of equity and fixed income funds.

Real estate investment trust funds – The objective of the real estate investment trust funds (REITs) category is to provide a high level of income and moderate long-term capital appreciation. To achieve this objective, the funds in this category track the performance of a benchmark index that measures the performance of publicly traded equity REITs. The funds employ an indexing investment approach designed to track the performance of a given REIT index.

Changes in fair value and related gains and losses:

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) are reported in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

Investment valuation and income recognition:

At December 31, 2024 and 2023, the Plan's investments were held in various investment accounts and are stated at net asset value which approximates fair value. All investment accounts are part of and held in the Mutual of America Separate Account No. 2, as discussed above. The net appreciation in the fair value of investments include realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the plan year to the end of the plan year is included with realized gains/losses as net appreciation in fair value of investments reported in the accompanying statements of changes in net assets available for benefits.

2. Summary of significant accounting policies (continued):

Contributions:

Contributions from employees and the Organization are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

Distributions:

Distributions are recorded when paid.

Expenses:

Certain administrative expenses of the Plan are paid by the Organization. Other expenses such as transaction fees charged by Mutual of America are paid from plan assets and deducted from participant accounts in accordance with the plan document.

Forfeitures:

Forfeitures of terminated participants' non-vested accounts must first be used to pay Plan expenses and then are used to reduce the Organization's future contributions to the Plan. For years ending December 31, 2024 and 2023, forfeitures of \$117,982 and \$79,182, respectively, were used to reduce Organization contributions to the Plan. At December 31, 2024 and 2023, forfeitures of \$365 and \$5,115, respectively, were available.

Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent events:

Management has evaluated for subsequent events through October 8, 2025, the date the financial statements were available for issuance.

3. Investments:

All investments held by the Plan are party-in-interest. Certain investments of the Plan are held under a Group Annuity Contract (GAC) which is a variable accumulation annuity contract. The GAC includes a general account, the Mutual of America Interest Accumulation Account (IAA). Amounts placed in the IAA are credited with interest at a rate determined from time to time by Mutual of America. Mutual of America has the right to change the interest rates at their discretion, but not below minimum guaranteed interest rates based on total account balances. Principal and previously-credited interest in the account are guaranteed. Effective annual yield currently applicable to contributions held in this account for participants in this Plan was 1.44% and 1.44% for December 31, 2024 and 2023, respectively. The yield quoted assumes that money is compounded daily.

3. Investments (continued):

Contract account balances are reviewed on a daily basis and are used to determine the applicable interest rate credited to amounts in the IAA.

Mutual of America guarantees interest will be credited to amounts in the IAA at a rate at least equal to the greater of (1) any contractual minimum guarantee provided by the contract or (2) the minimum rate required by applicable state law or set pursuant to National Association of Insurance Commissioners (NAIC) standard nonforfeiture law. The NAIC minimum rate is determined by a formula and cannot be less than .15% or more than 3.00% in any event.

Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. Mutual of America may credit a higher rate of interest to contract amounts in the IAA at their discretion, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Interest is compounded daily on contract amounts in the IAA to produce an effective annual yield that is equal to the stated interest rate. Requests for withdrawal can be made at any time and are not dependent on Mutual of America having to liquidate securities. The account balance is measured at net asset value, the practical expedient of fair value.

The guaranteed rate is subject to Mutual of America's financial strength and claims-paying ability.

4. Tax status:

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

6. Transactions with party-in-interest:

The Plan invests in securities sponsored by the Plan's custodian, as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions. Administrative fees related to the administration of the Plan are paid by the Plan. Other administrative fees are paid by the plan sponsor on behalf of the Plan.

7. Subsequent event:

Subsequent to year end, the Plan sponsor transferred the Plan's assets to a new custodian, and will have a new recordkeeper and third-party administrator. In connection with this transfer, the Plan Sponsor adopted a new plan document provided by the recordkeeper. The plan document provider obtained an IRS opinion letter dated November 29, 2024, indicating that the plan document, as designed, satisfies the requirements of Section 403(b) of the Internal Revenue Code.

There were no changes to the Plan provisions other than participants are allowed to take loans directly from their accounts. Loans to participants are permitted at the discretion of the Plan administrator. Participants may borrow from a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant can have up to two loans outstanding. The interest rate is 1% above prime. Loans are secured by the balance in the participant's account.
