NOTE A | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Suburban Drywall Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan was adopted January 1, 2014, and restated effective December 1, 2023. It is a defined contribution plan and a profit sharing 401(k) plan under Section 401(k) of the Internal Revenue Code covering all eligible employees of Suburban Drywall Inc., Suburban Insulation Inc., and Suburban Custom Finishes Inc. (Plan Sponsors).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. *Administrative Fees*

The Plan Sponsors have elected to pay certain administrative fees for the Plan while the remainder of the expenses are paid by the Plan. Total administrative expenses paid by the Plan were \$39,980 and \$30,050 for the years ended December 31, 2024 and 2023, respectively.

3. *Contributions*

Each year, participants may contribute up to 92% of their compensation, as defined in the Plan. Participants are permitted to designate a portion or all of their deferral contributions as either pre-tax or Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

In addition to the participants' contributions, the Plan Sponsors match participants' deferrals. The Plan Sponsors matched 100% of the first 3% and 50% of the next 2% of eligible compensation contributed by participants to the Plan. These Plan Sponsors' contributions totaled \$315,068 and \$281,046 for 2024 and 2023, respectively.

Additionally, the Plan Sponsors may make an elective profit-sharing contribution to the Plan for participants that meet certain age and hours of service requirements. There were no profit-sharing contributions for either of the years ended December 31, 2024 and 2023.

4. *Participant Accounts*

Each participant's account is credited with the participant's contribution, Plan Sponsors' contributions, and an allocation of Plan earnings. Plan earnings are allocated to each of the participants at the end of the day based on the individual participant's balances at the beginning of the day as a percent of the total participants' beginning balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

5. *Vesting*

Participants are immediately 100 percent vested in the participant's contributions and Plan Sponsors' contributions.

6. *Payment of Benefits*

On termination of service, death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant's interest in his or her account. Distributions may also be taken as installments or applied to the purchase of an annuity contract. A participant that terminates employment whose account balance is less than \$5,000 will receive a distribution of their account in the form of lump sum cash. In-service withdrawals of all or a portion of the participant's vested account balance are also permitted upon the participant's attainment of age 59 ½. Under certain conditions participants may receive a hardship distribution.

7. *Use of Estimates*

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

8. *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

9. *Income Tax Status*

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the plan is qualified and the related trust is tax-exempt.

10. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through September 26, 2025, which is the date the financial statements were available to be issued. No subsequent events required recognition or disclosure.

NOTE B | INVESTMENTS

The Plan's investments are participant directed and held by a trust company. Participants may direct their contributions into any of the investment options offered by the Plan. Investment option changes and transfers may be made by the participants on a daily basis.

NOTE C | RISKS AND UNCERTAINTIES

Investments, in general, are inherently subject to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that a change in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

NOTE D | FAIR VALUE MEASUREMENT

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value, and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

- Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.
- Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.
- Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

NOTE D | FAIR VALUE MEASUREMENT

The fair value of mutual funds is equal to the net asset value of the funds multiplied by the number of shares held by the Plan, primarily using quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in collective investment trusts, which provides for various investment options. Fair values of the collective investment trusts are reported to the Plan based on the NAV of the units of the collective investment trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

- Exercise professional judgment and maintain professional skepticism throughout the audits.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Suburban Drywall Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan was adopted January 1, 2014, and restated effective December 1, 2023. It is a defined contribution plan and a profit sharing 401(k) plan under Section 401(k) of the Internal Revenue Code covering all eligible employees of Suburban Drywall Inc., Suburban Insulation Inc., and Suburban Custom Finishes Inc. (Plan Sponsors).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. *Administrative Fees*

The Plan Sponsors have elected to pay certain administrative fees for the Plan while the remainder of the expenses are paid by the Plan. Total administrative expenses paid by the Plan were \$39,980 and \$30,050 for the years ended December 31, 2024 and 2023, respectively.

3. *Contributions*

Each year, participants may contribute up to 92% of their compensation, as defined in the Plan. Participants are permitted to designate a portion or all of their deferral contributions as either pre-tax or Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

In addition to the participants' contributions, the Plan Sponsors match participants' deferrals. The Plan Sponsors matched 100% of the first 3% and 50% of the next 2% of eligible compensation contributed by participants to the Plan. These Plan Sponsors' contributions totaled \$315,068 and \$281,046 for 2024 and 2023, respectively.

Additionally, the Plan Sponsors may make an elective profit-sharing contribution to the Plan for participants that meet certain age and hours of service requirements. There were no profit-sharing contributions for either of the years ended December 31, 2024 and 2023.

4. *Participant Accounts*

Each participant's account is credited with the participant's contribution, Plan Sponsors' contributions, and an allocation of Plan earnings. Plan earnings are allocated to each of the participants at the end of the day based on the individual participant's balances at the beginning of the day as a percent of the total participants' beginning balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

5. *Vesting*

Participants are immediately 100 percent vested in the participant's contributions and Plan Sponsors' contributions.

6. *Payment of Benefits*

On termination of service, death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant's interest in his or her account. Distributions may also be taken as installments or applied to the purchase of an annuity contract. A participant that terminates employment whose account balance is less than \$5,000 will receive a distribution of their account in the form of lump sum cash. In-service withdrawals of all or a portion of the participant's vested account balance are also permitted upon the participant's attainment of age 59 ½. Under certain conditions participants may receive a hardship distribution.

7. *Use of Estimates*

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

8. *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

9. *Income Tax Status*

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the plan is qualified and the related trust is tax-exempt.

10. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through September 26, 2025, which is the date the financial statements were available to be issued. No subsequent events required recognition or disclosure.

NOTE B | INVESTMENTS

The Plan's investments are participant directed and held by a trust company. Participants may direct their contributions into any of the investment options offered by the Plan. Investment option changes and transfers may be made by the participants on a daily basis.

NOTE C | RISKS AND UNCERTAINTIES

Investments, in general, are inherently subject to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that a change in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

NOTE D | FAIR VALUE MEASUREMENT

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value, and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

- Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.
- Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.
- Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

NOTE D | FAIR VALUE MEASUREMENT

The fair value of mutual funds is equal to the net asset value of the funds multiplied by the number of shares held by the Plan, primarily using quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in collective investment trusts, which provides for various investment options. Fair values of the collective investment trusts are reported to the Plan based on the NAV of the units of the collective investment trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.
