### Note 1: Description of Plan

The following description of the Torgerson's LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the provisions.

#### General

The Plan is a multiple employer defined contribution plan covering all employees of Torgerson's LLC, Lloyd Torgerson, Inc., Billings Equipment Company, and A&B, A&L, B&L, E&A, E & B, and E & L Torgerson's, Inc., (collectively the "Company"). Employees are eligible to participate for purposes of salary deferrals once they have attained age 18 and have completed two months of employment. Employees are eligible to participate for purposes of matching contributions and profit sharing contributions once they have obtained age 18 and completed one year of service (at least 1,000 hours of service during the plan year). The entry date to the Plan is the first day of the month coinciding with or next following the date the eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### Accounting Estimates

The preparation of financial statements in conformity with the accrual basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

#### Contributions

Participants may contribute up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code Sections 401(k), 402(9), and 415. The Company matches 50% of the participant contribution up to 2% of gross compensation. For the year ended December 31, 2024, the Company made matching contributions of \$403,206. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company matching contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their elective deferrals and earnings thereon.

#### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$65,114 and \$15,118, respectively. These accounts will be used to reduce future Company discretionary contributions or pay plan expenses in accordance with the plan document. During 2024, forfeitures were not used to pay administrative expenses or reduce Company contributions.

#### Payment of Benefits

The Plan provides for normal retirement benefits upon reaching age sixty-five. Upon retirement, permanent disability or death, a participant may elect to receive either a lump sum amount equal to the participant's vested interest in his or her account, or substantially equal installments or partial withdrawals. In-service distributions may be made to a participant who has not separated from service, attained age 59 1/2, and is fully vested.

#### Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. The Plan's management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.62% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions are recognized when earned and distributions are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 12, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the Custodian of the Plan.

Investment activity and balances were certified as complete and accurate by Minnesota Life Insurance Company, a custodian of the plan from January 1, 2023 through September 19, 2023.

### Note 4: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 5: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Mutual funds consist of publicly traded funds of registered investment companies. Shares of mutual funds are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within level 1 of the valuation hierarchy.

### Note 6: Related Party Transactions and Party In-Interest Transactions

The Plan administrator is an employee of the Company, and the owners are also participants in the Plan. There are no transactions between these parties-in-interest other than contributions to the Plan. Certain investments are managed by John Hancock Retirement Plan services. John Hancock Retirement Plan services is the custodian of the plan and therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for services were \$18,101 for the year ended December 31, 2024.

The Plan pays fees for investment advisory services to Edward Jones & Co. Investment advisory fees are considered party-in-interest transactions. Fees paid for investment advisory services totaled \$27,806 for the year ended December 31, 2024.

### Note 1: Description of Plan

The following description of the Torgerson's LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the provisions.

#### General

The Plan is a multiple employer defined contribution plan covering all employees of Torgerson's LLC, Lloyd Torgerson, Inc., Billings Equipment Company, and A&B, A&L, B&L, E&A, E & B, and E & L Torgerson's, Inc., (collectively the "Company"). Employees are eligible to participate for purposes of salary deferrals once they have attained age 18 and have completed two months of employment. Employees are eligible to participate for purposes of matching contributions and profit sharing contributions once they have obtained age 18 and completed one year of service (at least 1,000 hours of service during the plan year). The entry date to the Plan is the first day of the month coinciding with or next following the date the eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### Accounting Estimates

The preparation of financial statements in conformity with the accrual basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

#### Contributions

Participants may contribute up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code Sections 401(k), 402(9), and 415. The Company matches 50% of the participant contribution up to 2% of gross compensation. For the year ended December 31, 2024, the Company made matching contributions of \$403,206. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company matching contribution and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their elective deferrals and earnings thereon.

#### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$65,114 and \$15,118, respectively. These accounts will be used to reduce future Company discretionary contributions or pay plan expenses in accordance with the plan document. During 2024, forfeitures were not used to pay administrative expenses or reduce Company contributions.

#### Payment of Benefits

The Plan provides for normal retirement benefits upon reaching age sixty-five. Upon retirement, permanent disability or death, a participant may elect to receive either a lump sum amount equal to the participant's vested interest in his or her account, or substantially equal installments or partial withdrawals. In-service distributions may be made to a participant who has not separated from service, attained age 59 1/2, and is fully vested.

#### Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. The Plan's management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.62% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Contributions are recognized when earned and distributions are recorded when paid.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 12, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Trust Company LLC, the Custodian of the Plan.

Investment activity and balances were certified as complete and accurate by Minnesota Life Insurance Company, a custodian of the plan from January 1, 2023 through September 19, 2023.

### Note 4: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 5: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

### Note 5: Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Mutual funds consist of publicly traded funds of registered investment companies. Shares of mutual funds are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within level 1 of the valuation hierarchy.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### Note 6: Related Party Transactions and Party In-Interest Transactions

The Plan administrator is an employee of the Company, and the owners are also participants in the Plan. There are no transactions between these parties-in-interest other than contributions to the Plan. Certain investments are managed by John Hancock Retirement Plan services. John Hancock Retirement Plan services is the custodian of the plan and therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for services were \$18,101 for the year ended December 31, 2024.

The Plan pays fees for investment advisory services to Edward Jones & Co. Investment advisory fees are considered party-in-interest transactions. Fees paid for investment advisory services totaled \$27,806 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.
